Independent Auditors' Report

To the Participants and Trustees of

Opinion

We have audited the accompanying financial statements of Niemann Foods, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

1. Plan Description

The following brief description of the Niemann Foods, Inc. Employee Stock Ownership Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for complete information.

Niemann Foods, Inc. ("Company") established the Niemann Foods, Inc. Employee Stock Ownership Plan effective as of January 1, 1997. The plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an Employee Benefits Administration Committee comprised of up to three persons appointed by the Niemann Foods, Inc. Board of Directors.

Employees of Niemann Foods, Inc. are generally eligible to participate in the Plan after one year of service providing they worked at least 1,000 hours during such plan year. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. The Plan provides for a put option which requires Niemann Foods, Inc. to repurchase the allocated and vested stock of terminated employees at the current appraised value at the time of repurchase.

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any share for which instructions have not been given by a participant.

Vesting is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Forfeitures are allocated to participants based upon their annual allocation of the release of shares.

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account.

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during December 31, 2024 and 2023, totaled \$72,165 and \$78,605, respectively. There were no unallocated forfeitures at December 31, 2024 and 2023.

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Benefits Administration Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund.

The Company has allocated all shares in the Plan to participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The common shares of the Company are valued at fair value on December 31, 2024 and 2023. Fair value is determined by annual independent appraisals. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method.

3. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated November 9, 2016, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Code.

4. Administration of Plan Assets

The Plan’s assets, which consist principally of Niemann Foods, Inc. common shares, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses are paid directly by the Company.

5. Investment

The Plan’s investment in Niemann Foods, Inc. common shares at December 31, 2024 and 2023, is as follows:

6. Employer Contributions

The Company is obligating shares from Treasury Stock to release to eligible participants every year in an amount determined by the Board of Directors. The Company currently does not pay dividends. There were 19,110 and 17,100 shares released for the years ending December 31, 2024 and 2023, respectively.

7. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The following tables present fair value measurement information for certain financial instruments. The carrying values of receivables included in the accompanying statement of net assets available for benefits approximated fair value at December 31, 2024 and 2023, and thus are not included in the following table.

FASB ASC 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 and Level 2 inputs were not available.

Level 3 Fair Value Measurements

The fair value of the Niemann Foods, Inc. common stock is determined by annual independent appraisals. The appraisal value per share was \$48.30 and \$65.19 at December 31, 2024 and 2023, respectively. The valuation process involves the selection of an appraiser. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution.

The appraisal methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. **Risks and Uncertainties**

The Plan invests in employer securities. Employer securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. **Related Party and Party in Interest Transactions**

The Plan invests in Company stock which is a related party and party in interest transaction. As described in Note 4, the Company pays all plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

10. **Subsequent Events**

The Plan has evaluated subsequent events through September 5, 2025, the date upon which the financial statements were available to be issued.
