## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Chisholm Chisholm & Kilpatrick 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Chisholm Chisholm & Kilpatrick 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

**1. Description of the Plan**

The following description of the Chisholm Chisholm & Kilpatrick 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement or the Summary Plan Description for more information about the Plan.

***General***

The Plan is a participant-directed defined contribution plan, covering all eligible employees of Chisholm Chisholm & Kilpatrick, Ltd. (the Employer or Plan Sponsor) who have attained the age of 21 and completed one year of eligible service (1,000 hours). Substantially all employees and partners of the Plan Sponsor are considered eligible to participate in the Plan after they have satisfied this requirement. During 2024, the Plan adopted the required long-term, part-time (LTPT) employees eligibility provision of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act), to provide that LTPT employees who have attained the age of 21, are eligible to participate in the Plan for purposes of making employee deferral contributions if they worked 500 or more hours during the last three consecutive years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation in the Plan is voluntary. Employees are eligible to enter the Plan on the first day of the month following completion of eligibility requirements.

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. The Vanguard Group, Inc. (VGI) holds and manages certain Plan investments and Ascensus Trust Company (Ascensus) provides certain services on behalf of VGI. Ascensus, LLC is the recordkeeper of the Plan, as an affiliate for Ascensus Trust Company, who is the custodian of the Plan. Two officers of the Employer are trustees of the Plan.

***Contributions***

Participants may elect to contribute any percentage of their eligible compensation to the Plan, on a pre-tax basis, so long as those contributions do not exceed annual limitations set by the Internal Revenue Code (IRC). The Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified retirement plans.

Effective September 1, 2024, the Plan was amended to allow voluntary after-tax contributions.

Plan participants entering the Plan are automatically enrolled in the Plan with their deferral pre-tax rate set at 5% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. The automatic enrollment rate is increased by 1% each year, up to a maximum of 10%.

The Employer makes a safe-harbor matching contribution to the Plan in an amount equal to 100% of the first 3% of eligible compensation that a participant contributes to the Plan, and 50% of each participant's eligible compensation that a participant contributes to the Plan in excess of 3% but not in excess of 5% of the participant's compensation. For the year ended December 31, 2024, the Employer contributed safe-harbor matching contributions in the amount of \$672,608.

The Employer may make a discretionary matching contribution as determined by the Employer. No Employer discretionary matching contributions were made to the Plan for the year ended December 31, 2024. The Employer may elect to make a profit-sharing contribution to be allocated to eligible participants in an amount designated by the Employer. No Employer profit-sharing contributions were made to the Plan for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, any rollover contributions made by the participant, the Plan Sponsor's matching, discretionary and profit-sharing contributions, and investment earnings/losses from the investment option(s) selected by the participants and investment expenses. The benefit to which a participant is entitled is based on the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions, Employer safe-harbor contributions and accrued earnings thereon. A participant becomes fully vested in the Employer's discretionary matching and profit-sharing contributions and the annual allocation of Plan earnings on those contributions after six years of service. Participants are partially vested in the Employer's discretionary matching and profit-sharing contributions as follows: 20% after two years, 40% after three years, 60% after four years, 80% after five years, and 100% after six years. Each participant shall be 100% vested in their Employer contribution accounts upon death, disability or attainment of normal retirement age.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, or up to 15 years for the purchase of a principal residence, with one note outstanding at any one time. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Upon retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) receives a lump-sum amount equal to the value of the participant's vested interest in their account or may choose to receive annuity distributions. Participants who have reached age 59½ may elect to withdraw all or a portion of amounts in their employee deferral account while still employed by the Employer.

In addition, participants may request a financial hardship withdrawal from their elective deferral and rollover accounts, subject to limitations imposed by the IRC. If a participant's vested account balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance, and the non-vested portion shall be treated as a forfeiture. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$7,000, the amount will be distributed in cash or rolled over to an individual retirement account designated by the Employer, unless otherwise directed by the participant.

During 2024, the Plan adopted certain provisions of the SECURE Act 2.0, including participant self-certification for hardship withdrawals, qualified birth or adoption distribution provisions, distributions for individuals with a terminal illness, and an increase in the automatic cash-out threshold from \$5,000 to \$7,000. Additional SECURE Act 2.0 provisions may also apply based on plan design and future regulatory guidance.

***Forfeitures***

Participants in the Plan who leave the employment of the Plan Sponsor before completing six years of service forfeit the non-vested portion of the Employer discretionary matching and profit-sharing contributions to their accounts. Forfeitures may be used to reduce future Employer contributions or pay administrative expenses. At December 31, 2024 and 2023, there were no forfeited non-vested accounts. During 2024, forfeitures in the amount of \$45 were used to pay administrative expenses.

***Plan Termination***

The Plan Sponsor expects to continue the Plan indefinitely. However, the Plan Sponsor reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Contributions***

Participant contributions are recorded bi-weekly when the Employer remits the payroll deductions for investment into the Plan. Plan Sponsor safe-harbor matching contributions are remitted and recorded annually. Plan Sponsor discretionary matching and discretionary profit-sharing contributions are also remitted and recorded annually, if applicable.

***Payment of Benefits***

Benefits are recorded when paid to participants or their designated beneficiaries. Also recorded are distributions paid to former employees when their funds are paid to them or rolled over into another plan. The Plan also provides for mandatory distribution to participants upon reaching age 73.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within the stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

***Administrative Expenses***

Expenses incurred in the administration of the Plan are paid by the Company unless the Company directs that such expenses be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management fees for certain investments are included as a reduction of investment return (net appreciation or depreciation) and not reflected separately in the Statement of Changes in Net Assets Available for Plan Benefits.

Administrative revenues arise when investment managers return a portion of the investment fees to the recordkeeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. The Plan held unallocated administrative revenues of \$83 at December 31, 2024.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in four mutual funds that accounted for approximately 63% of total Plan investments at December 31, 2024. The Plan invested in three mutual funds that accounted for approximately 55% of total Plan investments at December 31, 2023.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single custodian. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Fund:* The Plan invests in the Putnam Stable Value Fund, an investment vehicle that invests in benefit-responsive investment contracts, fixed income securities and money market funds. It is valued at NAV of units held by the Plan. The NAV, as provided by Putnam, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan, however, there is up to a 12-month redemption for this investment at the Plan level.

**4. Income Tax Status**

The Plan is an adoption of a non-standardized pre-approved profit sharing plan. The Plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**7. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are held and managed by VGI, and recordkeeping administrative services are provided by Ascensus, LLC. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to VGI for investment management services of \$9,446 for the year ended December 31, 2024. In addition, participant notes receivable also qualify as party-in-interest transactions.

**8. Subsequent Events**

Effective January 1, 2025, the Plan adopted a provision of the SECURE Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

Management has evaluated subsequent events through August 28, 2025, which is the date these financial statements were available to be issued.
