Report on the Audit of the Financial Statements

Profit Sharing/401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of the HOM Furniture, Inc. (the Employer) Profit Sharing/401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was originally effective January 1, 1997 and last amended and restated effective March 11, 2022. The Plan is a voluntary salary reduction and investment program sponsored by HOM Furniture, Inc. for substantially all employees who have completed one year of service during which a participant has at least 1,000 hours of service and attained age 21. Participants enter the Plan as of the first day of the month after meeting the eligibility requirements. The Plan excludes those employees covered under a collective bargaining agreement, nonresident aliens, and independent contractors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan administrator is responsible for the oversight of the Plan.

Contributions

The Plan includes a 401(k) cash or deferred arrangement. Under this arrangement, and subject to Plan provisions, participants may elect to defer a percentage of compensation not to exceed a certain dollar limit set by law. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. The Plan also includes an auto increase feature for participants who were automatically enrolled in the Plan whereby their 401(k) contribution will automatically increase by 1% each year up to a maximum of 10%. Participants who are age 50 or older may elect to defer additional amounts (catch-up contributions) to the Plan, subject to certain limitations as defined by law. The Plan does not allow employer matching contributions on catch-up contributions being deferred by participants. Participants may also contribute amounts representing distributions from other qualified plans.

The Employer will make a matching contribution equal to 100% of the total salary reduction elections of all participants, up to 2% of compensation plus 37.5% of salary reductions more than 2% up to 10% of compensation. In addition, the Employer may make a discretionary profit sharing contribution. For the Plan years ended December 31, 2024 and 2023, no discretionary profit sharing contribution was made.

A participant must be actively employed during the Plan year to participate in the matching contribution. A participant must complete a year of service during the Plan year and be actively employed on the last day of the Plan year to share in the discretionary profit sharing contribution. Such requirements must be met unless termination occurred due to death, disability, or attainment of normal retirement age as specified by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's matching and discretionary profit sharing contributions, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. Participants are allowed to direct the investment of their account balances in a variety of funds as determined by the trustee of the Plan. Participants may change their investment options at any time through an interactive voice response system or on the Principal Retirement Plan Services Web site. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's discretionary and nondiscretionary matching and discretionary profit sharing contributions is based on continuous years of service according to the following schedule:

Notwithstanding the above, a participant becomes fully vested upon death, disability, or attainment of normal retirement age as defined in the Plan.

Payment of Benefits

Upon termination of service, death, disability, or normal retirement (as defined by the Plan), the participant may receive the value of the vested interest in their account in the form of a lump-sum distribution or installments. Plan participants with balances of \$1,000 or less must withdraw their benefits when their employment with the Employer ends. The Plan requires mandatory distributions for account balances between \$1,000 and \$5,000 to be rolled over into an IRA. Plan participants may, in accordance with current IRS guidelines, withdraw their benefits if they are suffering from a hardship while still employed by the Employer. The Plan also allows for in-service distributions if a participant reached age 59½ subject to Plan provisions. Upon separation of employment, participants may withdraw their benefits at the next valuation date or wait until normal retirement age.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$100,000 or 100% of their nonforfeitable account balance. Note transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable fund. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest must be paid at least quarterly.

Forfeitures

Forfeited nonvested accounts are used to pay administrative expenses and to reduce Employer contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$18 and \$3,574, respectively. There were \$1,011 and \$368 of forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively. There were \$71,934 and \$56,591 of forfeitures used to reduce Employer contributions for the years ended December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determine the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Delaware Charter Guarantee & Trust Company (dba: Principal Trust Company), the trustee of the Plan, and Principal Life Insurance Company, the insurance company of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and related interest income and all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Represent investments with various investment managers. The fair values of mutual funds are determined by reference to the fund’s underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value (NAV).

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

In 2007, the Plan entered into a group annuity contract with Principal Life Insurance Company (Principal). Principal maintained the contributions in guaranteed investment contracts (GICs). The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but was not to be less than 3%. The crediting rate was reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)

This contract met the fully benefit-responsive investment contract criteria and, therefore, was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

During the plan year ended December 31, 2024, the group annuity contract was terminated and all assets were liquidated.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 PLAN TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

The investments are managed by Delaware Charter Guarantee & Trust Company (dba: Principal Trust Company), the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment.

NOTE 10 SUBSEQUENT EVENT

Effective July 7, 2025, Empower Trust Company, LLC became the trustee of the Plan.
