NOTE 1: DESCRIPTION OF PLAN

The following description of the Children’s Mercy - Community Choice Pediatrics, Inc. (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering all employees of the Company with one year of service and are age 21 or over. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

B. Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to certain limitations by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. The Company provides a safe harbor match of 100% of the first 3% and 50% of the next 2% of employees’ eligible compensation contributed to the Plan. The Plan also allows the Company to make discretionary profit-sharing contributions, and the Company contributed \$0 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds investment options for participants.

C. Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Plan’s earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Vesting

Participants are vested immediately in the entire amount credited to their account including: their contributions, the safe harbor employer match, and the discretionary profit sharing plus actual earnings thereon.

E. Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or one half of their vested account balances. The loan is secured by the balance in the participant’s account and bears interest rates of 8.75% to 9.50%, which is commensurate with local prevailing rate as determined by the Plan administrator.

F. Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

G. Forfeited Accounts

Forfeitures are available to offset employer contributions and/or to pay plan expenses. Forfeitures for the year ended December 31, 2024 were \$1,049 and related to excess employer match contributed to the Plan. For the year ended December 31, 2023, no forfeitures were used to off-set employer contributions or pay plan expenses. The forfeiture account balance was \$12,720 and \$11,115 as of December 31, 2024 and 2023, respectively.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

E. Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of change in net assets available for benefits.

F. Excess Contributions Payable

Amounts payable to participants for contributions in excess of threshold allowed by the IRS were \$413 and \$1,200 at December 31, 2024 and 2023, respectively, and are included as liabilities on the statement of net assets available for benefits. They are also included in benefits paid to participants for the years then ended.

G. Subsequent Events

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through August 27, 2025, the date of financial statement issuance.

NOTE 3: FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include –

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Pooled Separate Accounts: The Plan holds units of participation in pooled separate accounts, which are valued daily at their accumulation unit value. Accumulation unit value is determined based on the net asset values of the underlying funds, which are quoted in active markets, and the contract's separate account charges. There are no transfer or redemption restrictions, and no unfunded commitments on these investments. Each subaccount holds shares of a single underlying mutual fund, which is actively traded.

Fixed Income Annuities: The recorded values for fixed income options are reported daily based on the discounted cash flow valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement as the reporting date.

NOTE 5: PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company has not expressed any intent to terminate the plan. However, in the event of plan termination, participants will become 100% vested in their accounts.

NOTE 6: TAX STATUS

The Internal Revenue Service has determined and informed the company by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7: RELATED PARTY AND PARTY-IN INTEREST TRANSACTIONS

All plan investments are either shares of units of pooled separate accounts managed or contracts issued by the trustee of the Plan, Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the trustee as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan sponsor pays a portion of the Plan's expenses directly. The amount of these expenses is not material to the financial statements for the Plan year 2024. The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
