Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rapp Operations LLC 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended November 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Rapp Operations LLC 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Emphasis of Matter — Plan Merger

As discussed in Note E to the financial statements, the board of directors of the Company voted on August 14, 2024 to merge the Plan into the Reliable Doors LLC 401(k) Plan effective October 1, 2024. All Plan assets were transferred to the Reliable Doors LLC 401(k) Plan on November 8, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rapp Operations LLC 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A- DESCRIPTION OF PLAN

The following description of the Rapp Operations, LLC 401(k) Profit-Sharing Plan and Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The terms "Company" and "Plan" shall refer to Rapp Operations and the 401(k) and profit-sharing plan, respectively.

General:

The Plan is a defined contribution plan covering all employees who have completed two months of service, beginning on the date of hire, and are aged twenty-one years or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investments, monitors investment performance, and reports to the Plan's Board of Directors. The Plan's trustee is Reliance Trust Company. The Plan's administrative agent is ADP Retirement Services.

Contributions:

All participant contributions during a Plan year are subject to maximum dollar limitations established by the IRC. For the period ended November 30, 2024, the total maximum allowable tax-deferred contribution to the Plan under the IRC from employee sources was \$23,000, plus catch-up contributions of \$7,500 for eligible employees. In addition, participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual fund accounts and common/collective trust funds, which includes a Stable Value Investment contract, as well as various index funds as investment options for participants. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan. Unless a participant makes an affirmative election, the Employer will withhold 1% of eligible compensation for each payroll period.

The Company may make a discretionary matching contribution equal to 50 percent of the participant's elective deferrals. The Company match is limited to 6% of a participant's compensation. The matching contributions are invested in funds directed by the eligible participants in the Plan. Additional discretionary profit-sharing amounts may be contributed at the option of the Company's board of directors which are also invested in funds as directed by the participants of the Plan. No such additional contributions were made in 2024.

Participant Accounts:

A separate individual account is established for each participant in the Plan. Each participant's account is credited with the participant's contribution, any Company matching contribution and allocation of investment earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants' contributions and rollover contributions plus actual earnings thereon are 100% vested at all times. Participants vest in Company contributions based upon the following schedule:

Notes Receivable from Participants:

Participants may borrow for any purpose, a minimum of \$500 and a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. Loans are repayable over a period of up to five years. Loans are secured by the participant's account balance and evidenced by a promissory note. Interest rates on outstanding loans are stated at the prime rate plus 2%. All loans, principal plus interest are repaid

through participant payroll deductions.

Payment of Benefits:

Upon termination of service due to death, disability or retirement, a participant becomes 100% vested and may receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in installments over a period of time not more than the participant's (or beneficiary's) assumed life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the participant's vested account balance is less than \$5,000, then a lump sum distribution is required.

Forfeited Accounts:

Forfeitures must be disposed of no later than the last day of the Plan Year in which the forfeiture occurs. The Employer may direct the Administrator to use forfeitures to reinstate previously forfeited account balances of participants, to satisfy any contribution required, or to pay Plan expenses. At November 30, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$14, respectively. During 2024, \$29,303 of forfeitures were used to reduce employer contributions.

NOTE B- SUBSEQUENT EVENTS

Subsequent events were evaluated through September 15, 2025, which is the date the financial statements were available to be issued.

NOTE C- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements are prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of

assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants:

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of November 30, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at the net asset value ("NAV") of shares held by the Plan at year end. The investment in the common/collective trust ("CCT") is stated at fair value, as determined by the issuer of the CCT, based on the fair market value of the underlying investments. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE D- FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Investment Committee determines the Plan's valuation policies. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and they have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices included in Level 1, (i.e., quoted prices for similar assets or liabilities in active markets), and Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were available to the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish

their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

The fair value of participation units in common/collective trust funds is based on net asset values reported by the fund manager as of the financial statement dates.

Level 3 Fair Value Measurements

Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the period presented.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds. Valued at the unit price reported by the sponsoring trust company. The underlying investments owned by the funds can include money market funds, stable value funds, fixed-income securities, registered investment companies, common stocks, corporate bonds, U.S. Government Securities, other collective trust funds, or guaranteed insurance contracts priced by the sponsoring insurance company using applicable interest rates and contract provisions. The unit price is based on the fair value of these underlying investments owned, less any accrual of fees and expenses borne by the fund and divided by the number of units outstanding. The unit price is readily determinable and quoted on the active private market on which participants can transact daily with no redemption restrictions on these investments.

NOTE E- PLAN MERGER

On November 8, 2024, the Plan merged with Reliable Doors, LLC 401(k) Plan. As a result, net assets of \$3,600,926 were transferred to the control of Reliable Doors, LLC 401(k) Plan. The merger did not impact participant benefits, as the benefit provisions were incorporated into the Reliable Doors, LLC 401(k) Plan.

NOTE F- TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated October 6, 2020, that the Prototype Non-standardized Profit Sharing Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and accordingly is exempt from taxation.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both November 30, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
