## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of Daxko, LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all full-time employees of Daxko, LLC (the Company) upon employment who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may elect to make pretax and/or Roth contributions of up to 90 percent of eligible annual compensation (as defined in the Plan document), not to exceed federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to 100 percent of eligible annual compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan provides for an automatic deferral feature of two percent of eligible compensation for newly eligible employees 35 days after the employee's date of hire unless they elect otherwise. The Plan also provides for an automatic annual increase of one percent per year up to seven percent of eligible compensation for existing participants. The automatic annual increase may continue above seven percent of eligible compensation if the participant elects to continue in the annual increase program.

The Plan provides for a discretionary Company matching contribution. For the year ended December 31, 2024, the Company contributed 50 percent of the first seven percent of pretax eligible annual compensation that a participant contributed to the Plan. Contributions are subject to certain limitations.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

#### **Participant Loans**

Through a company acquisition, the Plan assumed participant loans which are currently in repayment status. No new loans are allowed in the Plan.

## Daxko, LLC 401(k) Retirement Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution, and earnings or losses from that participant's account activity. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Benefit Payments**

On termination of service due to separation, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals. In-service withdrawals, including hardship withdrawals (from participant deferral contributions only), may be available as defined in the Plan document.

##### **Administrative Expenses**

Certain administrative expenses of the Plan have been paid by the Company, including accounting and trustee fees. Participant initiated distribution fees are charged directly to the participant's account. All other administrative expenses including recordkeeping, investment advisory and investment transaction fees (including investment-related expenses which are included in net appreciation in fair value of investments) are paid by the Plan.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company discretionary matching contribution portion of their account is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

##### **Forfeitures**

Forfeitures of terminated participants' nonvested accounts may be used first to pay administrative expenses of the Plan and then used to reduce future Company contributions.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company discretionary matching contributions.

#### **2. Summary of Significant Accounting Policies**

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and any investment-related expenses.

The Plan provides for investments in various investment securities that in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Basis of Presentation**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

##### **3. Investment Information**

All information related to investments and participant loans disclosed in the accompanying financial statements and supplemental schedule, including investments held and participant loans receivable at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

##### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### 4. Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: valued at the NAV of units of bank collective trusts. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Tax Status**

The Company adopted a non-standardized pre-approved profit-sharing plan with a cash or deferral arrangement that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

#### **6. Subsequent Events**

Management of the Company evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 14, 2025, which is the date the financial statements were available to be issued.
