INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Psych Associates Group LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Psych Associates Group LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Psych Associates Group LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) adopted on January 1, 1998. The Plan covers substantially all employees of Psych Associates Group LLC dba Bloom Health Centers and its affiliate Psych Associates of Maryland LLC (collectively the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 1, 2024, the Plan appointed Principal Trust Company and Principal Life Insurance Company (collectively Principal) as Plan custodian. Capital Bank and Trust Company served as the trustee of the Plan until March 26, 2024, at which time all Plan assets were transferred to Principal. The conversion initiated a blackout period beginning March 18, 2024, and continuing through April 14, 2024. During this period, funds could not be applied to the employee-selected funds with the custodian or withdrawn from the Plan until the custodian could complete the conversion. Employee contributions through payroll deductions continued to be made during the blackout period, and the contributions were deposited and held in the plan general account at Principal, until the completion of the blackout period. At the end of the blackout period, such funds were transferred to the investment options requested by each participant. The account balance and all future contributions of participants who had not provided investment instructions prior to the blackout period were invested in the Qualified Default Investment Alternative (QDIA) selected by the Plan. The Plan's QDIA includes the American Funds Target Date Retirement portfolios.

Effective January 1, 2024, the Plan adopted a prototype defined contribution plan documents sponsored by Definiti LLC and appointed Definiti LLC as the Plan's third-party administrator. There were no changes in the plan provisions.

Eligibility

The Plan covers all employees aged 21 and older except union, leased, non-resident alien with no U.S. source income, interns, part-time, seasonal and temporary employees of Psych Associates Group LLC. Part-time, seasonal and temporary employees become eligible to participate in the plan when they have completed at least 1,000 hours of service within the reporting period. The entry date for the Plan is the first day of the calendar month coinciding with or next following the date the employees satisfy the eligibility requirements.

Contributions

Participants may contribute on a pre-tax or after-tax basis up to 100% of their annual compensation, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC).

Contributions (Continued)

The after-tax "Roth" contributions are subject to federal income taxes in the year of deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts and a fully benefit responsive guaranteed investment contract as investment options for participants.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are auto enrolled in the Plan with a default deferral rate set at 6% of eligible compensation unless they affirmatively elect not to participate.

Effective January 1, 2024, the Company provides a safe harbor matching contribution for all eligible employees equal to 100% of participant pre-tax or after-tax deferrals up to 3% of eligible compensation, plus 50% of deferrals between 3% and 6% of compensation. During 2024 and 2023, the Company made safe harbor matching contributions to the plan in the amount of \$587,573 and \$578,968 (net of forfeitures), respectively (gross amount was \$740,984 and \$662,721, respectively).

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions and allocations of the Company's contributions, investment earnings and losses and any administrative expenses paid by the plan. Allocations are based on participant investments held, account balances, or specific participant transactions, as defined. Plan participants have daily access to their account via phone or internet and may change the allocation of their investments to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals, rollovers, and all earnings thereon. Vesting in the safe harbor match, employer discretionary matching contributions and discretionary profit-sharing contributions is based on years of continuous service. Prior to March 1, 2024, participants became 20% vested in their employer discretionary matching and profit-sharing contributions after two years of service, and the vesting percentage increased by 20% each year until participants became fully vested in their account after six years of service.

Effective January 1, 2024, participants become fully vested in their employer safe harbor matching contributions after two years of service. A participant will also become fully vested upon attainment of normal retirement age, retirement due to disability, upon death, or upon termination of the Plan.

Notes Receivable from Participants

Participants in the Plan may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their eligible account balance, reduced by any outstanding note balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Loan terms range from one to five years, or longer for the purchase of a principal residence. Plan participants may have up to one loan outstanding at any one time. Principal and interest are paid ratably through payroll deductions. The interest rates of the outstanding loans at December 31, 2024 and 2023 ranged from 5.25% to 9.50% and from 5.00% to 9.00%, respectively.

Payment of Benefits

Upon termination of service due to retirement, death, full and permanent disability or attaining age 65, participants may elect to receive either a lump-sum amount equal to the value of their account, a direct rollover into a qualified retirement plan, or a combination of cash and direct rollover distribution. For termination of service due to other reasons, participants may receive their benefits in the form of a distribution equal to the value of the vested interest in their account. Partial withdrawals or installments are only permitted for required minimum distributions. The Plan allows in-service withdrawals at age 59 1/2 and hardship withdrawals under certain circumstances, as defined in the Plan document.

Forfeited Accounts

Forfeitures may be used to reduce employer contributions at the discretion of the employer or to pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$453 and \$1,953, respectively. During the years ended December 31, 2024 and 2023, the Plan used \$153,411 and \$83,753, respectively of forfeited nonvested accounts to reduce employer contributions. During the years ended December 31, 2024 and 2023, the Plan used \$3,341 and \$-0-, respectively of forfeiture funds to pay plan expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts (FBRIC). Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to FBRIC because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for FBRIC, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Due to plan sponsor

Amounts due to plan sponsor represent the refund of excess matching contributions in order for the Plan to comply with the safe harbor provisions.

Contributions

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid either by the Plan or directly by the Company. The Plan is not required to reimburse the Company for expenses paid on behalf of the Plan.

Administrative Expenses (Continued)

Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified by the trustee and custodian of the Plan, as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA as follows:

- by Capital Bank and Trust Company, the plan trustee as of and for the year ended December 31, 2023, and for the period ended March 25, 2024; and
- by Principal Life Insurance Company and Principal Trust Company (collectively Principal), the custodian of the Plan as of and for the year ended December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission, valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSA)

The PSA are primarily invested in mutual funds. The PSA are valued daily at the unit value of shares held by the Plan in the separate investment accounts based on the underlying mutual funds and their quoted net asset value (NAV). The NAV of the PSA is not publicly quoted but is available to current investors via the Company website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, those investments are considered to have a readily determinable fair value. The PSA are classified in Level 2 in the fair value hierarchy.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT - FBRIC

The Plan has a fully benefit-responsive investment contract (FBRIC) with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The FBRIC is a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Under the terms of the existing contract, the crediting interest rate is based on a formula agreed upon with the issuer.

The crediting rate is currently reset on a semiannual basis and will not be less than the guaranteed minimum interest rate. In no case will the guaranteed minimum interest rate be less than 0.15% or greater than 3%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The FBRIC is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The FBRIC does have a surrender charge of 5% that may be charged if the Plan terminates its interest in the contract.

Certain events limit the ability of the Plan to transact at account value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Plan investments are managed by Principal and Capital Bank and Trust Company (CBT). American Funds is the mutual fund division of Capital Group Companies, Inc. CBT was the trustee of the plan as of and for the year ended December 31, 2023, and for the period ended March 25, 2024. Principal serves as custodian of the Plan as of and for the year ended December 31, 2024, and also provides recordkeeping services to the Plan. Therefore, these transactions qualify as party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the plan. There were no financial transactions recorded between the Company and the Plan other than contributions made. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 8 - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing plan sponsored by Definiti LLC. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - LATE REMITTANCES

During the year ended December 31, 2023, the Company failed to remit to the plan custodian participant contributions totaling \$457 within the period prescribed by Department of Labor regulations. These contributions are considered nonexempt party-in-interest transactions. The Company calculated lost earnings on the delinquent remittances and remitted the amount to the Plan on July 23, 2024, at which time the lost earnings were allocated to the affected participants' accounts.

NOTE 11 - VOLUNTARY COMPLIANCE

Subsequent to December 31, 2023, the Company determined that the incorrect definition of eligible compensation had been used during 2023. The plan document defines eligible compensation as W-2 wages, however, the Company excluded bonuses paid to certain employees from the compensation for the purpose of calculating plan contributions. As a result, the affected participants' contributions were less than what they should have been had the correct definition of eligible compensation been used. The Company self-correcting the error on November 29, 2024 by making corrective contributions to the affected participants' accounts for the missed deferrals and match and the associated lost earnings. The calculated corrective contributions totaled \$9,824 and \$12,278 for the missed deferrals and match, respectively, and are included in employer contributions on the statements of changes in net assets available for benefits.
