Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedule Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule (modified cash basis), other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule (modified cash basis) that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. I. Description of Plan

The following brief description of the M Management, Inc. 401(k) Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

A. General

The Plan is a defined contribution plan covering substantially all employees of M Management, Inc., Moishe's Moving Systems, LLC, Milk Studios, LLC, Guarantee Wine Storage Inc., House Productions, LLC, GRM Information Management Services of Atlanta, LLC, GRM Information Management Services of Philadelphia, LLC, Moishe's Guarantee Asset Management, LLC, GRM Information Management Services, Inc., Guarantee Records Management, LLC, GRM Information Management Services of California, LLC, GRM Information Management Services of Miami, LLC, GRM Information Management Services of Chicago, LLC, GRM Information Management Services of San Francisco, LLC, Milk Studios of Los Angeles, LLC, House Productions of Los Angeles, LLC, Moishe's Self Storage, GRM Document Storage, LLC, GRM Information Management Services of Boston, LLC, GRM of Indiana, Milk Agency, LLC, Lilian Properties, LLC, GRM Information Services of Austin, LLC, Mana Miami Management, LLC, Mana Wine, LLC, GRM Information Services of Dallas, LLC, Maya Properties, LLC, 888 Mana Cultural, LLC, Moishe's Mini Storage of Chicago, LLC, Mana Common Marketing, Visual Vault, JC Metal Shop and Maintenance, LLC, Zappix Inc., Milk Made, LLC, and Mana Decentralized Art, (collectively known as the "Company"), who are age twenty-one or older and have completed one year of service and 1000 hours of service. Upon satisfying eligibility requirements, each employee can commence making elective contributions to the Plan on the following January 1, April 1, July 1, or October 1. The Plan was amended effective January 1, 2022 to allow participation after 6 months of service and to allow participants to change their deferral elections at the beginning of each payroll period. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA) and was adopted effective December 1, 2020. During 2023, Milk Makeup, LLC formed their own Plan and the assets of the Participants' of Milk Makeup, LLC were transferred to the Milk Makeup, LLC 401(k) Plan.

B. Contributions

Each year, participants may contribute up to 90% of pretax annual compensation up to the maximum amount allowed by the Internal Revenue Code, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans, subject to the rules of the Plan. The Company has elected to make safe harbor matching contributions on behalf of each employee who has elective contributions under the Plan. The amount of the matching contribution will be 100% of the participant's elective contributions that do not exceed 6% of compensation. The Company may make an additional discretionary non-matching contribution. Contributions are subject to certain limitations.

C. Participants' Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are immediately vested in all contributions, including Company matching contributions plus actual earnings thereon.

E. Forfeited Accounts

Forfeitures arising under the Plan shall be used to reduce future employer contributions and / or pay plan expenses. As of December 31, 2024 and 2023, forfeited non-vested account balances totaled \$28,897 and \$22,419, respectively. During the years ended December 31, 2024 and 2023, forfeiture balances were used to reduce plan expenses in the amounts of \$1,677 and \$21,991, respectively. Forfeitures generally occur if the Plan Sponsor over matches the participants.

F. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or fifty (50) percent of their vested interest. Loan terms range to a maximum of five (5) years (the term may be extended for acquisition of a principal residence). The loans are secured by the balance in the participant's account.

G. Payment of Benefit

Upon termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, or installments over a specific number of years, as defined in the Plan. In service withdrawals may be permitted after attaining age 59 1/2, or in the event of an immediate financial hardship, as defined in the Plan. Hardship withdrawals are subject to certain restrictions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which differs from generally accepted accounting principles since the contributions, and any related contribution corrections, including gain and loss adjustments, are recorded when received, rather than when earned.

Common/Collective Trusts

The Plan has an investment, the GS Stable Value SELI Fund, in a common/collective trust. Common collective trust funds are comprised of shares or units in commingled funds that are not publicly traded. The underlying assets in these funds are primarily publicly traded equity securities, fixed income securities, and commodity related securities and are valued at their NAV, as a practical expedient, that is calculated by the investment manager or sponsor of the fund and have varying liquidity, redemption period notices and other restrictions. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net Appreciation on Investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan may be paid by the Company or by the Plan.

3. Funding Policy

This Plan is funded by participating employees who make elective contributions to the Plan, pursuant to the Internal Revenue Code Section 401(k). The Plan is also funded through an employer matching contribution. Employer contributions for the year ended December 31, 2024 were \$2,138,588.

4. Information Certified by Plan's Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's rules and regulations for reporting and disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified as complete and accurate by Fidelity Management Trust Company and was not subjected to any auditing procedures by the independent public accountants:

5. Investments

The Plan's investments are administered by Fidelity Management Trust Company and are held in a trust fund.

During 2024, the Plan's investment (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$4,636,746.

6. Fair Value Measurements

Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlations or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Reported at fair value using the net value ("NAV") of shares held by the Plan at year end and not classified in the fair value hierarchy in accordance with ASC subtopic 820-10. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

Money Market Fund: Valued based on short-term cash components at the measurement date and classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Related Party Transactions and Parties in Interest

Certain Plan investments are registered investment company funds and a money market fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee of the Plan assets and, therefore, these transactions qualify as party in interest as identified on Schedule H, Line 4i - Schedule of Assets (Held at End of Year).

Participant notes receivable qualify as party-in-interest transactions as identified on Schedule H, Line 4i - Schedule of Assets (Held at End of Year).

The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The Company may also pay quarterly record keeping charges and other charges for the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are automatically 100% vested in their accounts.

9. Tax Status

The Company adopted a Prototype Tax-Favored Savings and Discretionary Contribution 401(k) Plan with a cash or deferral arrangement that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The favorable opinion letter stated that the Plan is designed in accordance with applicable sections of the IRC. The plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
