## Independent Auditors' Report

To the Plan Administrator of  
National Employee Management Resources 401(k) Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of National Employee Management Resources 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of National Employee Management Resources 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

### Basis for Opinion

**1. Description of Plan**

The following description of the National Employee Management Resources Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering eligible employees of National Employee Management Resources (the "Employer"), an employee leasing company. The Plan was established effective January 1, 2014. The Plan offers a 401(k) option to multiple employers. All participating employers of this multiple employer plan have signed co-adoption agreements that enable them to accept or modify the elections of a master plan document to meet their needs. Each company's adopted plan agreement should be referred by the participants for additional information regarding plan specifications. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

*Contributions*

Each year, participants may contribute a portion of their pre-tax compensation, as defined in the plan, subject to certain Internal Revenue Code limitations. In addition, after-tax contributions may be made from 1% to 15% of participant's compensation. Participants are eligible once they reach the age of 21. Participating employers may contribute a discretionary percentage of the amount deferred by the employees. The employer may also contribute a discretionary amount as determined each year by the participating employer. Effective August 1, 2014 participants may designate a portion of their contributions to be treated as Roth contributions and are subject to current federal income tax at the time of contribution to the Plan. Contributions are subject to certain limitations.

*Funding Policy*

Most of the participating employers make monthly contributions to the Plan on behalf of covered employees in amounts determined by the signed co-adoption agreements. Certain employers make a contribution by the due date of their corporate tax return.

*Participant Accounts*

Each participant's account is credited with the participant's contribution, the company's matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of Plan expenses are based on participant account balances, or specific transactions directed by the participant as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

*Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. For certain employers, vesting in the Company's contribution portion is based on years of continuous service. A participant is 20% vested after two years of service and an additional 20% each year thereafter; participants are fully vested after six years of service. Other employers offer immediate vesting upon payment of the employer's contribution.

*Participant Loans*

Participant loans are a Plan option that must be elected by the co-adopting employer. The rules are covered in a separate loan application form and promissory note form and loans must be applied for through the plan administrator. Participants may borrow from their employee elective deferral accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with prevailing rates as determined quarterly by the plan administrator. Loan terms range from 1-5 years or up to a reasonable amount of time for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

*Payment of Benefits*

Participants will receive the full amount of their vested account balances in the event of normal retirement, termination of service, death or disability. Early withdrawals are permitted at the participant's request after the age of 59-1/2. Certain hardship withdrawals are also permitted. Distributions will be made in lump-sum payments, joint and survivor annuities or pre-retirement survivor annuities.

*Hardship Withdrawals*

The Plan provides for hardship withdrawals, not to exceed an amount required to meet the immediate need created by the hardship, and then only to the extent such immediate need cannot be satisfied by other sources readily available to the participant. Permissible circumstances for hardship withdrawals include education expenses, costs directly related to the purchase of a principal residence, and costs necessary to prevent eviction from the participants' personal residence and such other circumstances as the Plan Administrator may determine based on rules set forth in the Internal Revenue Service regulations.

*Forfeited Accounts*

All forfeitures from non-vested interests in the Plan occurring during the plan year shall be applied to reduce employer contributions. In addition, forfeitures shall be calculated and applied separately with respect to employees of each particular employer. Balances in forfeited non-vested accounts at December 31, 2024 and 2023 were \$50,424 and \$46,880, respectively, and are invested in the Key Guaranteed Portfolio Fund. During 2024 \$2,157 of forfeited balances were used to offset the employer contributions.

*Investment Options*

Participants direct the investment of their employer contributions into various investment options offered by the Plan. The Plan currently offers a variety of registered investment companies, one pooled separate account and a Key Guaranteed Portfolio fund to participants.

**2. Summary of Significant Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with FASB Accounting Standards Codification (ASC 962).

*Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities.

*Notes Receivable from Participants*

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a deemed distribution is recorded. On a periodic basis, the Plan sponsor evaluates notes receivable from participants and if necessary, establishes an allowance for doubtful accounts. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Fair Value Accounting*

Valuation techniques used in fair value measurements maximize the use of observable inputs and minimize the use of unobservable inputs. A valuation method may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date. Assets and liabilities measured at fair value are categorized into one of three different levels depending on the observability of the inputs employed in their measurement. Level 1 inputs are quoted prices in active markets for identical assets or liabilities. Level 2 inputs are observable inputs other than quoted prices included within Level 1 for the asset or liability, either directly or indirectly through market-corroborated inputs. Level 3 inputs are unobservable inputs for the asset or liability, including the Plan's own assumptions in determining the fair value of the assets or liabilities.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold during the year.

*Administrative Expenses*

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Certain costs such as the annual contract fees are paid by the Plan. Certain other administrative and auditing fees are paid by the Employer. A Plan expense account (the "ERISA account") is maintained to hold revenue sharing funds the Plan receives from Empower Retirement Services pursuant to an agreement between Empower Retirement Services and the Plan. These revenue sharing funds are available to pay qualified Plan administrative expenses. For the year ended December 31, 2024 \$95,681 was used to pay Plan expenses.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not have an amount payable in excess contributions during the 2024 or 2023 plan year.

*Payment of Benefits*

Benefits are recorded when paid.

*Concentrations*

The investments of the Plan are held in publicly traded mutual funds, collective investment funds and are administered by Empower Trust Company. Investments that represent 10% or more of total plan assets are separately identified.

*Date of Management's Review*

Subsequent events have been evaluated through September 3, 2025 which is the date the financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1	Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds are valued at quoted market prices, which represent the Net Asset Value (NAV) per share at the close of the financial markets. The NAV is based on the value of the underlying assets owned by the investment, minus its liabilities and then divided by the number of shares outstanding. Mutual funds report NAV daily and are required to transact at that price.

Pooled Separate accounts are valued at NAV each day by the trustee. The NAV is based on the value of the underlying assets owned by the investment, minus its liabilities and then divided by the number of shares outstanding. The NAV of a pooled separate account is used as a practical expedient to fair value.

**4. Guaranteed Investment Contract**

The Plan entered into a fully benefit-responsive guaranteed investment contract with Empower Trust Company, LLC (Empower Trust Company). Empower Trust Company maintains the contributions in a general account. The account is credited with earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023, was \$519,627 and \$597,909, respectively, which approximates contract value. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed every quarter for resetting. Payout dates are the last day of each calendar month. The contract yielded 1.64% and 1.38% for the plan years ended December 31, 2024 and 2023, respectively.

*Limitations on Contract Value Transactions*

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, the issuer reserves the right to defer payment or impose restrictions under certain circumstances. These circumstances include, but are not limited to:

- The Plan's termination or partial termination.
- The Plan's failure to qualify under the Internal Revenue Code.
- The Plan's merger with another plan or transfer of assets to another plan.
- The complete withdrawal from the contract by the Plan.
- Amendments to the Plan that significantly affect the nature of the investment.

Employer-initiated events such as layoffs, plant closings, or early retirement programs that result in significant withdrawals.

The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value is probable as of December 31, 2024.

**5. Related Party and Party in Interest Transactions**

During 2024 the Key Guaranteed Portfolio Fund was managed by Empower Trust Company, LLC, as described in Note 4. In addition, certain investment and administrative fees may be deducted from participant accounts prior to the calculation of investment returns. Participant loans and plan investments in trustee-managed funds are party-in-interest transactions permitted under ERISA.

**6. Prohibited Transactions**

The Plan is required to remit participant contributions to the trust as soon as they can be reasonably segregated from the Employer's assets. During the year ended December 31, 2024, certain participant contributions totaling \$30,658 were remitted to the trust after the date on which such amounts could be reasonably segregated. These late remittances constitute nonexempt prohibited transactions under ERISA.

The Plan Sponsor has not remitted lost earnings to the affected participant accounts or paid any associated excise taxes, which are the responsibility of the Plan Sponsor and are not recorded in the Plan's financial statements. All amounts related to these late remittances have not been fully corrected as of the date of issuance of this financial statement.

Additional detail is provided in the Schedule of Delinquent Participant Contributions accompanying these financial statements.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Company may determine.

**8. Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Tax Status**

The Plan obtained its latest determination letter dated December 5, 2023, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.
