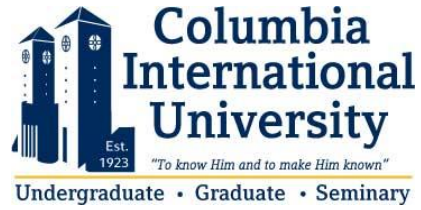

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF THE PLAN:

The following brief description of the Columbia International University 401(k) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan established by Columbia International University (University) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the University. All employees of the University who are 18 years of age or older and have completed three months of creditable service, as defined by the Plan, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees of the Plan are certain members of management of the University. The retirement committee is responsible for oversight of the Plan. The retirement committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

CONTRIBUTIONS

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, not to exceed the Internal Revenue Service (IRS) limitation, which was \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who have reached the age of 50, by the end of the Plan year, may make additional pre-tax "catch-up" contributions up to \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may designate all or a portion of their deferral as a Roth after-tax contribution.

During the years ended December 31, 2024 and 2023, the University made fixed non-elective contributions equal to 3% of compensation and matched employee contributions up to 4% of compensation for all eligible participants. Participants direct the investments of all contributions into various investment options offered by the Plan.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of the University's contributions and the Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

INVESTMENT OPTIONS

The Plan offers several investment options which are intended to meet the requirements of ERISA section 404(c) by providing participants with sufficient information to make informed investment choices. The investment options are managed by VALIC Trust Company, Inc., and Corebridge Financial is the third-party administrator and investment advisor.

1. DESCRIPTION OF THE PLAN, continued:

VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon, in addition to the University's matching contributions. Vesting in the University's non-elective contributions, plus earnings thereon, is based on completed years of qualifying service. A participant is 100% vested after 2 years of service.

Also, a participant will become 100% vested in his or her account balance on the date that he or she reaches the normal retirement age of 65, becomes disabled, or dies while still employed by the University, even if he or she has not achieved 2 years of service.

PAYMENT OF BENEFITS

Upon termination of service, disability, death, retirement, or attainment of age 65, a participant may take a distribution in the form of a lump sum payment. Withdrawals for financial hardship are permitted provided they are for an immediate and significant financial need, and the distribution is necessary to satisfy that need. The hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's account balance, whichever is less.

FORFEITURES

Forfeited balances of terminated participants' nonvested accounts are used to reduce future employer contributions and pay certain administrative benefits. During 2024 and 2023, forfeitures used to offset employer contributions totaled \$929 and \$17,773, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,427 and \$2,268, respectively.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual basis of accounting.

ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the paragraph below for a discussion of fair value measurements and Note 4 for a discussion on fully benefit-responsive investment contracts.

2. SIGNIFICANT ACCOUNTING POLICIES, continued:

INVESTMENT VALUATION AND INCOME RECOGNITION, continued

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FAIR VALUE MEASUREMENTS

The Plan uses appropriate valuation techniques to determine fair value based on inputs available. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs consist of unadjusted quoted market prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

Mutual funds are valued using Level 1 inputs, and are valued at the daily closing price as reported by the fund. There were no significant changes to valuation methodologies during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Some fees paid for the administration of the Plan and for the activities of the investment advisor are charged to the participants and deducted from the participants' accounts. The University pays any remaining administrative expenses of the Plan.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VALIC Trust Company, Inc. has certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule H, line 4i—schedule of assets (held at end of year), as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan has a benefit-responsive guaranteed investment contract with Corebridge Financial. Corebridge Financial maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Corebridge Financial, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the University has the right under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the University may determine.

6. TAX STATUS:

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The plan administrator timely adopted the restated prototype plan. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTIES-IN-INTEREST:

Certain investments of the Plan are contracts managed by Corebridge Financial. Corebridge Financial performs recordkeeping services for the Plan; therefore, these transactions qualify as party-in-interest transactions. Direct fees of \$86,769 and \$87,484 were paid to Corebridge Financial for the years ended December 31, 2024 and 2023, respectively.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through May 28, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
