## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of State Volunteer Mutual Insurance Company Thrift Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements

Years Ended December 31, 2024 and 2023

### **1. Description of the Plan**

The following description of the State Volunteer Mutual Insurance Company Thrift Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of State Volunteer Mutual Insurance Company (the Company) who have completed one hour of service, except those that work for the Company on a "seasonal" or "leased" basis. Employees hired or rehired by the Company on or after April 1, 2019, are automatically enrolled in the Plan contributing 6% of their eligible compensation. Charles Schwab Trust Bank (the Trustee) is the trustee of the Plan. Charles Schwab Retirement Plan Services, Inc. is the recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Administrative Expense**

The Plan's administrative expenses are paid by either the Plan or Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include a portion of the investment advisor, recordkeeping, and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate and are included as a reduction to investment income. Loan fees are paid by the participant and all other administrative expenses of the Plan are paid by the Company.

#### **Contributions**

Participants may make contributions of up to 15% of their annual compensation, as defined by the Plan document subject to certain Internal Revenue Code (the Code) limitations. Participants who have attained age 50 before the end of the Plan year and meet the Code limitations on pre-tax deferrals may make additional catch-up contributions to the Plan up to \$7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company matches 100% of the first 6% of the participant's compensation. Employees hired or rehired by the Company on or after April 1, 2019, receive a 2% non-elective annual contribution from the Company in addition to the existing match of 100% of contributions up to 6% of eligible compensation. Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Catch-up contributions are not matched.

## Notes to Financial Statements (continued)

### 1. Description of the Plan (continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions is based on years of service. Participants vest in the Company contributions ratably over six years of service. Participants will become 100% vested upon death, disability, or attainment of normal retirement age. Forfeited non-vested accounts can be used to reduce future Company contributions. During 2024 and 2023, \$14,491 and \$16,725, respectively, were used to reduce Company contributions to the Plan. There were remaining forfeited balances of \$38 and \$887 at December 31, 2024 and 2023, respectively.

#### Payment of Benefits

Participants (or their beneficiaries) will be eligible to be paid the full value of their vested accounts at normal retirement age, upon total or permanent disability, termination of service with the Company, or death. The method of payment is based upon the participant's election and may be made by a lump-sum payment or annual installments.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## Notes to Financial Statements (continued)

### **1. Description of the Plan (continued)**

#### **Participant Loans**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Interest rates are fixed for the term of the loan and are set by the Plan administrator based on the current prime rate. Principal and interest are paid ratably through semi-monthly payroll deductions.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The shares of mutual funds are valued at quoted active market prices that represent the net asset value (NAV) of shares held by the Plan at year-end. The fair value of collective trust funds is calculated using the NAV as a practical expedient on the last business day of the Plan year. See Note 4 for further discussion and disclosures related to fair value measurements.

The Trustee records purchases and sales of securities on a trade-date basis. Interest income is recorded as earned. Dividends are recorded when declared. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **2. Summary of Significant Accounting Policies (continued)**

#### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Subsequent Events**

Management has reviewed transactions and events occurring in the period December 31, 2024, through September 2, 2025, the date the financial statements were available for issuance, for anything that would require recognition or disclosure in the accompanying financial statements.

### **3. Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023; net appreciation in fair value of investments; interest, dividends, and capital gain distributions; other income; and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

### 4. Fair Value Measurements

The Plan has categorized investments that are measured at fair market value into the three level hierarchy established under the provisions of Financial Accounting Standards Board Accounting Standards Codification 820 based on the priority of the inputs to the respective valuation techniques. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 – Inputs utilize quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 – Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. Level 2 inputs may include quoted prices for similar assets and liabilities in active markets, as well as inputs that are observable for the asset or liability (other than quoted prices), such as interest rates, foreign exchange rates, and yield curves that are observable at commonly quoted intervals.
- Level 3 – Unobservable inputs for the asset or liability that reflect management’s best estimate of what market participants would use in pricing the asset or liability at the measurement date.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* These investments are public investment vehicles valued using NAV provided by the administrator of the fund. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Collective Trust Funds:* These investments pool the funds of multiple investors in order to participate in a wider range of investment than normally feasible for most investors and to share the costs and benefits in doing so. The Plan’s investments in collective trust funds do not have any unfunded capital commitments. Further, the Plan has the ability to redeem shares at the measurement date. These investments are public investments vehicles valued using the NAV practical expedient.

#### **4. Fair Value Measurements (continued)**

*Self-Directed Brokerage Accounts:* The investments in the self-directed brokerage accounts, which include money market, common stock, and mutual funds, are valued at the quoted prices in an active market and classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants' fair value measurements, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. Income Tax Status**

The underlying pre-approved plan has received an opinion letter from the IRS dated September 21, 2020, stating that the written form of the underlying pre-approved plan document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Related-Party and Parties-in-Interest Transactions**

Transactions with parties-in-interest include purchases and sales through the Trustee, notes receivables from participants, and contributions and plan expenses paid by the Company.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
