### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Schell & Kampeter, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS**

**1. DESCRIPTION OF THE PLAN**

The following description of the Schell & Kampeter, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

*General:* The Plan is a defined contribution plan covering employees of Schell & Kampeter, Inc., Diamond Pet Food Processors of South Carolina, LLC, Diamond Pet Food Processors of California, LLC, Sugar Creek, Inc., and Diamond Pet Food Processors of Ripon, LLC (collectively referred to as "the Employer"). The Plan was established January 1, 1989, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Eligibility:* Employees who have completed six months of service and have attained the age of 20 are eligible to participate in the 401(k) and matching portions of Plan. Prior to January 1, 2024, employees could then enter the Plan on the following January 1 or July 1. Effective January 1, 2024, employees can enter the Plan on the first day of each month after meeting the eligibility requirements. Prior to January 1, 2024, employees who had met the eligibility requirements were automatically enrolled in the Plan at a contribution rate of 3% of eligible compensation, unless otherwise elected by the employee. The contribution rate was automatically increased by 1% after two years and by an additional 1% each year until the contribution rate reached 6%. Effective January 1, 2024, the Plan was amended to change the automatic enrollment deferral rate to 6% of eligible compensation and remove the automatic escalation feature. Employees must have completed one year of service based on anniversary date of hire and be employed on the last day of the Plan year to be eligible to share in an allocation of the Employer discretionary contribution, unless these requirements are not met due to retirement, death or disability. Employees covered by a collective bargaining agreement are excluded from participation in the Plan.

*Contributions:* Each year, participants may contribute up to 100% of pre-tax or after-tax annual compensation, as defined in the Plan, not to exceed maximum amounts specified by the Internal Revenue Service (IRS), in accordance with a participant salary deferral agreement. Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$7,500 for 2024 and 2023, under certain conditions. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Employer is required to make a safe harbor matching contribution equal to 100% of each participant's deferral contributions up to 1% of participant salary, plus 50% of each participant's deferral contributions between 1% and 6% participant salary. The Employer met the required funding minimum. The Employer may also make discretionary profit sharing contributions to the Plan. In 2024 and 2023, the Employer contributed \$3,572,425 and \$3,176,146, respectively, in discretionary profit sharing contributions. Participants direct the investment of contributions into various investment options offered by the Plan.

*Participant accounts:* Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contributions, (b) Plan earnings, and (c) the participant's rollover contributions from other qualified benefit plans, if any, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are automatically 100% vested in the portion of their accounts resulting from participant salary deferrals. Participants vest in employer profit sharing contributions at a rate of 20% after two years of service and in 20% increments each subsequent year with full vesting in employer profit sharing contributions

occurring after six years of service. Participants vest in employer matching contributions at a rate of 100% after two years of service. A participant is considered to have one year of service for each one-year period in which he or she is employed on the anniversary date of hire.

Participants become automatically 100% vested in Employer contributions upon attaining normal retirement age of 65, early retirement, total disability, or death.

*Forfeitures:* Forfeitures may be used to pay Plan expenses or to reduce Employer contributions. During 2024 and 2023, forfeited nonvested accounts used to pay Plan expenses totaled \$189,944 and \$162,203, respectively. During the years ended December 31, 2024 and 2023, forfeitures used to reduce Employer contributions were \$44,422 and \$24,041, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts available for future use totaled \$58,736 and \$88,851, respectively.

*Notes receivable from participants:* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, excluding profit sharing balances. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with local prevailing rates as determined by the Plan administrator. Participants are limited to one loan per calendar year and one outstanding loan at any time. Principal and interest are payable ratably through payroll deductions.

*Payment of benefits:* Upon termination of service, a participant or his/her beneficiary may receive benefit distributions in one of the following forms:

- 1) Substantially equal payments.
- 2) A single lump sum payment (required for vested balances less than \$1,000), which may be in the form of a cash payout or rolled over into another qualified pension plan.
- 3) Partial withdrawals of at least \$1,000.

*Administration:* Standard Retirement Services, Inc. (Standard) is the Plan's third-party administrator and Reliance Trust Company (Reliance) is the Plan's custodian. Standard provides general professional and administrative services related to the Plan and maintains the participant accounts and reports to the Plan administrator and the participants. Reliance holds the Plan's assets, administers investment activity, and invests contributions into funds designated by each participant. Certain administrative and record-keeping costs are being absorbed by the Employer, while the Plan pays other costs. The Plan's trustees are responsible for the oversight of the Plan. The Plan's trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

*Basis of accounting:* The financial statements of the Plan are prepared under the accrual basis of accounting.

*Valuation of investments:* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the declaration date. Interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Contributions:* Contributions from plan participants and the matching contributions from the Employer are recorded in the year which the employee contributions are withheld from compensation.

*Notes receivable from participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

*Payment of benefits:* Benefits are recorded when paid.

*Expenses:* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Employer. No officer or employee receives compensation from the Plan for these services. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

*Estimates:* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Subsequent events:* Events that have occurred subsequent to December 31, 2024, have been evaluated through September 10, 2025, which represents the date the Plan's financial statements were approved by management and, therefore, available to be issued.

### **3. TERMINATED PARTICIPANTS**

Net assets available for benefits at December 31, 2024 and 2023 included \$8,345,565 and \$7,722,841 respectively, allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts may be paid within the next year, at the request of the participants. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

### **4. TAX STATUS**

The IRS has determined and informed Standard Retirement Services, Inc. by a letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan as amended through December 31, 2018, is in a form acceptable under Section 401 of the Internal Revenue Code (IRC). On January 1, 2022, the Employer adopted this plan as an amendment and restatement of the existing plan to bring the Plan into compliance with legislative and regulatory changes. There was no significant impact to the Plan as a result of this amendment and restatement. Effective January 1, 2024, the Plan was amended to change participant entry dates to the first day of each month and change the automatic enrollment deferral rate to 6% of eligible compensation.

The Company may rely on the opinion letter issued by the IRS as evidence that the Plan is qualified under the applicable sections of the IRC. The Plan is relying on the opinion letter. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **6. CERTIFICATION OF INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and the ERISA-required supplemental schedule of assets held at year-end related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **7. FAIR VALUE OF INVESTMENTS**

Plan investments are held in a trust and managed by Reliance, the Plan's custodian, and are unsecured. All investments are participant-directed and held by parties-in-interest.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of balances that are required or permitted to be measured at fair value for reporting in financial statements. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets recorded at fair value.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund on an active market which is based on the underlying net asset value (NAV) of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the net asset value (NAV) of the units of a bank or trust company collective trust held by the Plan at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of its underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are generally no restrictions as to the redemption of this investment nor does the Plan have any contractual obligations to further invest in the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 8. PROHIBITED TRANSACTIONS

The DOL considers late deposits of employee contributions to be nonexempt prohibited transactions. During the year ended December 31, 2023, the Employer inadvertently failed to remit certain January and December 2023 employee deferrals totaling \$345 to the Plan within the time frame required by the DOL under plan asset rules. The Employer remitted the late employee deferrals to the Plan in January 2023 and January 2024. Missed earnings of \$2 were paid to the Plan in August 2024.

## 9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include transactions with fiduciaries or employees of the Plan, any person providing services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, and relatives of parties-in-interest. The Plan has various parties-in-interest. Investments are held with parties-in-interest and certain fees are paid to parties-in-interest.
