INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Moore, Ingram, Johnson & Steele, LLP 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. PLAN DESCRIPTION

The following description of the Moore, Ingram, Johnson & Steele, LLP (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) is provided for general informational purposes only. Participants should refer to the Plan document, copies of which are available from the Plan Administrator, for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering all employees of the Company who have completed one year of service and are age 18 or older. An employee may elect to participate in the Plan at the first payroll of the month after becoming eligible to participate.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan’s management determines the appropriateness of the Plan’s investment offerings and monitors investment performance

B. Contributions

Eligible employees may make pre-tax and ROTH contributions up to 100% of eligible compensation as defined by the Plan but shall not exceed the maximum allowable deferral under Section 401 of the Internal Revenue Code (the “Code”) for any plan year. Participants who have attained age 50 before the end of the Plan year may elect to defer additional amounts (called "catch-up contributions") to the Plan up to the maximum allowable amount. Participants may change their deferral election percentage online on any business day. Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

The Plan was amended as of January 1, 2017 to provide for employer Safe Harbor matching contributions of 100% of the first 3% and 50% of the next 2% of an employee’s contributions. Prior to January 1, 2017, the Plan provided for a matching contribution of 50% of the first 6% of an employee’s contributions. Employer matching contributions are calculated and remitted with each payroll cycle. For 2024, the Company made \$517,375 in matching contributions.

C. Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollovers, the Company’s matching contributions, discretionary profit sharing contribution (if any), and a proportionate interest in the earnings or losses on investments in their account and is charged with transaction fees related to loans and hardship withdrawals received by that participant.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, an insurance investment contract and shares of closely-held stock as investment options for participants. Participants may change their investment options online on any business day. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Vesting

Participants are vested immediately in their contributions (elective deferrals and/or rollovers) plus actual earnings thereon. Beginning January 1, 2017, participants are 100% vested in their Safe Harbor matching contributions. For matching and or profit sharing contributions made before January 1, 2017, vesting on such contributions and earnings thereon is based on years of continuous service as follows:

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of the lesser of (a) 50% of the participant's vested account, reduced by any outstanding loan balance or (b) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over your current outstanding balance of loans as of the date of the new loan. Participant's may have a maximum of one loan outstanding for purchase of his/her primary residence and one loan for any other purpose. Generally, the term of a loan may not exceed five (5) years. However, if the loan is for the purchase of the Participant's principal residence, the Administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear annual interest rates ranging from 4.25% to 9.5% which are commensurate with local prevailing rates as determined by the Plan Administrator. The interest rate will be fixed for the duration of the loan. Principal and interest is paid ratably through bi-monthly/monthly payroll deductions or through payments directly to the Custodian.

F. Payment of Benefits and Withdrawals

On termination of service due to normal retirement, permanent disability or death; a participant or their designated beneficiary will receive payment of the participant's entire share of accumulated vested benefits of the Plan in a single lump-sum distribution if the vested account balance does not exceed \$5,000. If the vested account balance exceeds \$5,000, the participant or beneficiary may elect to receive the distribution as a single lump-sum, installments over a period of not more than the life expectancy of the participant or beneficiary or partial withdrawals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as described above. The participant may elect to have his/her vested account balance distributed as soon as administratively feasible following termination of employment. However, if the value of the participant's vested account balance does not exceed \$1,000, then a distribution will be made to him/her regardless of whether participant consents to receive it. The participant's contributions may also be withdrawn for certain hardship situations.

G. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively. These accounts are used to first pay plan expenses and then to reduce future employer contributions. In 2024, plan expenses were reduced by \$0 and employer contributions were reduced by \$0 from forfeited non-vested accounts.

H. Investment Options

Participants direct the investment of their account balances to various separate accounts sponsored by Minnesota Life Insurance Company (“Minnesota Life”). Participants may change their investment options online any business day and may change or discontinue their deferral percentages online any business day. Any modification becomes effective as soon as administratively feasible after it is received by the Administrator.

I. Plan Administration

The Company is the administrator for the Plan. The Standard f/k/a Securian Financial Group (“Standard”) is the recordkeeper and Minnesota Life has been appointed to serve as the custodian of the Plan’s assets.

J. Plan Adoption and Amendments

The Plan was originally effective on December 21, 1994 and was restated in January 2022 using Minnesota Life’s Non-Standardized Defined Contribution Pre-Approved Plan. The Summary Plan Description was also updated in January 2022.

The Plan implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow the Plan’s participants to take a COVID-19 related distribution up to \$100,000 beginning on or after January 1, 2020 and before December 31, 2020 and certain eligible individuals may receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

2. SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

B. Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 3 for discussion of fair value measurements.

The portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit- responsive investment contracts are reported at contract value. Contract value is the relevant measurement since it is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

E. Payment of Benefits

Benefits are recorded when paid.

F. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants or distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

G. Date of Management's Review of Subsequent Events

The Plan has evaluated subsequent events through September 15, 2025 the date the financial statements were available to be issued.

3. CERTIFIED INFORMATION AND FAIR VALUE MEASUREMENTS

As explained in Note 1.I., the Plan's assets are maintained by the custodian, Minnesota Life. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Minnesota Life. The Plan Administrator has instructed the independent auditors not to audit the information certified as complete and accurate by the custodian.

The framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable input and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Private Equity Funds: Valued at the final price per share price used by issuing entity for the year, which approximates fair value. Private equity funds held by the Plan are investments in businesses and are valued using the market approach.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In December 2011, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Minnesota Life totaling \$1,242,549 for 2024 and \$1,701,097 for 2023. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 2.14%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminated the agreement prior to the scheduled maturity date.

This contract meets the fully-benefit responsive contract criteria and, therefore, is reported as contract value. Contract value is the relevant measure fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the Plan's ability to transact at contract value with the issuer. Such events include but may not be limited to the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the issuer's consent.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Minnesota Life. Minnesota Life is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Contract administrator fees paid directly by the Plan for the investment management services totaled \$4,986 for the year ended December 31, 2024. As described in note 2.F., the Plan Sponsor pays directly for any fees related directly to the Plan's operations that are not related to the administration of notes receivable from participants or distributions to participants. Additional Fees paid to the custodian are netted against investment returns.

The above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would be fully vested in their employer contributions.

7. TAX STATUS

The Plan participates in a Non-Standardized Defined Contribution Pre-Approved Plan. The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the favorable opinion letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (“GAAP”) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities and successfully completed an audit of the 2012 tax return and there are currently no audits for any other tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
