Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SET Environmental, Inc. 401(k) Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1: Description of the Plan

The following description of the SET Environmental, Inc. 401(k) Savings Plan (Plan) provides only general information. Users of these financial statements should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by SET Environmental, Inc. (Company) and is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. All employees, except for excluded employees as defined in the plan document, are eligible to participate in the Plan. Employees must be 21 years of age to be eligible to participate in the Plan. Eligible employees are automatically enrolled into the Plan at a contribution rate of 6% of pretax compensation. Unless eligible employees opt out of the automatic enrollment contribution, the deferral percentage will be increased annually by 1% of pretax compensation, up to a maximum of 15%.

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation (salary reduction contributions), as defined in the plan document. Age 50 and over participants could contribute an additional \$7,500 in 2024. Participants are permitted to designate a portion, or all of the deferral contributions made as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Company, at its discretion, may make a profit-sharing contribution to participants on an annual basis. Effective January 1, 2024, the Company, at its discretion, may also make an employer-matching contribution. As approved by the Company's Board of Directors, a discretionary employer-matching contribution of \$429,992 was made for the year ended December 31, 2024. Contributions are subject to certain limitations.

Investment Options

Participants direct the investment of all contributions to various investment options offered by the Plan. The Plan currently offers various registered investment companies and common or collective trust funds as investment options for participants. The default investments for automatic enrollment are the registered investment company target date funds.

Participant Accounts

Each participant's account is credited with the participant's salary reduction contributions, rollover contributions and an allocation of the Company's contributions and plan earnings (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary reduction contributions, rollover contributions and Company discretionary profit-sharing contributions plus earnings thereon. Vesting in the discretionary employer-matching contributions plus earnings thereon is based on years of service as follows:

Years of Service	Vesting
Less than 1	0%
1 less than 2	20%
2 less than 3	40%
3 less than 4	60%
4 less than 5	80%
5 or greater	100%

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the plan agreement. The Plan provides for normal retirement at age 65 and early retirement on or after attaining age 55 and completing seven years of vesting service. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment. Participants experiencing financial hardship may withdraw a portion of this account balance as defined in the Plan. Participants may make withdrawals at age 59½ or for hardship, subject to \$500 minimum, prior to termination of employment.

Participants Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. These loans are secured by the balance in the participant's account. The trustee of the Plan will establish the loan interest rates on the first business day of the next month following any change in the prime rate. The loan period cannot exceed five years, unless the proceeds of the loan are used to purchase a primary residence for which the loan period shall not exceed ten years. At December 31, 2024, the interest rates on the notes ranged from 4.25% to 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan and the Company. Additionally, certain employees of the Company provide administrative and trustee services to the Plan and the Company is not reimbursed by the Plan for such services.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments in shares of registered investment companies are valued at quoted market prices.

The common or collective trust funds are valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liability. The Plan's interest in the common or collective trust funds is valued based on information reported by the investment advisor using the audited financial statements of the collective trusts at year end. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

Note 3: Information Certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Personal Trust Company, FSB, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, cash and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from participant notes receivable as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Income Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by Sentinel Benefits Group, Inc. This non-standardized profit sharing plan has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated November 30, 2020, from the Internal Revenue Service stating that the profit sharing plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA.

Note 7: Party-in-Interest Transactions

Certain plan investments are managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. Expenses paid to parties-in-interest were \$185,935 in 2024.

Note 8: Subsequent Events

Subsequent events have been evaluated through August 12, 2025, which is the date the financial statements were available to be issued.
