Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Tawa Supermarket, Inc. 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Tawa Supermarket, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

General – The Plan was adopted by Tawa Supermarket, Inc. (the “Company”) as of July 1, 1992, and restated as of April 1, 2016. The Plan is a defined contribution plan covering substantially all employees of the Company. The Plan also covers eligible employees of Welcome Market, Inc. effective July 1, 1992; Walong Marketing, Inc. effective June 4, 1999; Tawa Nevada, Inc. effective February 26, 2009; Tawa Inc. effective February 13, 2009; Tawa Services, Inc. and Welcome Services, Inc. effective January 1, 2012; and Welcome California Market, Inc. effective April 1, 2016, all affiliates of the Company. The Company; Welcome Market, Inc.; Walong Marketing, Inc.; Tawa Nevada, Inc.; Tawa, Inc.; Tawa Services, Inc.; Welcome Services, Inc.; and Welcome California Market, Inc. are herein collectively referred to as the “Companies.”

Effective July 1, 2023, the Plan’s employee salary deferral and employer match contribution age and service eligibility criteria were amended.

Plan administration – The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the Fiduciary Retirement Committee (the “Committee”) of the Companies. Plan assets are held, under the direction of the Committee, by Bank of America N.A. Bank of America Merrill Lynch (“BAML”) serves as the Plan’s recordkeeper.

Eligibility – Effective July 1, 2023, employees of the Company are eligible to participate upon reaching age 20.5 and after completing two months of service. Employees are eligible to receive employer matching contributions upon reaching age 20.5 and after completing one year of service.

Contributions

Participant contributions – Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions and transfer part or all of a non-Roth fully vested account to a Roth account within the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer match contributions – The Companies match 100% of employee contributions, up to 4% of each participant’s earnings contributed. Contributions are made by the Companies for their respective participants.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contributions and the Companies’ matching contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting – Participant contributions and related earnings are fully vested immediately. Contributions from the Companies vest 20% after two years of continuous service and increase by 20% for each year of service thereafter; participants are fully vested after six years of continuous service. Benefits attributable to each participant will become fully vested in the event of death, total disability, and normal retirement at age 65 or upon partial or total plan termination.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 30 years. Plan loans will bear interest at 2% over the prime rate. As of December 31, 2024 the rates of interest on outstanding loans ranged from 5.25% to 10.50%, with various maturities through September 2049.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum payment or periodic installment payments or transfer the balance in his or her account to another qualified plan. Vested accounts of \$1,000 or less will be automatically paid in a lump-sum amount. Vested accounts between \$1,001 and \$5,000 will be subjected to an automatic IRA rollover. Participants are allowed to defer receiving their vested benefits if above \$5,000.

A participant may make withdrawals from his or her account (except as provided in the Plan Document) upon reaching age 59 ½ or on becoming disabled. Withdrawals may also be made for financial hardship, which is determined pursuant to the provisions of the Internal Revenue Code (IRC).

Administrative expenses – Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Total administrative expenses for the year ended December 31, 2024, amounted to \$400,629.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to reduce employer contributions under the Plan, with any remaining amount to offset plan administrative expenses. Finally, any remaining forfeitures will be allocated to participants. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$43,701 and \$67,068, respectively. Forfeitures in the amount of \$206,000 were used to offset employer match contributions during the year ended December 31, 2024.

Plan termination – The Companies anticipate and believe the Plan will continue without interruption but reserve the right to terminate the Plan, in part or in whole, at any time. In the event that such discontinuance results in termination of the Plan, participants become 100% vested in their entire account balance and the Plan's net assets will be allocated among the participants in accordance with the terms of the Plan and ERISA.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's trustee, Bank of America N.A., certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits – Benefits are recorded when paid.

Risks and uncertainties – The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Tawa Supermarket, Inc. 401(k) Plan Notes to Financial Statements

Interest-bearing cash – Valued at the carrying amount which approximates fair value due to their short maturities.

Collective trust – Units held in the collective trust (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The Plan has investments in one CT, the Federated Capital Preservation Fund.

The Federated Capital Preservation Fund is a CT that invests primarily in guaranteed investment contracts (traditional GICs), separate account GICs, and synthetic GICs. Participants may purchase units of the CT daily based on the established NAV practical expedient of \$10. Participants may redeem units of the CT for the purpose of funding a bona fide benefit payment, making a participant loan, honoring an employee-directed transfer of the employee's interest in the Plan to another noncompeting investment option, or paying trustee fees. Participants may make withdrawals from the CT for other purposes generally only upon 12 months' advance written notice to the trustee. There were no unfunded commitments for the CT as of December 31, 2024 and 2023.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes to Financial Statements

Note 4 – Tax Status

The Plan Document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions. During 2024, the U.S. Department of Labor opened an investigation of the Plan and its fiduciaries. The investigation revealed the Plan was not properly allocating excess expense budget account earnings to the participants at the end of each Plan year as stipulated. The Company immediately took corrective action in November 2024 and allocated a total of \$357,667 to participants, which include \$302,181 of expense budget account balance and \$55,486 in interest. In January 2025, the Plan received a letter indicating no further action related to the investigation.

Note 5 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Transactions with the trustee qualify as party-in-interest transactions. The trustee receives management and contract administration fees from the Plan.

Note 6 – Information Certified by the Trustee

The Companies have elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A., the trustee of the Plan, has certified to the completeness and accuracy of the following:

- Investments, other receivables, notes receivable from participants, and other liabilities reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).
