**Note 1. Plan Description**

The following description of the Pearce Services, LLC (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information with regard to the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:**

The Plan is a defined contribution plan covering all employees of the Company who are age 18 and have met the service requirement of one calendar month of employment. The Plan covers all employees of the Company, except members of a collective bargaining unit and non-resident aliens. Employees enter the Plan on the first day of every month that occurs after the employee has met the service requirement. The Plan is a cash or deferred profit-sharing plan under Section 401(a) and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan administration:**

The Company is the Plan sponsor and Plan administrator. The Plan administrator is responsible for carrying out the duties imposed under the ERISA, including oversight of the Plan, appropriateness of investment offerings, and monitoring investment performance.

The Company contracts with Standard Insurance Company (The Standard) to act as the custodian for insurance contract options. The Standard also acts as the recordkeeper and third-party administrator to process and maintain records of participant data. The Company contracts with Charles Schwab Trust Bank (Charles Schwab) to act as the custodian and trustee of mutual funds and other investment options, if any.

**Contributions:**

Participants may elect to make pretax elective deferrals and Roth elective deferrals as defined in the Plan document, which are withheld from the employee's pay through payroll reductions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover or transfers-in from merged plans). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions. For the year ended December 31, 2024, the Company made discretionary matching contributions every pay period, matching 100 percent of employee elective deferrals up to 3 percent of compensation. Participants direct the investment of the discretionary matching contributions.

Contributions are subject to certain IRS limitations.

***Transfers:***

Transfers in represent transfers of balances from the retirement plans of acquired employers merged into the Plan. During the year ended December 31, 2024, the balances from the Clark Land Surveying, Inc. 401(k) Plan were transferred into the Plan.

***Participant accounts:***

Each participant's account is credited with the participant's contribution via salary reductions, the Company's discretionary matching contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All amounts in participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting:***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their account balance, if any, is based on years of service as follows:

1 year	25%
2 years	50%
3 years	75%
4 years	100%

***Notes receivable from participants:***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at prime plus 1%, which has been determined by the Plan administrator as a reasonable rate of interest, commensurate with local prevailing rates, as of the loan date. Principal and interest are paid through payroll deductions, or through direct payments from the participants.

***Benefit payments and withdrawals:***

Upon termination of service for any reason, if the terminated participant's vested and non-forfeitable balance is less than \$1,000, the participant's balance may be distributed in the form of a cash distribution. If the terminated participant's vested and non-forfeitable balance over \$1,000 but less than \$7,000, the participant's balance may be distributed as a direct rollover to a default IRA, without authorization from the participant.

A participant may withdraw the elective deferral account balance of their account for reasons of hardship.

***Forfeited accounts:***

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. Forfeitures may be applied to reduce administrative expenses of the Plan or may be used to supplement employer contributions. At December 31, 2024 and 2023, the forfeiture plus the expense account balance was \$9,769 and \$10,085 respectively. The expense account is used to record compensation recapture amounts and pay investment advisor fees that are net with Plan earnings. During the year ended December 31, 2024, \$134,612 in forfeitures were used to offset employer contributions.

***Note 2. Significant Accounting Policies***

***Basis of accounting:***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of estimates:***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment valuation and income recognition:***

The Plan's investments are reported at fair value, except for the fully benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor's management determines the Plan's valuation policies utilizing information provided by the custodian, trustee, and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes receivable from participants:***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

***Excess contributions payable:***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. As of December

31, 2024 and 2023, excess contributions payable were \$71,390 and \$2,734 respectively. The 2024 excess contributions were refunded on March 12, 2025.

***Payment of benefits:***

Benefits are recorded when paid.

***Administrative fees:***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are netted out of the check paid to participants. Investment-related expenses are included in net appreciation or depreciation of fair value of investments. Other expenses related to the administration of the Plan are included in administrative fees.

***Note 3. Certified Investments and Notes Receivable***

The following information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab and Standard Insurance Company.

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5. *Guaranteed Investment Contract with Insurance Company***

The Plan has a traditional fully benefit-responsive investment contract with Standard Insurance Company totaling \$4,023,855 and \$3,207,391 as of December 31, 2024 and 2023, respectively. Standard Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Standard Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of

the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**Note 6. Related Party and Party-in-Interest Transactions**

The Standard Retirement Services and its affiliates, including Standard Insurance Company (The Standard) provides recordkeeping and third-party administrative services to the Plan, as well as certifies certain insurance investment options. Charles Schwab is the custodian and trustee of the Plan. StanCorp Investment Advisors is the investment advisor of the Plan. Fees incurred by the Plan for investment advisory services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than a direct payment.

These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules.

Notes receivable from Plan participants and related interest income are also considered party-in-interest transactions.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of the ERISA. Upon termination, all interests of participants become fully vested, and the assets are distributed among the participants of the Plan in accordance with the provisions of the Plan.

**Note 8. Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Including any applicable amendments, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan as of December 31, 2024, and is not aware of any uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
