## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Setco, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Setco, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Setco, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Setco, Inc., Setco Transportation, and Red River Mixing, LLC (together referred to as the Company). All employees of the Company are eligible to participate in the Plan provided they have 60 days of service. Employees may enter the Plan on the first of the month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Voya Institutional Plan Services, LLC provides recordkeeping services to the Plan and Voya Retirement Insurance and Annuity Company (VRIAC) is the custodian of the Plan's investments and serves as Trustee. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan.

**Contributions**

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). In addition, participants are permitted to transfer the vested portion of their accounts to an in-plan Roth transfer account subject to the Plan's provisions.

The Plan provides for a qualified automatic contribution arrangement (QACA) that includes a safe harbor employer matching formula. The QACA provides that all newly eligible employees are automatically enrolled in the Plan at a pre-tax deferral rate of 6% of eligible compensation unless the employee elects otherwise.

The non-discretionary QACA safe harbor matching contribution is equal to 100% of employee deferrals up to 1% of eligible compensation and 50% of employee deferrals between 1% and 6% of eligible compensation.

Discretionary profit sharing contributions are determined annually by the Company's Board of Directors. Profit sharing contributions are allocated to each eligible participant based upon a formula determined by the Company as each participant is in her or her own allocation group. There were no profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and QACA safe harbor matching contributions, as well as allocations of the Company's profit sharing contribution, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate that was effective at the time the loan was issued, as defined. Only one loan is permitted at a time. Principal and interest is paid ratably through monthly payroll deductions.

**Vesting**

Participants are vested immediately in their contributions plus earnings thereon. Vesting in the Company's QACA safe harbor matching contribution and discretionary profit sharing contribution portions of their accounts is based on years of service. For the Company's QACA safe harbor matching contribution, a participant is 100% vested in the Plan after two years of service. For the Company's discretionary profit sharing contribution, after two years of service, a participant becomes 20% vested in the Plan; the vesting increases by 20% each year. A participant is 100% vested after six years of credited services. In addition, a participant is 100% vested in all contributions upon reaching plan retirement age of sixty-five, death, or disability.

**Payment of Benefits**

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump sum amount or in installments to satisfy required minimum distributions. Participants with a vested account balance of less than \$7,000 must take a lump-sum distribution. The account of a participant with a vested account balance between \$1,000 and \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from a participant's elective deferral and rollover accounts and are subject to specific statutory and regulatory requirements.

In-service distributions are permitted from all vested accounts when a participant has attained age 59½.

**Forfeitures**

Forfeited nonvested accounts may be used to reduce Company contributions or pay plan expenses. For the year ended December 31, 2024, forfeitures of \$25,520 were used to pay plan expenses. Unallocated forfeitures were \$32,934 and \$10,499 at December 31, 2024 and 2023, respectively.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

**Contributions**

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Plan expenses primarily consist of plan administration fees and investment advisory fees. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**Subsequent Events**

Subsequent events were evaluated through September 9, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by VRIAC.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023, unless otherwise stated in the description below.

*Separate accounts:* Valued at the net asset value (NAV) of units of the fund, which is based on the readily determined fair value of the underlying investments less its liabilities. The underlying investments consist of mutual funds and money market funds.

**NOTE 5 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are managed by VRIAC. Arvest Wealth Management is the investment advisor for the Plan. ERISA Services Midwest, LLC is the third-party administrator for the Plan. Total fees paid from the Plan to these entities for the year ended December 31, 2024 were \$80,577. These transactions qualify as party-in-interest transactions.

**NOTE 7 — TAX STATUS**

As this Plan is a pre-approved defined contribution plan, the IRS issued an opinion letter dated June 1, 2021, stating that while they do not issue a determination as to whether a specific employer’s plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan document. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the IRS for the statutory period.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
