INDEPENDENT AUDITORS' REPORT

To the Executive Committee of the Board of Directors and Plan Participants
Maynard Nexsen P.C. 401(k) Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Maynard Nexsen P.C. 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the Maynard Nexsen, P.C. (the Firm) 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering most employees of the Firm. Employees are eligible to make salary reduction elections beginning the first day of the quarter following the employee's date of employment but are not eligible to receive any allocation of Firm-matching contributions or discretionary nonelective profit-sharing contributions until the employee has attained one year of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 25% of annual compensation, as defined in the Plan. Participants, who have attained age 50 before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may elect to make all pretax, all Roth (after-tax) or combination deferrals each pay period. The Roth deferrals will be included in the employee's ordinary taxable income and will be maintained separately from pretax deferrals. Earnings will accumulate on a tax deferred basis. Participants direct the investment of their contributions into various investment options offered by the Plan. All Participants have the option to self-direct their investments, which allows them to invest in other desired investments outside the investment options offered by the Plan. The Firm contributes 50% of the first 3.5% of annual compensation that a participant contributes to the Plan. The Firm also contributes discretionary nonelective profit-sharing contributions, which are allocated among participants using a range of percentages, as defined in the Plan. Participants must be actively employed during the Plan year in order to share in these discretionary nonelective profit-sharing contributions. Effective January 1, 2025, the Plan began making profit-sharing contributions biannually, as opposed to semi-monthly, on the final pay period in June and final pay period in December.

Additionally, the Plan allows for the Firm to make a special qualified nonelective contribution to satisfy, or prevent the failure of, certain Plan compliance requirements. There were no qualified nonelective contributions made during 2024. Contributions are subject to certain IRS limitations.

Allocation of Interest in Master Trust

The Plan's investments represent interests in Maynard Nexsen, P.C. 401(k) Master Trust (the Master Trust), which was established for the investment of assets of the Plan and another company-sponsored retirement plan. Each participating retirement plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by the trustee. The value of the Plan's interest in the Master Trust is based on the Plan's interest at the beginning of the year plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was 97% and 98%, respectively. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon the amount of time the Plans' assets were invested in the Master Trust.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Firm's matching contributions and Plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Firm's matching contribution and discretionary nonelective profit-sharing contribution is based on years of continuous service. A participant is 100% vested after six years of credited service. If a participant has reached age 65, the participant becomes 100% vested in his or her account upon termination, regardless of length of service.

Notes Receivable from Participants

Participants are able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance only when an immediate and heavy financial need exists, as defined by the Plan. The existing loans are secured by the vested balance in the participant's account. The loans bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. The Plan permits participant loans in accordance with the employer's established loan procedures as further described in the Plan Adoption Agreement.

Payment of Benefits

Upon termination of service, a participant may elect to receive an amount equal to the vested balance in his or her account in either a lump sum or a rollover of his or her account balance. Further, the Plan administrator may permit a participant who experiences a qualified financial hardship, as defined, to receive a distribution of a portion of the participant's account balance. Distributions are subject to the applicable provisions of the Plan agreement. Effective November 1, 2024, withdrawals are subject to a \$2,500 minimum amount limitation and a frequency limitation of two withdrawals per Plan year.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$212,647 and \$78,642, respectively. These accounts will be used to reduce future employer contributions and administrative expenses. In 2024, employer contributions and administrative expenses were reduced by \$240,079 from forfeited nonvested accounts.

Subsequent Events

The Plan's management has evaluated subsequent events through the date of the auditors' report, the date the financial statements were available to be issued.

Plan Amendments

Effective March 25, 2025, the following plans were made participating employers of the Plan and all employees as of the effective date were given immediate eligibility and previous time of service was applied to vesting within the plan: Dysart Willis, PLLC (participants employed on March 25, 2024), Winstead, PC (participants employed on April 1, 2024) and Bressler, Amery & Ross, PC (participants employed on July 10, 2024).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The fair value of the investments in the Galliard Stable Return Fund C (the Galliard Fund) common collective trust fund is estimated using its net asset value (NAV) per unit. The Galliard Fund distributes income in the form of units and provides a constant redemption value. The Galliard Fund invests in fully benefit-responsive investment contracts and is presented at fair value based on its NAV.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Contributions

Contributions from Plan participants and the matching contributions from the Firm are recorded in the year in which the employee contributions are withheld from compensation.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy, under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stock: Valued at the daily closing price as reported by the stock. Common Stock held by the Master Trust are stocks that are registered with the U.S. Securities and Exchange Commission. These stocks are publicly traded and transact at that price. The common stocks held by the Master Trust are deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Exchange traded funds traded on a recognized securities exchange are valued at the last repeated sale price that day or the official closing price, if applicable.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, common stocks, bonds and exchange traded funds that are valued on the basis of readily determinable market prices, along with money market funds valued at the NAV of shares held by the Plan at year end. Investments in common stock not traded on an active market are valued based on valuation reports utilizing the cost approach, market approach or discounted cash flow approach. Investments in certificates of deposit are valued at the exact runoff of principal, given its contractual maturity, discounted at the appropriate rate.

6. ROLLOVER CONTRIBUTIONS

On April 1, 2023, Maynard, Cooper & Gale, P.C. consummated a business combination with Nexsen Pruet, LLC to create the Firm and approved an amendment to terminate the Nexsen Pruet 401(k) Profit Sharing Plan (Nexsen Pruet Plan). All participants in the Nexsen Pruet Plan became 100% vested in that plan upon termination and were provided instructions on how to distribute their account balances in the plan through either lump-sum distributions or rollovers to any qualified plan (including the Plan) or IRA. On April 3, 2024, all participants who elected to rollover their balance to the Plan were transferred as part of a bulk rollover of approximately \$40,200,000, and is included in rollovers on the statement of changes in net assets available for benefits.

7. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Empower Trust Company. Empower Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan amounted to \$4,878 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. TAX STATUS

The Internal Revenue (IRS) has determined and informed the Firm by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

12. LIFE INSURANCE CONTRACTS

Participants in the Maynard, Cooper & Gale, P.C. Money Purchase Pension Plan and Trust could purchase life insurance with the vested funds in their participant accounts prior to January 1, 2008. The Plan also allows the purchase of life insurance. As of December 31, 2024 and 2023, the cash surrender value for life insurance purchased by participants totaled \$898,399 and \$873,949, respectively.

The life insurance contracts are considered to be allocated contracts since payments to the insurance companies are used to purchase contracts for specific individual participants. In accordance with generally accepted accounting principles, allocated contracts and the related benefit obligations have been excluded from the accompanying financial statements because the purchase of a contract transfers the obligation to pay the benefits and related risks to the insurance company.
