To the Board of Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tapia Brothers 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Tapia Brothers 401k (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan, as amended, was established effective June 1, 2016. The Plan is a defined contribution plan covering substantially all employees of Tapia Bothers Inc. and Kitchen Cuts, LLC, a company under common control, (collectively referred to as the Company), except leased employees. To participate in the Plan, a participant must have attained age 21 and have completed one year of service with a minimum of 1,000 hours. Prior to September 1, 2021, entry to the Plan was allowed on January 1, April 1, July 1, and October 1, coincident with or following completion of the eligibility requirements. Effective September 1, 2021, the Plan entry was changed to the first day of each calendar month, coincident with or following completion of the eligibility requirements.

The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may contribute up to 100% of their eligible compensation on a pre-tax basis, as defined in the Plan. Participants may also elect to make Roth contributions on an after-tax basis. Total participant contributions are subject to annual limits under the IRC. The maximum participant deferral limit was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Catch-up contributions of \$7,500 were available to participants who had attained age 50 or older by December 31, 2024 and 2023 and had not exceeded the contribution limit for the Plan year. The Plan allows rollover contributions.

The Company may make discretionary matching contributions to employees eligible for deferrals equal to an amount or percentage as determined by the Company. The Company made discretionary matching contributions in the amounts of \$283,786 and \$285,034 for the years ended December 31, 2024 and 2023, respectively.

The Company may also make discretionary profit sharing contributions to the Plan. In order to share in the discretionary profit sharing contributions, the participant is required to have completed 1,000 service hours during the Plan year and be employed by the Company on the last day of the Plan year, unless the participant's employment was terminated due to death, disability or normal retirement, under which circumstances, the service hour and last day requirements are waived. The Company did not make any discretionary profit sharing contributions to the Plan for the years ended December 31, 2024 and 2023.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts: Each participant's account is credited or charged with the participant's contribution and allocations of the Company's discretionary matching and profit sharing contributions, the Plan's investment earnings, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in Company discretionary matching contribution and profit sharing contribution is based on years of continuous service as follows:

Years of Service	Percentage
Less than 3	0%
3 or more	100%

Notwithstanding the above, if a participant (1) attains the normal retirement age of 59-1/2, (2) dies while employed, or (3) becomes disabled while employed, the Company discretionary matching and profit sharing contributions become 100% vested without regard to years of service.

Notes Receivable from Participants: Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Principal and interest are paid ratably through payroll deductions or participant's own personal funds over a term not to exceed five years, or 30 years for loans taken for purchase of a principal residence. The loans are secured by the vested balances in the participant's account and bear reasonable rate of interest at Wall Street prime rate plus one percent. The prime rate at December 31, 2024 was 7.50%. Participants shall pay all fees and costs incurred in the set-up and maintenance of the loans. Participants may only have one outstanding loan at a time.

Benefit Payments: Upon termination of employment, death, disability or retirement, a participant or his or her beneficiary may elect to receive an amount equal to the value of the participant's interest in his or her account in either a lump sum amount or in installment payments.

In-service distributions are allowed upon either attaining age 59-1/2 or experiencing a financial hardship as defined by the IRC. Such withdrawals are subject to applicable excise and income taxes, and may only be made with the approval of the Plan Administrator. Participant is still allowed to make deferral contributions after receiving a hardship distribution.

Payment to a participant is generally made when a participant submits a written request for distribution. Account balances of \$5,000 or less may be involuntarily distributed without a participant's request.

Forfeitures: Unvested Company matching or profit sharing contributions, if any, would be retained in the Plan as forfeitures and may be used to reduce Company contributions, reallocated as Company contributions or to pay administrative expenses. No forfeitures were used during the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, the balance in the forfeiture account amounted to \$15,638 and \$7,546, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition: The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The MassMutual Fixed Account is reported at contract value, as it is considered fully benefit-responsive and invests directly in insurance group annuity contracts. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Realized and unrealized appreciation is based on the market value of the assets at the end of the Plan year compared to the market value of the assets at the beginning of the Plan year, or at the time the assets were purchased or exchanged during the Plan year.

Notes Receivable from Participants: Notes receivable from participants are reported at their outstanding principal balances, plus any accrued but unpaid interest.

Benefit Payments: Benefit payments are recorded as expenses when paid.

Administrative Expenses: The Company incurs certain expenses in administering the Plan which are not passed on as expenses of the Plan. Administrative expenses charged to the Plan consist of charges related to investment transactions, benefit payments and loan processing.

NOTE 3. CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, investment transactions, investment income, notes receivable from participants, and the schedule of assets held at end of year have been derived from information certified as complete and accurate by Empower, the Plan's custodian, in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4. GUARANTEED INVESTMENT CONTRACT WITH MASSMUTUAL INSURANCE COMPANY

The Plan has entered into a fully benefit-responsive fixed account investment in a group annuity contract with MassMutual. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is generally the amount that participants would receive in a transaction, so it is the most relevant measurement for the participant. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus credited interest, less participant withdrawal and fees.

The crediting interest rate is established for amounts invested in the fixed account. The guaranteed interest rate is determined every six months. The guaranteed interest rate was 2.80% and 1.35% for the years ended December 31, 2024 and 2023, respectively.

NOTE 5. TAX EXEMPT STATUS

The Plan adopted a non-standardized form of a prototype plan which has received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since that date. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate accounts managed by Empower, the custodian of the Plan, which holds the investments of the Plan. These transactions qualify as party-in-interest transactions as defined by Section 3(14) of ERISA.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

Level 1 Observable quoted prices in active markets for identical assets and liabilities.

Level 2 Observable quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.

Level 3 Model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.

The following methods and assumptions were used to estimate the fair value of assets. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts with underlying mutual fund investments: Valued using quoted market prices of the underlying mutual funds, which represent the net assets value of shares held by the Plan at year-end.

NOTE 9. FAIR VALUE MEASUREMENTS (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 10. DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2022, the Company inadvertently failed to deposit \$64,483 of participant deferrals and loan repayments within the required timeframe as stated by the United States DOL regulations. The Company corrected \$64,483 of late remittances plus lost earnings, restored them to the affected participants' accounts, filed Form 5330 and paid the applicable excise tax during the year ended December 31, 2024. The excise tax payments were made from the Company's general assets and not from assets of the Plan.

During the year ended December 31, 2024, the Company inadvertently failed to deposit \$250 of participant deferrals within the required timeframe as stated by the United States DOL regulations. The Company corrected \$250 of late remittance, plus lost earnings, and restored them to the affected participants' accounts.
