## INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of  
Lone Wolf Real Estate Technologies, Inc. 401(k) Plan**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Lone Wolf Real Estate Technologies, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### **1. DESCRIPTION OF PLAN**

The following description of the Lone Wolf Real Estate Technologies, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan, established October 1, 2008 and most recently restated effective December 31, 2021, is a 401(k) plan subject to the provisions of the Employees Retirement Income Security Act of 1974 (“ERISA”). The Plan covers substantially all employees, except employees covered by a collective bargaining agreement, leased employees or nonresident aliens, of Lone Wolf Real Estate Technologies, Inc. (the “Company”). Employees become eligible to participate upon attaining the age of 18 with no service requirement. The entry date into the Plan is immediate upon meeting the eligibility requirements. In addition, in order to be eligible for the non-elective contributions from the Company, employees must have worked at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year.

#### **Contributions**

The Plan allows for pre-tax and roth elective salary deferrals. Participants may contribute up to 100% of annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable. Participants direct the investment of their contributions into various investment options offered by the Plan. If a participant does not make an affirmative investment election, the participant’s contributions are invested in the Plan’s Qualified Default Investment Alternative (“QDIA”). The Plan has elected the Fidelity Freedom Index series funds as its QDIA.

The Company, at its discretion, is permitted to make matching contributions to the Plan. For the year ended December 31, 2024, the Company made matching contributions to the Plan equal to 50% of deferrals up to 6% of eligible compensation, as defined, totaling \$602,855. The Company, at its discretion, may make non-elective employer contributions to the Plan. For the year ended December 31, 2024, the Company did not make any non-elective employer contributions to the Plan. Contributions are subject to certain statutory limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant’s contributions and the Company’s matching contributions, if any, as well as an allocation of the Company’s

non-elective employer contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions and Company matching contributions plus actual earnings thereon. Vesting in the discretionary non-elective contributions portion of their accounts is based on years of continuous service as follows:

Less than 1	0%
1	25%
2	50%
3	75%
4 or more	100%

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The interest rates on outstanding loans at December 31, 2024 range from 4.50% to 9.50% per annum. Principal and interest are paid ratably through payroll deductions.

### **Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants shall be entitled to receive in-service withdrawals upon attainment of age 59 ½ or as a hardship distribution, as defined in the Plan document.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4 and \$1,358, respectively. Forfeitures, if any, can be used to reduce employer contributions or pay plan expenses. For the year ended December 31, 2024, the Plan used \$10,712 of forfeitures to pay administrative expenses.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions**

Contributions from Plan participants and employer contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

### **3. CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### **Mutual Funds**

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

### **Common Collective Trust**

Common Collective Trusts are not publicly quoted and are priced at net asset value ("NAV"). ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value.

Strategic Advisors, Inc. is the investment advisor of the Plan, and therefore certain transactions qualify as exempt party-in-interest transactions. Advisor fees of approximately \$20,400 were paid to Strategic Advisors, Inc. during the year ended December 31, 2024.

Fidelity Workplace Services, LLC (“Fidelity”) is the recordkeeper of the Plan and therefore certain transactions qualify as party-in-interest transactions. Approximately \$24,500 in administrative fees were paid to Fidelity from the Plan during the year ended December 31, 2024.

### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **7. TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### **9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

## INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of  
Lone Wolf Real Estate Technologies, Inc. 401(k) Plan**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Lone Wolf Real Estate Technologies, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. DESCRIPTION OF PLAN

The following description of the Lone Wolf Real Estate Technologies, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan, established October 1, 2008 and most recently restated effective December 31, 2021, is a 401(k) plan subject to the provisions of the Employees Retirement Income Security Act of 1974 (“ERISA”). The Plan covers substantially all employees, except employees covered by a collective bargaining agreement, leased employees or nonresident aliens, of Lone Wolf Real Estate Technologies, Inc. (the “Company”). Employees become eligible to participate upon attaining the age of 18 with no service requirement. The entry date into the Plan is immediate upon meeting the eligibility requirements. In addition, in order to be eligible for the non-elective contributions from the Company, employees must have worked at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year.

#### **Contributions**

The Plan allows for pre-tax and roth elective salary deferrals. Participants may contribute up to 100% of annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable. Participants direct the investment of their contributions into various investment options offered by the Plan. If a participant does not make an affirmative investment election, the participant’s contributions are invested in the Plan’s Qualified Default Investment Alternative (“QDIA”). The Plan has elected the Fidelity Freedom Index series funds as its QDIA.

The Company, at its discretion, is permitted to make matching contributions to the Plan. For the year ended December 31, 2024, the Company made matching contributions to the Plan equal to 50% of deferrals up to 6% of eligible compensation, as defined, totaling \$602,855. The Company, at its discretion, may make non-elective employer contributions to the Plan. For the year ended December 31, 2024, the Company did not make any non-elective employer contributions to the Plan. Contributions are subject to certain statutory limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant’s contributions and the Company’s matching contributions, if any, as well as an allocation of the Company’s

non-elective employer contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions and Company matching contributions plus actual earnings thereon. Vesting in the discretionary non-elective contributions portion of their accounts is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Percent Vested</u>
Less than 1	0%
1	25%
2	50%
3	75%
4 or more	100%

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The interest rates on outstanding loans at December 31, 2024 range from 4.50% to 9.50% per annum. Principal and interest are paid ratably through payroll deductions.

### **Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants shall be entitled to receive in-service withdrawals upon attainment of age 59 ½ or as a hardship distribution, as defined in the Plan document.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4 and \$1,358, respectively. Forfeitures, if any, can be used to reduce employer contributions or pay plan expenses. For the year ended December 31, 2024, the Plan used \$10,712 of forfeitures to pay administrative expenses.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions**

Contributions from Plan participants and employer contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

### **3. CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### **Mutual Funds**

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

### **Common Collective Trust**

Common Collective Trusts are not publicly quoted and are priced at net asset value ("NAV"). ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value.

## 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Strategic Advisors, Inc. is the investment advisor of the Plan, and therefore certain transactions qualify as exempt party-in-interest transactions. Advisor fees of approximately \$20,400 were paid to Strategic Advisors, Inc. during the year ended December 31, 2024.

Fidelity Workplace Services, LLC (“Fidelity”) is the recordkeeper of the Plan and therefore certain transactions qualify as party-in-interest transactions. Approximately \$24,500 in administrative fees were paid to Fidelity from the Plan during the year ended December 31, 2024.

### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **7. TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### **9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.
