### ***Basis for Opinion***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 – DESCRIPTION OF PLAN**

MacroFab, Inc. 401(k) Plan (the Plan) is a qualified retirement plan, covering substantially all eligible employees of MacroFab, Inc. (the Company). The Plan was originally adopted by the Company effective January 1, 2018, to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was most recently amended and restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the Company. Significant provisions of the Plan in effect as of December 31, 2023, are summarized below. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

Eligibility: The Plan covers all eligible employees (excluding union employees and nonresident aliens). Eligible employees will be eligible to participate for purposes of salary deferrals and matching contributions when they have attained age 21. Eligible employees will be eligible to participate for purposes of employer nonelective contributions when they have attained age 21 and completed one year of service. Eligible employees may enter the Plan on the date on which they satisfy the eligibility requirements for salary deferrals and matching contributions. For employer nonelective contributions, eligible employees may enter the Plan on first day of the 7<sup>th</sup> month of the Plan year coinciding with or next following the date eligibility requirements are met.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a salary deferral, not to exceed the annual dollar limitation set forth by the Internal Revenue Code (IRC) section 402(g). There are two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other qualified retirement plans or an individual retirement account as rollover contributions. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts as catch-up contributions. The Plan also has an automatic enrollment feature. If a new or existing employee does not make a deferral election, the Company will automatically contribute 1% of their compensation from each payroll into the Plan. These deferrals will be treated as pretax deferrals. The automatic enrollment deferral amount for both new and existing employees will be increased each year on January 1 by 1% from each payroll up to a maximum rate of 10%. Participants may change or terminate the election of the amount they are deferring into the Plan at any time.

The Company may make an employer matching contribution on a participant's behalf during the Plan year. Each year, the Company will determine the amount of the discretionary percentage. For 2023, the Sponsor elected to make a discretionary match equal to 50% up to 6% of a participant's eligible compensation for the Plan year. The Company may also make a discretionary employer profit sharing contribution to the Plan. For 2023, the Company did not make any discretionary employer profit sharing contributions.

The Plan permits the Company to make Qualified Nonelective Contributions (QNECs) on behalf of participants when needed to correct certain plan provisions. As of December 31, 2023 and 2022, the Plan recorded other employer contributions receivables, net of forfeitures of \$76,351, respectively, related to such QNECs.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer matching contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability

Investment Options: Participants direct the investment of their entire interest in the Plan into various investment options. The Plan currently offers various mutual funds and a money market fund as investment options for participants. Participants may redirect the investment of future contributions or reallocate or transfer existing balances among available investment securities at any time.

Vesting: Participants are fully vested in their salary deferrals, including catchup contributions, rollover contributions, QNECs and the appreciation of earnings thereon. Vesting in employer matching and profit sharing contributions are based on each employee's length of service. A participant is 100% vested after three years of credited service.

Notes Receivable From Participants: Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, or longer if the loan is for the purchase of a principal residence. The loans are secured by the balance in the participants' account and bear an interest rate equal to 1% over the Prime Interest Rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service due to death, disability, retirement, or termination of employment, a participant (or beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum distribution or a direct rollover distribution to another qualified retirement plan or to an individual retirement account. If the participant's vested account balance does not exceed \$5,000, then the vested account balance will be automatically distributed in a single lump-sum payment. If the vested amount of a participant's account exceeds \$5,000, they must consent to any distribution of their account.

Participants who reach age 59½ may receive an in-service distribution from all contribution accounts during the Plan year. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Forfeitures: When participants separate from service, any amounts that are not vested will be forfeited. Forfeited funds may be used to pay administrative expenses of the Plan or used to reduce employer contributions. Forfeitures available to offset future matching contributions and administrative expenses as of December 31, 2023 and 2022, were \$35,505 and \$3,703, respectively.

Administrative Expenses: The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, generally all administrative expenses of the Plan are paid by the Company. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Subsequent Events: Effective August 15, 2024, the Plan was amended to remove the automatic enrollment provision. Going forward eligible employees are now required to make an affirmative election in order to participate in the Plan. This change did not have an impact on the amounts reported in the financial statements as of and for the year ended December 31, 2023.

Plan management has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Payable: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Reclassifications: Some items in the prior year financial statements were reclassified to conform to the current presentation. Reclassifications had no effect on prior year net assets available for benefits or the prior year net increase in net assets available for benefits.

### NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2023 and 2022, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as an authorized representative for Ascensus Trust Company.

### NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds: Valued using the market approach based on quoted prices in active markets (Level 1 inputs). These are open-end mutual funds that are registered with the SEC and transact at published daily net asset values.

Money Market Fund: Valued using the market approach based on the closing net asset value per share as reported by the fund (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

There were no transfers between Levels 1, 2, or 3 during the years ended December 31, 2023 and 2022. The Plan did not hold any Level 3 investments as of December 31, 2023 or 2022.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Ascensus, LLC and Ascensus Trust Company are service providers to the Plan and, therefore, the Plan's payment of fees to these entities qualify as party-in-interest transactions. Cetera Advisor Networks provides investment management services to the Plan and therefore, the Plan's payment of fees to this entity qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by FIS Business Systems LLC. The non-standardized pre-approved profit sharing plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the non-standardized pre-approved profit sharing plan, as then designed, was acceptable under section 401 of the IRC for use by the employer for the benefits of its employees. Although the Plan has been amended from the original non-standardized pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
