## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit -

### 1) Description of plan and summary of significant accounting policies -

- A) **Description of Plan:** The following description of the Cooperativa de Ahorro y Crédito Oriental Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established by Cooperativa de Ahorro y Crédito Oriental Retirement Plan (the Plan Sponsor) under the provisions of Section 1081.01(a) of the Internal Revenue Code for a New Puerto Rico of 2011 (the Code), which includes a qualified cash or deferred compensation arrangement, for the benefit of eligible employees of the Plan Sponsor. The employees have to complete six months of services to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - All employees aged 18 years and older are enrolled automatically in the Plan after completion of six months of service unless the employee makes an election to waive participation. Employees under a collective bargaining agreement, Puerto Rico nonresident employees, leased employees and independent contractors are not eligible to participate in the Plan.

Contributions - Each participant may contribute a minimum of 1% of his or her eligible compensation on a pre-tax basis subject to limitations (\$15,000 for 2024 - normal age) under the "Código de Rentas Internas para un Nuevo Puerto Rico", as amended. Participants are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. All employees automatically enroll in the Plan at a contribution rate of 4%. Contributions are invested in a target date fund until the participant directs investment of the automatic deferrals into another investment option offered by the Plan. The participants may modify their salary deferral elections at each payroll period.

The Plan Sponsor may make contributions in one or more installments for the Plan's year, in such amounts that it determines and are allocated to participants on a pro-rata percentage based on compensation.

Additional profit-sharing amounts may be contributed at the option of the Plan's Sponsor board of members and are invested in a portfolio of investments as directed by the Plan's Sponsor.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in all contributions plus actual earnings thereon. Plan's Sponsor contributions are vested as follows: at least 2 years of services 20%, at least 3 years of services 40%, at least 4 years of services 60%, at least 5 years of services 80% and at least 6 years of services 100%.

Notes receivable from participants - A participant may apply for a loan to be made from his or her vested account balance in the Plan not to exceed the lesser of 50% of the participant's vested account balance in the Plan, or \$50,000, and a minimum amount of \$1,000. Loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. As of December 31, 2024 and 2023, interest rates amounted to 4.25%, and maturities ranged from 3 to 10 years, respectively. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures - As established by Plan document, forfeitures may be used to reduce Plan's administrative expenses or future Plan Sponsor contributions. As of December 31, 2024, and 2023, forfeitures contributions balance amounted to approximately \$61,000 and \$48,000, respectively.

Plan termination - Although it has not expressed any intent to do so, the Plan's Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Party-in-interest - During the years ended December 31, 2024 and 2023, certain Plan assets are investments funds managed by Empower Trust Company, LLC. and subsidiaries which acted as the trustee of the Plan. Accordingly, transactions qualify as party-in-interest under ERISA regulations.

- B) Summary of significant accounting policies:** The accounting and financial reporting policies followed by the Plan conform with accounting principles generally accepted in the United States of America and to prevailing practices within its industry. The following is a description of the most significant of these policies:

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates - Preparing the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payments of benefits - Benefits are recorded when paid.

Operating expenses - Administrative expenses include participant loan fees, monthly and quarterly assets fees, quarterly contract charges and withdrawal charges. Participants who take a loan from the Plan incur a one-time fee for establishing the loan as well as a quarterly loan administration fee. These fees are charged directly to the individual participant's accounts. All other administrative expenses including auditing and recordkeeping expenses are paid and absorbed by the Plan Sponsor. Expenses that are paid and absorbed by the Plan Sponsor are excluded from these financial statements.

Subsequent events - In accordance with ASC 855 - *Subsequent Events*, the Plan evaluated subsequent events through September 10, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

### 2) Information certified by Trustee -

The following information included in the accompanying financial statements as of December 2024 and 2023 and in the supplemental schedule as of December 31, 2024, was obtained from data that has been prepared and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, which is a party-in-interest under ERISA regulations.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodology used for assets measurement at fair value:

Level 1 fair value measurements - The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Level 2 fair value measurements - The fair value of investment funds for which quoted market price are not available are valued based on the market approach which utilizes process and other relevant information generated by market transactions involving identical generated assets or liabilities. Observable inputs reflect the assumptions market participants would use in valuing a financial instrument based on market data obtained from independent sources. The availability of observable market data is monitored to assess the appropriate classification of financial instruments with the fair value hierarchy.

The Key Guaranteed Portfolio Fund which is issued by Empower Annuity Insurance Company of America is a fully-benefit responsive contract which is invested in the general account of the insurance company. It has no maturity value. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest credit rate is reset quarterly. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluated the significance of the transfers between levels based upon the nature of the financial information and size of the transfer relative to total net assets available for benefits. During the years ended December 31, 2024 and 2023, there were no significant transfers in or out levels 1, 2 or 3.

Plan's fiduciary of the Cooperativa de Ahorro y Crédito Oriental Retirement Plan set investment policies and strategies for trust. Long-term strategic investment objectives include preserving the funded status of the trust and balancing risk and return. Plan's fiduciary oversees the investment allocation process, which includes selecting investment managers, commissioning periodic asset-liability studies, setting long-term strategic targets and monitoring asset allocations.

#### **4) Investment contract with insurance company -**

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America. It maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. As described in the basis of accounting disclosure because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract approximates the contract value. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting. During the years ended December 31, 2024 and 2023, the average yield earned amounted to .06% and 1.40%, respectively.

### 5) Tax status -

The Puerto Rico Department of Treasury (PRTD) has determined and informed the Plan Sponsor on a letter dated March 26, 2019, that the Plan is designed in accordance with the applicable sections of the Code and therefore, exempt from income taxes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the PRTD. The Plan Administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6) Risk and uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
