Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of A.C. Nelsen Enterprises, Inc. Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. Plan Description

The following brief description of the A.C. Nelsen Enterprises, Inc. Savings Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of A.C. Nelsen Enterprises, Inc. and Arrow Distributing, Inc. (the Company).

Employees are eligible to make pre-tax salary deferral contributions and receive safe harbor matching contributions, discretionary matching contributions, and profit-sharing contributions after attaining age 21 and completing twelve months of service with at least 1,000 hours. Long-term part-time (LTPT) employees are eligible to make pre-tax salary deferral contributions after attaining age 21 and completing at least three consecutive years beginning after December 31, 2020, with at least 500 hours of service each year. Eligible employees are automatically enrolled in the Plan, with salary deferral contributions starting at 6% of their eligible compensation. Effective January 1, 2023, the Plan was amended to remove the automatic escalation of employee's deferral rate. Effective January 1, 2024, the Plan was amended to remove the automatic enrollment of eligible employees. Employees have the option to choose their own salary deferral percentages and participation during the Plan year. Eligible employees become participants on the first day of the first calendar quarter following the date on which entry requirements were fulfilled.

Contributions

Participants may make voluntary salary deferral contributions up to the maximum dollar amounts allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. The Plan is a "Safe Harbor 401(k) Plan", whereby the Company makes safe harbor matching contributions. The Company safe harbor matching contributions are made in an amount equal to 100% of the amount of the participant's elective deferrals up to 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals greater than 3% and up to 5% of the participant's compensation. The Company may also make discretionary matching and profit-sharing contributions. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of a) the Company's safe harbor matching contributions, discretionary matching contributions, and discretionary profit-sharing contributions and b) Plan earnings and losses, and charged with an allocation of administrative expenses. Company safe harbor matching contributions and discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. Discretionary profit-sharing contributions are allocated based on eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of investments held in participant accounts. Investments are maintained in individual member accounts managed by Charles Schwab Trust Bank (Charles Schwab).

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions, discretionary matching contributions, and profit-sharing contributions plus actual earnings thereon.

Payment of Benefits

Upon termination, retirement, disability, or death or attainment of age 59.5 (for certain in-service distributions), the participant or beneficiary may either receive a partial or single lump sum payment equal to the value of the vested funds allocated to the participant's account. Effective April 11, 2024, the Plan requires that distribution payments between \$1 and \$7,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Participants may also receive hardship distributions, as permitted in the Plan. Prior to April 11, 2024, the Plan required distribution payments between \$1 and \$5,000 to be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Benefits are recorded when paid.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Other

Certain administrative and investment management expenses may be paid by the Plan or the Company. If the Company does not pay Plan related expenses, such expenses are allocated to the accounts of participants and are included in net appreciation in fair value of investments or in administrative expenses. Other expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Audit fees are paid by the Company and are excluded from these financial statements.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 8, 2025, noting not items requiring disclosure.

3. Information Certified by Charles Schwab

Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Charles Schwab, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. Mutual and money market funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from Federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

7. Related-Party Transactions

Certain Plan investments are a money market fund and mutual funds managed by Charles Schwab. Charles Schwab is the custodian of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.
