Note 1. Description of the Plan

The following description of the 401(k) Nemco Opportunity Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined contribution plan covering all full-time employees of Nemco Food Equipment, Ltd. (Company) who are 18 years of age or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). A member of the Company's management serves as the Plan trustee. Empower Retirement Company serves as the Plan recordkeeper. Empower Trust Company, LLC serves as the Plan custodian.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of annual eligible compensation. Employee rollover contributions are also permitted. The Company makes safe harbor contributions for each full-time employee with one year of service equal to 3.25% of eligible compensation annually. Contributions are subject to certain limitations. Roth deferrals are an allowable contribution type.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, as well as any Company safe harbor contributions, plus earnings thereon.

Notes Receivable From Participants

The Plan Document included provisions authorizing loans from the Plan to active eligible participants. Loans were made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans was determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator. Effective January 1, 2016, the Plan Document was amended and restated to no longer permit new loans from the Plan.

Payment of Benefits

Upon termination of service, participants will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. At December 31, 2024 and 2023, there were no Plan assets allocated to accounts of terminated or retired participants who have elected to withdraw from the Plan, but have not yet been paid.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,142 and \$6,215, respectively. These accounts will be used to reduce future employer contributions or Plan administrative expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies (mutual funds) are valued at quoted market prices, which represent the net asset value (NAV) of the shares held by the Plan at year-end. Pooled separate accounts are valued at the NAV of the units of the pooled separate accounts as provided by the custodian. The NAV is used as a practical expedient to estimate the fair value of the pooled separate accounts. The Plan's interests in the collective trust funds are valued at the NAV provided by the administrator of the funds. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding. The NAV's unit price is quoted by the administrator of the funds and the market is not active.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. During 2024, the balances of notes receivable from participants was repaid.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Tax Status

The Plan operates under a volume submitter profit sharing Plan Document sponsored by Orchard Trust Co. This Plan Document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification by Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodian of the Plan, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024, and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, December 31, 2024, and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform procedures with respect to this certified investment information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in certain funds of the Plan custodian. The Plan paid \$35,459 and \$26,925 to Empower Retirement Company for administrative expenses in 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan has no liabilities measured at fair value on a recurring basis. In addition, the Plan has no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. Level 1 investments include interests in mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no investments classified as Level 2 or Level 3.

The pooled separate accounts and common collective trust fund are valued based upon the net asset value (NAV) of the funds multiplied by the units held by the Plan at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The underlying investments of the pooled separate accounts consist solely of mutual funds and the investment strategy of the respective pooled separate accounts aligns directly with the investment strategy of the underlying mutual fund investments.

Note 6. Reconciliation of Financial Statements to Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the Internal Revenue Service and the accompanying financial statements include classification differences. In addition, differences between the Form 5500 filed with the Internal Revenue Service and the accompanying financial statements include reporting \$6,089 of delinquent loans as deemed distributions in Form 5500 for 2023, and as notes receivable from participants in the accompanying statements of net assets available for benefits. The change in the delinquent loan amount noted above resulted in a difference in benefits paid to participants of \$6,089 for 2023, between Form 5500 and the accompanying statements of changes in net assets available for benefits. There were no such occurrences in plan year 2024.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all contributions to the Plan, contributions of \$12,512 were not remitted within the required time period during the year ended December 31, 2024.

Note 9. Amendments

Effective January 1, 2024, long-term part-time (LTPT) employees are eligible to contribute to the Plan, but are not eligible to receive any Company contributions, including safe harbor, matching contributions, or employer non-elective profit sharing contributions. Eligible LTPT employees must have worked at least 500 hours of service in each of the three consecutive twelve-month periods and be at least 21 years of age.

Note 10. Subsequent Events

Subsequent events have been evaluated through August 26, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan name was changed to Nemco Food Equipment 401(k) Plan.

Effective January 1, 2025, participants will be deemed to have made an elective deferral automatic contribution election in the amount of 4% of their plan compensation for participants whose entry date is on or subsequent to the effective date. These automatic elections will be designated as pre-tax elective deferral contributions.

Effective January 1, 2025, the Company safe harbor contribution was increased to 4% of eligible compensation annually.

Effective May 17, 2025, the Plan added Edgetech Grinding as an eligible employer. Employees of Edgetech Grinding who were employed on May 16, 2025, will be immediately eligible to participate in the Plan. Employees hired after May 16, 2025, are subject to the eligibility age and service.
