Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule H, line 4i-schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial

statements but is supplementary information required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Plan Description**

The following brief description of the Norco, Inc. Employee Stock Ownership Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

Norco, Inc. (the Company) established the Plan effective as of January 1, 2015. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Principal Trust Company, assist the ESOP Trustee (Trustees) in administering the Plan. Fees for their services, and significantly all costs of administering the Plan, are paid by the Company.

In 2015, the Plan purchased the Company's convertible preferred stock shares using the proceeds of a note (Note 8) and holds the preferred stock in a trust established under the Plan. At inception of the Plan, the Company issued a note receivable due from the Plan of \$141,580,000. During 2016, due to an amendment to the original purchase price to purchase Company preferred stock shares, the note receivable issued by the Company due from the Plan was increased by \$1,929,213 which comprised of additional principal of \$1,634,162 and interest capitalized into principal totaling \$295,051, calculated from the original date of the transaction through the date of the amendment. The Plan will make payments of principal and interest in equal annual installments until the maturity date during the Plan year 2035. As the Plan makes debt payments, an appropriate percentage of preferred stock shares will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

In 2020, convertible preferred shares were converted to common shares.

The borrowing is collateralized by the unallocated shares of stock and is guaranteed by the Company. The lender has no rights against shares of the stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

1. Accounts of employees with vested right in allocated shares (allocated).
2. Shares not yet allocated to employees (unallocated).

**Eligibility**

Employees of the Company are eligible to participate in the Plan after attaining age 21 and completing a consecutive 12-month period of service provided they worked at least 1,000 hours during such period. Leased and labor union employees are excluded from the Plan.

### **Entry Date**

Employees may enter the Plan on the first day of January coinciding with the date they satisfy the Plan's eligibility requirements.

### **Contributions**

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Additional amounts may be contributed at the discretion of the Company's board of directors. Employee contributions are not permitted.

### **Voting Rights**

Each participant has the right to direct the Trustees regarding the common stock that are allocated to their participant account with respect to corporate matters which involves the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction as the Department of Treasury may prescribe in regulations. On other corporate matters requiring a vote of the shareholders, the Trustees may vote on behalf of the Plan and its participants based on common stock allocated and unallocated.

### **Put Option**

Under federal income tax regulations, the common stock shares that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares distributed to participants for which there is no market. The put price is representative of the current appraised value of the shares. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

**Vesting**

Participants vest in the shares allocated to their account based on the table shown below. If participation in the Plan is terminated by reason other than resignation or dismissal before retirement, the participant will become fully vested in the balance in their account. A participant is 100% vested after 6 years of credited service.

Participants are 100% vested in their account balances upon retirement, death or disability.

**Forfeitures**

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures are used in the same year they are forfeited. Forfeitures result from termination of employment before full vesting has occurred. Forfeitures are allocated proportionally among Plan participants employed on the last day of the Plan year based on their eligible annual compensation. As of December 31, 2024 and 2023, there were 9,487 and 14,214, respectively, forfeited shares reallocated to participants' accounts at \$85.25 per share and \$78.49 per share, respectively.

**Payment of Benefits**

Upon death, disability or retirement, a participant may receive a lump sum if their account balance is less than \$225,000, otherwise the distribution may be subject to annual installments as defined in the Plan document and the Plan's distribution policy. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Plan Account.

The amount to be distributed is based upon the immediately preceding valuation date. Account balances for employees that have terminated but have yet to be paid out have been included in net assets available for benefits. They will be reflected in the statement of changes in net assets available for benefits when actually paid. Balance of the benefits due to terminated participants as of December 31, 2024 and 2023, totaled \$10,850,590 and \$10,526,502, respectively.

### **Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified.

Participants who are at least age 55, with at least 10 years of participation in the Plan, may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants electing to diversify receive a cash distribution. The election to diversity is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants would become 100% vested in their account. Upon termination of the Plan, the ESOP committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale will be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

## **Note 2 - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Allocations**

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated shares ("allocated") and (b) shares not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is determined by an independent appraisal and is based primarily on the market value of the Company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Released gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported above and in the statement changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Payment of Benefits**

Benefits payments to participants are recorded when paid.

### **Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits.

### **Reclassifications**

Certain amounts from the prior year financial statements have been reclassified for comparative purposes to conform to the presentation in the current year financial statements.

### **Subsequent Events**

Subsequent events were evaluated through September 9, 2025, the date the financial statements were available to be issued.

### **Note 3 - Valuation of Company Common Stock**

The investment in the Company's common stock is valued at December 31, 2024 and 2023, in the accompanying financial statements based on an independent appraisal using financial data as of December 31, 2024 and 2023. As of December 31, 2024 and 2023, the fair value of the Company's common stock on a per share basis was \$85.25 per share and \$78.49 per share, respectively. The following tables provide details of the activity in the allocated and unallocated accounts and the associated cost and fair value of the shares in the respective accounts as of December 31, 2024 and 2023.

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Employer common stock: The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, discount rates, return on assets, return on equity, market comparable and estimated fair value of Company assets and liabilities, including discounts for lack of control and lack of marketability.

The valuation process involves Plan management's selection of an independent appraiser on an annual basis. Plan management accumulates the data for the appraiser from the reviewed financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with the ESOP committee and ESOP trustee, review in detail, discuss, and approve. The results of this process are documented in the minutes of the ESOP committee.

Mutual funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 29, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC.

Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company and Plan management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan and the related trust continue to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6 - Administration of Plan Assets

The Plan's assets which consist of Company common stock were held by Summit Fiduciary Group. Company contributions are held and managed by the Trustee, which invests cash received, dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loans.

Certain administrative functions are performed by officers or employees of the Company. No officer or employee of the Company receives compensation from the Plan. Any administrative expenses related to Trustee fees are paid directly by the Company.

## **Note 7 - Risks and Uncertainties**

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## **Note 8 - Note Payable**

In 2015, the Plan entered into a \$141,580,000 term loan agreement with the Company, and former shareholders of the Company, to purchase 35% of the Company's preferred stock. During 2016, due to an amendment to the original purchase price to purchase shares of preferred stock, the amount of principal owed under the term loan agreement was increased by \$1,929,213. Unallocated shares are collateral for the loan. The agreement provides for the loan to be repaid in equal installments of \$7,876,571 to the shareholders, including interest at 2.6% until maturity during Plan year ended 2035. During 2020, all preferred stock was converted to common shares.

Shares are released from collateral and allocated to participants as payments of principal and interest are made on the loan. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments.

**Note 9 - Related Party and Party-in-Interest Transactions**

The Plan investments are shares of common stock in the Plan sponsor. Transactions with the Plan sponsor related to common stock held by the Plan are exempt party-in-interest transactions under ERISA. The Plan received no dividends from the Company for the year ended December 31, 2024. The Plan has a note payable with the Company and former shareholders of the Company. No fees were paid to the Company during the year ended December 31, 2024.

As described in Note 2, the Plan paid certain administrative expenses related to Plan operations to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

**Note 10 - Right of First Refusal**

Company stock that has been distributed to a participant and not immediately repurchased by the Company or Trust, may be subject to a right of first refusal if so, determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company, and then, if refused by the Company, to the Trust at fair market value as determined by an independent appraiser appointed by the ESOP Committee.
