Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Hydrologic Distribution Company 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). December 31, 2024 and 2023

(1) Description of Plan

The following description of Hydrologic Distribution Company 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution plan covering substantially all employees of Hydrologic Distribution Company (the “Company”) who have completed three months of service, and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan operates under an agreement with Principal Financial Group (“Principal”) to act as recordkeeper of the Plan and custodian of the Plan’s investments.

(b) Contributions

Participants may contribute up to 100% of eligible annual compensation limited by the maximum amount allowable by law. Participants direct the investment of their elective deferral and the Company’s contributions into various investment options offered by the Plan.

Participants may contribute a portion of eligible compensation on a pre-tax basis or as Roth contributions, as defined in the Plan and subject to Internal Revenue Service limits. Participants age 50 or older may also contribute catch-up contributions, up to Internal Revenue Service limits. The Plan accepts rollovers from other tax-qualified plans.

The Plan is a safe harbor plan effective January 1, 2021. The Company contributes 100% of employee contributions up to 3% of eligible compensation plus 50% of employee contributions in excess of 3% of eligible compensation up to 5% of eligible compensation.

(c) Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of the employer’s matching and additional discretionary contributions, if any. Plan earnings and losses are allocated to each participant’s account based upon the ratio of their account to the total of all participants’ accounts. The Plan allows participants to direct their contributions to any investment option available to the Plan.

(1) Description of Plan - Continued

(d) Vesting

Participants' contributions plus actual earnings are 100% vested immediately. Discretionary employer matching contributions are subject to the following vesting schedule:

(e) Forfeitures

Non-vested benefits of terminated participants are forfeited on the date the participant receives a complete distribution of vested benefits. Forfeitures are used to reduce future employer contributions or administrative expenses. During 2024, approximately \$1,000 of forfeitures were used to offset employer matching contributions for the year. At December 31, 2024 and 2023, the Company had \$0, of forfeited non-vested accounts available to reduce future employer contributions or administrative expenses of the Plan.

(f) Payment of Benefits

On termination of service due to death, disability or retirement, a participant shall be 100% vested in their accounts under the Plan. Normal retirement age under the Plan is 65. The Plan provides for benefit distributions by lump-sum payment or installments. The Plan also allows for in-service withdrawals for those 59 ½ or older. The Plan allows participants to withdraw from their account balance in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need but not in excess of the vested portion of the participant's individual account balance. The participant must qualify with respect to plan provisions.

(g) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of up to 50% of the vested account balance or \$50,000. Participants may have a maximum of one loan outstanding at one time. Such notes are collateralized by each respective participant's account and bear interest at a commercially reasonable rate. Participant note interest rates ranged from 5.25% to 10.50% as of December 31, 2024. Notes generally must be repaid within 5 years except for notes used for the purchase of a principal residence, which may be repaid over a period not to exceed 10 years. Principal and interest is paid ratably through payroll deductions. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and present net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan invests in mutual funds and pooled separate accounts which are stated at fair value based on the quoted market prices of shares held by the Plan at year end. Investments in guaranteed investment contracts which are fully benefit responsive are valued at contract value. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investments in the guaranteed investment contract, the Fixed Income Guaranteed Option ("FIGO"), are held as a general account product offered through a group annuity contract with Principal. Participant principal and interest are fully guaranteed by the entire general account assets of Principal. The general account assets are primarily high-quality, fixed income bonds. The FIGO is credited with declared rates of interest based on the earnings of the underlying assets in the portfolio compared to the minimum interest crediting rate, as stated in the contract with Principal.

The FIGO is reported at contract value which is the basis for participant-initiated transactions.

Certain events limit the ability of the Plan to transact at contract value with the issuer of the general investment contract. The Company does not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

(f) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

(g) Administrative Expenses

Administrative expenses of the Plan may be paid from the forfeiture account or directly by the Company. Participants of the Plan may be charged with administrative and transaction-based fees.

(h) Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

(3) Information Certified by Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the Plan's custodian, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments, at fair value
- Investments, at contract value
- Net appreciation (depreciation) in fair value of investments
- Investment and dividend income
- The Schedule of Assets (Held at End of Year) excluding participant loans

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under ASC Topic 820 are described below.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2: Observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability (such as interest rates, volatilities, prepayment speeds, credit risks, etc.), or inputs that are derived principally from or corroborated by market data by correlation or other means;

Level 3: Unobservable inputs for determining the fair values of assets and liabilities that reflect assumptions that market participants would use in pricing the assets or liabilities.

The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

The mutual funds are valued at quoted market prices in an exchange and active markets, which represent the net asset values of shares held by the Plan at year end and are classified as Level 1 investments.

Pooled Separate Accounts

The pooled separate accounts are valued at quoted market prices in an exchange and active markets, which represent the net asset values of shares held by the Plan at year end and are classified as Level 1 investments.

(5) Parties-in-Interest

During the year ended December 31, 2024, there were transactions involving the investment of plan assets in mutual funds, pooled separate accounts, and a guaranteed investment contract maintained by Principal Financial Group, the custodian of the Plan. During 2024 and 2023, the Plan directly paid Principal approximately \$30,000 and \$22,000, respectively for these services. Additionally, the Plan indirectly paid approximately \$32,200 and \$23,500 for investment advisor fees during 2024 and 2023, respectively. While these transactions qualify as party-in-interest transactions as defined in Section 3(14) of ERISA, they are expressly exempted from the prohibited transaction rules.

(6) Plan Termination

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to terminate, at any time, the Plan subject to provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(7) **Tax Status**

Effective January 1, 2022, the Plan adopted a non-standardized pre-approved plan document (“PAPD”) sponsored by KB Pension Services, Inc. The IRS has determined that the PAPD is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) and informed KB Pension Services, Inc. of such in a letter dated June 30, 2020. Although the PAPD has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) **Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 15, 2025, the date the financial statements were available to be issued.
