### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Global Engineering & Technology 401(k) Plan (the Plan) provides only general information. For more complete information, participants should refer to the Plan instrument, a copy of which is on file in the office of the Plan sponsor.

#### *General*

The Plan is a defined contribution 401(k) profit sharing retirement plan covering all eligible employees from Global Engineering & Technology, Inc. (the Company and Plan sponsor). The Plan commenced on June 1, 2014, and was amended effective January 1, 2022. The GET-NSA, LLC 401(k) Plan was merged into this Plan on January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Eligibility*

Employees of the Company are eligible to participate in the Plan on the day they become employees.

#### *Funding*

Each year participants may contribute a portion of their compensation on a pre-tax or post-tax (ROTH) basis as defined in the Plan. According to Internal Revenue Service (IRS) rules, the deferral may not exceed \$23,000 in 2024 and \$22,500 in 2023. Participants who have reached at least age 50 may contribute an additional catch-up yearly contribution of \$7,500 during 2024 and 2023. Eligible participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

The employer matches 100% of the participant contribution not to exceed 4% of compensation. Contributions are subject to certain limitations.

The employer may also make additional discretionary contributions to the Plan. These discretionary contributions would be allocated to each eligible participant on December 31 on a pro rata basis.

#### *Participant Accounts*

Each participant's account is credited with 1) participant contributions; 2) the employers' matching contribution; and 3) a ratable portion of investment gain or loss, net of Plan expenses. Each participant's account is charged with any distributions made to that participant.

#### *Vesting*

Participants are immediately vested in their contributions and the corresponding employer matching contributions plus actual earnings thereon.

#### *Investment Options*

Upon enrollment in the Plan, participants may direct contributions to be allocated among a selection of securities provided by the Plan (see Note 3).

#### *Forfeitures*

The Plan has limited forfeitures as participants are automatically vested.

#### *Notes Receivable from Participants*

Participants may borrow from their accounts from \$1,000 up to a maximum of 50% of their vested account balance or \$50,000 minus outstanding loan balance, if any, during the one-year period ending on the day before the new loan is made. Only one loan may be outstanding at any time. Loan terms would not exceed 5 years unless the loan was for the purchase of a primary residence. The maximum loan term for a primary residence is 10 years. The loans would be secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates provided by local lending institutions. Loans are only available to Plan participants who are active employees of the Plan sponsor, therefore, they become payable in full upon termination of employment. Participant loans had outstanding balances for the years ended December 31, 2024 and 2023 of \$89,040 and \$114,174, respectively. The participant loans have various maturities through 2029 with interest rates ranging between 5.25% and 10.50%.

#### *Termination*

Although there is no intent to do so, the Plan document provides for termination of the Plan subject to the provisions of the agreement and ERISA.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting and Use of Estimates*

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

#### *Investment Valuation and Income Recognition (Continued)*

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Concentration of Credit Risk*

Financial instruments, which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of investments. The Plan invests in mutual funds, pooled separate accounts and collective investment trusts which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual debt security.

### NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Principal Trust Company (Principal), the custodian, held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule Form 5500 - Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,286,715. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

### NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used to measure fair value as of December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trusts: Fair value is determined by comparing the rates in effect on that date to the rates on which the actual interest is determined and the book value is adjusted based on the difference in those rates as calculated by Principal. Although there is no secondary market to which those fair values can be compared, the rates are applied to both new deposits and the calculation of fair value, constitute an active market.

Pooled separate accounts: The majority of the underlying securities have observable quoted pricing inputs obtained from a pricing service. While the underlying assets values are quoted prices, the net asset value (NAV) of a separate account is not publicly quoted.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5. FULLY BENEFIT-RESPONSIVE INSURANCE CONTRACT

The Plan has a traditional fully benefit-responsive guaranteed insurance contract, which was reported at a contract value of \$303,839 and \$267,981 as of December 31, 2024 and 2023, respectively. Contract value is the aggregation of contributions, plus interests, less withdrawals, if any. The crediting rate is currently reset on a semiannual basis and was as follows:

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

### **NOTE 7. TAX STATUS**

The Plan is exempt from Federal income taxes under Internal Revenue Code (IRC) and, therefore, no provision for Federal income taxes has been made. In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes no such positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax period prior to December 31, 2021.

### **NOTE 8. RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS**

The Company is the Plan's employer and sponsor and absorbs virtually all administrative expenses of the Plan except for investment administration fees.

Certain Plan investments may include shares of investments managed by Principal Life Insurance, which has fiduciary responsibility. This makes transactions between the Plan and Principal Life Insurance party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Additionally, the Plan pays Principal Life Insurance for contract administration fees. This expense amounted to \$49,442 for the year ended December 31, 2024, and has been included in the accompanying statement of changes in net assets available for benefits as part of administrative fees.

### **NOTE 9. SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for the Plan through June 30, 2025, the date the financial statements were available to be issued.
