INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Hunter Contracting Co. Inc. Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Hunter Contracting Co. Inc. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Hunter Contracting Co. Inc. Profit Sharing Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Hunter Contracting Co., Hunter Ditch Lining, LP and B.E.D, LLC (“Employers”) who are age eighteen years or older. Under the Plan’s 401(k) provisions, participants are eligible immediately for deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, the employers can contribute to the Plan a separately determined amount for each of the following participant classifications: shareholders; officers; division managers and controller; general superintendent; superintendents and safety directors; all other salaried employees; and all hourly employees. The amounts contributed are solely at the Employers’ discretion. Under the Plan’s 401(k) provisions, participants may defer up to 100% of their annual compensation into the Plan; however, the deferrals cannot exceed certain dollar limitations established by the Internal Revenue Code. In addition, the Employers can contribute to the Plan a matching contribution, based on the participants’ deferral, at its discretion, up to 6%. All contributions are subject to certain limitations. For December 31, 2024 and 2023, the sponsor matched 6% and 6% of contributions up to 100% of the employee’s deferral on eligible wages, respectively.

The Plan allows for automatic enrollment for all eligible employees. Participants’ contributions under automatic enrollment are made at 3% of eligible compensation. Eligible employees may elect to not have automatic enrollment contributions made on their behalf.

Participant Accounts

Each participant’s account is credited with the participant’s elected compensation deferral and an allocation of (a) the employer’s contribution, (b) plan earnings, and (c) forfeitures of terminated participants’ non-vested accounts. In addition, the participant’s account is charged with an allocation of the Plan’s administrative expenses. These allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon election of compensation deferral, the participant directs the deferred amounts to be invested based on percentages into investment options sponsored by John Hancock Trust Company LLC (“John Hancock”). Participants may change their investment options at any time and revoke their election on any pay date.

NOTE 1 – DESCRIPTION OF THE PLAN (continued)

Vesting

Participants are immediately vested in their elective deferrals, safe harbor matching contributions, any rollover contributions to the Plan, and actual earnings thereon. Vesting in the Employers' matching and profit-sharing contribution portion of the participant accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service. The Plan defines a year of credited service to be a period of twelve consecutive months during which an employee works at least 1,000 hours. Upon the death or disability of any participant prior to retirement, the participant's account balance shall become fully vested.

Participant Loans

Participants may borrow from their accounts up to one-half of their vested balance with the total of all loans made not to exceed \$50,000 and must be a minimum of \$1,000. Loan maturities range from one to five years or greater than 5 years if the loan is used for the purchase of the participant's principal residence. The loans are secured by up to one-half of the participant's vested account and bear interest at a rate of 1% above the current prime interest rate. Loans are measured at their unpaid principal balance plus any accrued but unpaid interest. All loans become due upon separation of service or are deemed a distribution.

Payment of Benefits

On termination of service for any reason, a participant will receive an amount equal to the value of the participant's vested interest in the participant's account in a lump-sum payment or partial withdrawals, whichever they choose, as long as the vested account balance exceeds \$5,000. If the vested account balance does not exceed \$5,000, it will be distributed in a lump-sum payment. Hardship withdrawals are also available to participants with certain types of immediate and heavy financial need, which fall under the stated guidelines of the Plan.

Forfeitures

Forfeitures occur when participants leave the Plan when they are less than fully vested. These amounts may be used to pay administrative costs of the Plan, reduce future employer contributions, or may be allocated proportionately among the participants. As of December 31, 2024 and 2023, forfeitures equaled \$94,632 and \$55,149, respectively.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles ("U.S. GAAP") requires the trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The fair values of mutual funds and money market funds are based on quoted net asset values of the shares held by the Plan at year-end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means.
	If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions in accordance with the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses.

Cash and Cash Equivalents

Cash and cash equivalents include demand deposits and money market funds available upon demand.

Subsequent Events

Subsequent events have been evaluated through September 9, 2025, the date the financial statements were available to be issued.

NOTE 3 – INVESTMENTS - INFORMATION CERTIFIED BY CUSTODIAN

Investments, income and net appreciation or depreciation in fair value of investments included in the accompanying financial statements and supplemental schedule have been certified by John Hancock Trust Company LLC, the investment custodian, to the Plan administrator as being complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 – TERMINATION OF PLAN AND RELATED TRUST

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan and related trust, subject to the provisions of ERISA. In the event of Plan termination, the amount of each participant's or beneficiary's account as of the date of such termination would become 100% vested and non-forfeitable in the employer matching and discretionary profit-sharing contributions, plus actual earnings thereon.

NOTE 5 – ADMINISTRATIVE EXPENSES

Administrative costs of the Plan related to administration of participant accounts and benefits, accounting, auditing and legal fees are paid directly by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits. Administrative expenses to the Plan were \$104,885 and \$150,716 for the years ended December 31, 2024 and 2023, respectively.

NOTE 6 – RELATED PARTIES AND PARTIES IN INTEREST TRANSACTIONS

The Plan investments include investments managed by John Hancock Trust Company LLC, the custodian, as defined by the Plan, and those transactions are considered as party-in-interest transactions.

NOTE 7 – INCOME TAX STATUS

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan last obtained a favorable determination letter from the Internal Revenue Service on June 30, 2020. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Effective January 1, 2021, the Plan was restated in order to comply with the requirements for Cycle 3 Pre-Approved Plans, pursuant to Revenue Procedure 2017-41 of the Internal Revenue Code (“IRC”). Following the restatement of the previously adopted Plan, the Plan Administrator believes that the Plan is still designed and operated in compliance with the applicable requirements of the IRC.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – INVESTMENT FAIR VALUE MEASUREMENT

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds with registered investment company: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: Valued at the daily closing price as reported by the fund. The objective of the fund is to earn interest while maintaining a \$1 net asset value (NAV). The assets of the fund are comprised of short-term securities representing high quality, liquid debt and monetary instruments.

Common collective trusts: The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Pooled separate accounts: The net asset value (“NAV”) is used as a practical expedient to estimate fair value. The NAV equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The following sets forth within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023:
