Notes to Financial Statements

Note 1: Description of Plan

The following description of the *Medical Transportation Management, Inc. 401(k) Profit Sharing Plan* (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Medical Transport Management and Subsidiaries, as well as certain leased employees under Employee Lease Agreements (the Plan Sponsors or Employer), for the benefits of its employees who are 21 years of age or older and have met the service requirement. In order to participate in the Plan, an employee must have worked two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). John Hancock Trust Company LLC (John Hancock) is the Custodian of the Plan. Minnesota Life Insurance Company (Minnesota) and Standard Insurance Company (Standard) were the custodians of the Plan from the beginning of the Plan year to February 2024.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. In accordance with SECURE 2.0, the Plan increased the age for required minimum distributions (RMD) from age 72 to age 73 effective January 2023. Further changes set forth in the SECURE 2.0 Act include eliminating pre-death RMD rules for Roth accounts and several voluntary changes to distribution provisions, effective January 2024. The Plan is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Plan Sponsors make annual contributions of up to 100% of eligible compensation. Employee Roth contributions and employee rollover contributions are also permitted. The Plan Sponsors will match contributions equal to 100% of the first 3% of employees' compensation and 50% of employees' salary deferral amounts on the next 2% of employees' compensation. Plan Sponsors profit-sharing contributions are discretionary as determined by the Plan Sponsors' Board of Directors. There were no such contributions in 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan Sponsors' contribution, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus earnings thereon. Vesting in the Plan Sponsor's profit sharing contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service. In the event a participant dies while employed by a Plan Sponsor or terminates their employment after becoming disabled, their balance in the Plan becomes fully vested. Upon termination of employment and participating in the Plan, the non-vested balance is forfeited except as previously described.

Forfeitures from profit sharing contributions are retained in the Plan and will first be used to pay administrative expenses. Any remaining amounts will be used to reduce future Plan Sponsor contributions payable under the Plan. There were no forfeited non-vested accounts at December 31, 2024 and 2023.

Payment of Benefits

On termination of service, disability, or retirement, the Plan shall automatically distribute the vested value of an account balance, as defined, if less than \$5,000, in a lump-sum amount. Vested account balances with a value greater than \$5,000, shall be distributed upon the participant's request. Upon death, the entire account balance must be distributed in a lump sum by the calendar year containing the fifth anniversary of death, unless the beneficiary elects to receive benefits ratably over a period of time not to exceed the beneficiary's life expectancy.

All amounts allocated to withdrawing participants for benefit claims that have been processed and approved for payment prior to December 31, 2024, were paid to the participants on or before that date.

Participant Hardship Withdrawals

Participants may withdraw from the Plan that portion of their account resulting from salary deferrals in the event of undue financial hardship. The maximum hardship withdrawal is the total of a participant's vested balance.

Note 1: Description of Plan (Continued)

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance, restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and repayable over a period not to exceed five years (except for loans for the purchase of a principal residence). The loans bear interest rates from 4.25% to 10.50%, which is commensurate with local prevailing rates at loan inception as determined by the Plan Administrator.

Plan Termination

Although it has not expressed an intention to do so, the Plan Sponsors have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP, requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reflected at contract value). Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at estimated fair value provided by John Hancock.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Note 2: Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Plan Sponsors or the Plan, at the Sponsors' discretion.

Transfers Between Fair Value Hierarchy Levels

Transfers in and out of Level I (quoted market prices), Level II (other significant observable inputs) and Level III (significant unobservable inputs) are recognized on the period beginning date.

Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level I - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Note 3: Fair Value Measurements (Continued)

Level II - Inputs other than quoted prices included within Level I that are observable for the asset or liability, either directly or indirectly. Level II inputs include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability

Level III - Unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. Unobservable inputs reflect the Custodian's own assumptions about what market participants would use to price the asset or liability. These inputs may include internally developed pricing models, discounted cash flow methodologies, as well as instruments for which the fair value determination requires significant management judgment.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the typical valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the registered investment company. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The registered investment companies held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the daily closing price as reported by the fund. These investments held by the Plan are open-end pooled separate accounts that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These investments held by the Plan are deemed to be actively traded.

Note 4: Investment Contract With Insurance Company

Until November 2023, the Plan maintained a fully benefit-responsive investment contract with Minnesota Life. In December 2023, the Plan transitioned to a similar contract with John Hancock Life Insurance Company. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The group annuity contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The value of this contract, as of December 31, 2024 and 2023, totals \$658,658 and \$838,303, respectively. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsors or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 5: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest earned on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock, Minnesota Life Insurance Company, and Standard Insurance Company.

Note 6: Related Party Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

John Hancock Trust Company is the Custodian of the Plan assets and, therefore, these transactions qualify as party-in-interest transactions. John Hancock is the third party administrator for the Plan and is therefore considered a party-in-interest. Minnesota Life Insurance and Standard Insurance Company were the custodians of the Plan from the beginning of the Plan year to February 2024, therefore, transactions with these custodians qualify as party-in-interest transactions. Minnesota Life Insurance and Standard Insurance Company were third party administrators of the Plan from the beginning of the Plan year to February 2024, therefore, transactions they are considered parties-in-interest.

The Plan incurs expenses related to general administration and record-keeping. The Plan Sponsors pay certain of these expenses and accounting and auditing fees relating to the Plan.

Note 7: Tax Status

The employer adopted a nonstandard prototype document with an IRS notification letter, dated June 30, 2020, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the previous three plan years.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
