### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Payette Associates, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors’ Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## *Notes to Financial Statements*

### **Note 1 - Description of Plan**

The following description of the Payette Associates, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan with a cash deferral 401(k) arrangement covering all eligible employees of Payette Associates, Inc. (“Employer”). All employees are eligible to make voluntary participant contributions (“Participants”), except non-resident aliens, interns, persons employed on a temporary basis to complete a specific project and employees who, prior to the Plan’s effective date, provided a written, irrevocable waiver of participation prior to their entry date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant-directed.

#### ***Participant Contributions***

Participants may generally defer up to 75% of their compensation as defined by the Plan, up to a dollar limit set by Federal law. The Plan has an auto enroll feature whereby unless a participant makes an election to defer upon eligibility, 6% will be deferred on their behalf. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”). The Plan allows for Roth (after-tax) deferrals.

#### ***Employer Discretionary Matching Contributions***

The Employer’s matching contributions are made at the discretion of the Board of Directors. The matching contribution is a discretionary percentage of a participant’s compensation or a discretionary dollar amount, subject to certain limitations. For the Plan year ended December 31, 2024, the Employer matched 25% of the first 6% of eligible compensation that a participant contributed to the Plan, subject to limits imposed by Federal law.

#### ***Participant Accounts***

Each participant’s account is credited with (a) the Participant’s contribution, (b) the Employer’s matching contribution, (c) actual investment earnings/losses, (d) charged with an allocation of administrative expenses, and (e) charged with actual loan fees, if applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant’s vested account.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Participants’ vested interests in Employer contributions are based on years of continuous service with the Employer. A participant begins vesting after one year of service and is fully vested after three years of service.

### **Note 1 - Description of Plan (Continued)**

#### ***Forfeitures***

A participant who leaves the employ of the Employer forfeits any non-vested balance. The Plan uses forfeitures to first reduce administrative expenses, then to reduce future Employer matching contributions. At December 31, 2024 and 2023, unused forfeitures in the amount of \$12,896 and \$13,097, respectively, were available. During the year ended December 31, 2024, \$8,513 of forfeitures were used for the Employer true up matching contribution for the 2023 Plan year funded into the Plan in 2024. Subsequent to December 31, 2024, \$12,896 of forfeitures were used for the Employer true up matching contribution funded into the Plan in 2025.

#### ***Payments of Benefits***

In-service withdrawals from a participant's elective pre-tax deferrals are permitted only due to financial hardship or disability. In-service withdrawals from a participant's vested account, excluding Roth elective deferrals, are permitted upon reaching age 59½. Upon termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of his or her account. If a participant's vested account does not exceed \$1,000, the Plan administrator, after notification, may distribute the entire non-forfeited account balance to the participant. If a participant's vested account is greater than \$1,000 but less than \$5,000, the Plan administrator, after notification, may distribute the entire non-forfeited account balance to the participant in the form of an IRA rollover account.

#### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at a time. The term of each loan may not exceed five years unless the loan is used to acquire a principal residence, in which case the term of the loan may not exceed ten years. The loans are secured by the balance in the Participant's account and bear interest at a reasonable rate of interest to be determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

#### ***Plan Administration***

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan.

## ***Notes to Financial Statements***

### ***Note 2 - Summary of Significant Accounting Policies***

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Unit Values***

Individual participant accounts for the common/collective trust are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units which are valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

#### ***Contributions***

Contributions from Plan participants and the discretionary matching contributions from the Employer are recorded in the year in which the contributions are withheld from compensation.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are charged to expense as incurred.

#### ***Benefits Paid***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from those estimates.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

### ***Note 3 - Information Certified by Trustee and Custodian***

Plan investments are held by the Plan's custodian and trustee, Fidelity Management Trust Company ("Fidelity"). The fair value of investments and all investment and notes receivable from participant transactions, including interest and dividends, and net appreciation in fair values, are reported to the Plan and certified as complete and accurate by Fidelity. Information included in the supplemental schedule of assets (held at end of year) and notes receivable from participants have also been derived from information certified by Fidelity.

The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on a participant's risk tolerance. The assets are invested funds through Fidelity. Plan participants have the option to invest their account balances among Fidelity and non-Fidelity mutual funds, a self-directed brokerage account and a stable value common/collective trust designated by the Investment Committee.

### ***Note 4 - Fair Value Measurements***

Financial accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

*Level I* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

*Level II* – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

### Note 4 - Fair Value Measurements (Continued)

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Mutual Funds

Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Stable Value Common/Collective Trusts

A stable value fund that is composed primarily of indirect fully benefit-responsive investment contracts is valued at the NAV of units less its liabilities. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Mutual Funds, Exchange Traded Funds, and Cash Reserve Funds (Self-Directed Brokerage Account)

Valued at closing price reported on the active market on which the individual securities are traded.

### Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Note 7 - Related-Party Transactions and Party-in-Interest Transactions***

Plan investments include mutual funds and a common/collective trust managed by Fidelity. Fidelity is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Fidelity totaled \$8,500 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

Effective December 1, 2023, Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the fund providers. When the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the Service Agreement, Fidelity remits the excess to the Plan's trust on a quarterly basis. The revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. The Plan received revenue credits of \$10,618 for the year ended December 31, 2024. Subsequent to year-end during 2025, the Plan utilized \$10,618 of revenue credits to pay plan expenses. The Plan or Plan Sponsor may make payments to Fidelity for administrative expenses not covered by revenue sharing.

### ***Note 8 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### ***Note 9 - Tax Status***

The Plan uses the Fidelity Volume Submitter Defined Contribution Plan prototype Plan document. The Internal Revenue Service (the "IRS") has determined that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC") and informed Fidelity of such in a letter dated June 30, 2020. The Plan has been amended since receiving the opinion letter. However, the Plan administrative committee believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
