NOTES TO FINANCIAL STATEMENTS**

**1 – Plan Description**

The following description of the Piolax Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution 401(k) profit-sharing plan established effective January 1, 1991, by Piolax Corporation (the Company or Plan Sponsor) to provide retirement benefits to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Upon meeting the entry date requirement, eligible employees may participate in the Plan as soon as administratively possible following the completion of 90 days of service with no minimum age requirement. Entry dates are January 1, April 1, July 1, and October 1.

**Contributions**

Each pay period, participants may elect to make deferral contributions of their pretax and after-tax compensation, as defined, subject to limitations as to the amount under the provisions of the Internal Revenue Service (IRS) (\$23,000 for 2024). Participants age 50 and older whose elective contributions have reached the IRS limit are permitted under the Plan to make catch-up contributions up to the IRS catch-up contribution limit (\$7,500 for 2024).

The Plan has a discretionary employer matching policy whereby the Company can change or discontinue its matching contribution. For the year ended December 31, 2024, the Company matched participant contributions at a rate equal to 40% of the participant's contribution, up to a maximum of 6% of the participant's salary. For the year ended December 31, 2024, the Company contributed \$233,794 to the Plan. The Company may also make a discretionary profit-sharing contribution to all eligible participants, whether or not they have elected to make contributions to the Plan. For the year ended December 31, 2024, the Company made no profit-sharing contributions to the Plan. Participants may change their investment options and deferral rates at any time.

The Plan allows for an automatic enrollment provision that includes an automatic escalation feature providing for a 1% automatic annual increase up to a maximum of 6% of participants' compensation, as defined.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of the Plan's investment results. Allocations of the Plan's investment results are based on relative account balances, as defined by the Plan.

**1 – Plan Description (continued)**

**Investment Options**

Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan. The Plan offers 23 mutual funds at registered investment companies, as well as a guaranteed investment account.

Participants may change their contribution percentages quarterly and may transfer some or all of the amounts in their accounts between fund options throughout the year.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are fully vested in the Company contribution portion of their accounts plus earnings thereon as follows:

2	20%
3	40%
4	60%
5 or more	100%

**Payment of Benefits**

A participant's vested account balance may be withdrawn upon retirement, as defined, termination of employment, or death during the Plan year. Distributions are made in the form of a lump-sum payment. Upon written request and approval, participants may withdraw some or all of their elective deferral contributions account balance while still employed, if the withdrawal is necessary due to financial hardship.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts, as defined by the Plan, a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000 (Note 2). Such loans bear interest at the prime rate plus one percent.

The loan is collateralized by the remainder of the participant's account and is repaid over a period not exceeding five years. Participants may select a repayment term of up to 10 years for loans used to purchase a principal residence. Principal and interest are paid ratably through payroll deductions.

**Forfeitures**

Forfeitures of terminated participants' non-vested accounts are used to reduce the employer's contribution to the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,210 and \$2,410, respectively. For the year ended December 31, 2024, \$16,851 of forfeiture was used to reduce the employer contribution.

**2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

**Accounting Pronouncements**

As of December 31, 2024, there were no new accounting pronouncements that had or were expected to have, including those not yet adopted, a significant impact on the financial statements or disclosures of the Plan.

The Plan assessed recent accounting pronouncements, noting none that would impact the financial statements or notes to the financial statements.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the reported amounts of assets and liabilities, as well as changes therein, and to disclose contingent assets and liabilities. Actual results could differ from those estimates.

**Reclassification**

Certain amounts from the prior year have been reclassified to conform to current year presentation.

**2 – Summary of Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition**

The Plan's investments (except for fully benefit-responsive investment contracts) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Pursuant to provisions of the Plan, expenses incurred in the administration of the Plan may, but need not, be paid by the Plan Sponsor. If the Plan Sponsor elects not to pay these expenses, they are paid by the Plan. During 2024, the Plan Sponsor paid all expenses on behalf of the Plan, except participant loan fees which were paid from participant accounts with outstanding loan balances. Investment-related expenses are paid from participant accounts within the Plan.

**3 – Fair Value Measurements**

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**6 – Excess Contributions Payable**

The Plan is subject to certain compliance requirements under non-discrimination rules of the Internal Revenue Service guidelines. For the years ended December 31, 2024 and 2023, the Plan failed a certain of these non-discrimination tests due to a lower level of contribution participation by non-highly compensated eligible Plan participants. Accordingly, the Plan had an excess contributions payable of \$8,482 and \$6,175, respectively, as of December 31, 2024 and 2023.

**7 – Party-in-Interest Transactions**

The Plan engaged in transactions involving John Hancock Life Insurance Company, an affiliate of John Hancock, the Plan’s trustee, which is a party-in-interest with respect to the Plan. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are not considered “prohibited transactions” under the Internal Revenue Code (IRC) and are not prohibited by ERISA.

**8 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the company contributions portion of their account.

**9 – Guaranteed Annuity Contract with Insurance Company**

As of December 31, 2024, and 2023, the Plan's fully benefit-responsive investment contract with John Hancock Life Insurance Company (U.S.A.) (JHLI) totaled \$1,417,925 and \$935,312, respectively. JHLI maintains the contributions in a general account. Accordingly, the guaranteed annuity contract balance is subject to the claims of JHLI's general creditors in the event of issuer insolvency. The guaranteed annuity contract is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value; thus, the contract is fully benefit-responsive. The guaranteed annuity contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The crediting rate is guaranteed never to fall below 1%.

Certain events limit the Plan's ability to transact at the contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable to occur.

**10 – Income Tax Status**

The Plan received a determination letter from the IRS, dated June 30, 2020, stating that the Plan was qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no such audits in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**11 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**12 – Subsequent Events**

The Plan has evaluated events subsequent to December 31, 2024 and through August 28, 2025, the date the financial statements were available to be issued and determined that there were no events that require adjustments to these financial statements.
