## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Harvard-Westlake School Defined Contribution Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Harvard-Westlake School Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Harvard-Westlake School Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Harvard-Westlake School Defined Contribution Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Harvard-Westlake School Defined Contribution Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of the Harvard-Westlake School Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Harvard-Westlake School (the "School" or "Employer") pursuant to Section 403(b) and related provisions of the Internal Revenue Code (IRC), was established effective January 1, 1975. The Plan was amended and restated, effective January 1, 2020. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan covers all eligible employees of the School upon employment. It is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), and subsequent laws.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The School has until the end of the first Plan year beginning on or after January 1, 2026 to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The School is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The School has delegated certain functions related to the operation and administration of the Plan. Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF), and as agent for TIAA Trust, N.A., (collectively, the "Custodians") are responsible for the custody and management of the Plan's assets and an affiliate of the Custodians maintains participant account records. Certain administrative expenses of the Plan, including audit fees, were paid by the School. Investment fees, which may vary according to the individual funds selected, are paid indirectly out of the assets of the Plan.

Eligibility

All employees, excluding students who are enrolled and attending classes offered by the School, are immediately eligible to participate in the Plan through elective deferrals, with no age or service requirements. Eligible employees for mandatory contributions and Employer matching contributions includes all employees except students enrolled and attending classes at the School, and employees whose employment and retirement benefits are governed by a collective bargaining agreement, provided that 2% or fewer of the employees covered by such agreement are classified as professionals.

Eligibility (continued)

In order to be eligible to receive Employer matching contributions, participants must be at least 21 years of age and work at the School on a schedule which, if expected to continue for the duration of a full Plan year, would result in the participant working at least 1,000 hours per Plan year.

Contributions

Each year, participants may contribute up to the limits permitted under the IRC of pretax annual compensation, as defined in the Plan. The maximum allowed deferral amount was \$23,000 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make an additional catch-up contribution of up to \$7,500 in 2024. Further, the Plan allows for additional catch-up contributions for employees with 15 years or more of service. Participants must contribute a minimum of 6 percent of their pretax compensation, as a condition of employment, if they are 30 years of age or older and meet the requirement of working on a schedule that results in at least 1,000 hours worked per Plan year.

The School matches 100% of the mandatory contribution of 6%. Participants may make an additional contribution, which the School will also match, up to 4% of each participant's eligible compensation.

Participants with compensation exceeding the social security wage base are eligible to receive an additional Employer contribution of 5.7% of compensation during any portion of the Plan year in which the participant's compensation exceeds the social security wage base.

Participants who are under 30 years of age, meet the requirements of working on a schedule, which if expected to continue for the duration of a full plan year, would result in at least 1,000 hours worked per the Plan year, and are deferring into the Plan are eligible to receive the School match of up to 10%.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans into the Plan as a rollover contribution. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies and variable annuities as investment options for participants.

Participant accounts

Each participant's account is credited with the participant's contributions, rollover contributions, if any, the School's contribution and an allocation of Plan earnings, if any, and charged with an allocation of administrative expenses and Plan losses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the School's matching contributions, plus actual earnings thereon.

Plan loans

Plan loans to participants, which are no longer offered as of October 2020, were available to participants through TIAA and CREF, subject to certain limitations. Plan loans were issued directly from funds owned by TIAA and CREF, therefore, Plan loans were not considered part of the Plan's assets. Adequate security was required and a portion of the participant's account was reserved, or held in collateral, to cover 110% of the outstanding loan in case of default. The Plan loan interest rate may have been fixed or variable, and the initial rate is determined by the terms of the controlling contract as is the rate adjustment and frequency, if applicable.

For Plan loans having collateral held in a Group Supplemental Retirement Annuity contract, principal repayments increased the amount of TIAA Traditional Annuity funds available for the participant's use. For Plan loans having collateral held in a Retirement Annuity, Retirement Choice or Group Retirement Annuity contract, principal repayments were allocated to the participants existing contribution elections on file.

For all Plan loans, interest was paid directly to TIAA and CREF. At December 31, 2024 and 2023, participants had outstanding Plan loan balances due to TIAA and CREF of \$389,726 and \$482,891, respectively.

If an employee defaults on a Plan loan and has a triggering event such as separation from service, retirement, death, disability or attainment of age 59½, the Plan loan is treated as a deemed distribution and funds held as collateral in the Plan are paid to TIAA and CREF. When a Plan loan default occurs prior to a triggering event, the funds that are held as collateral in the Plan are transferred to the Plan Loan Default Fund and are not paid to TIAA and CREF until a triggering event occurs. As of December 31, 2024 and 2023, the balance of the Plan Loan Default Fund was \$281,798 and \$261,453, respectively.

Notes receivable from participants

Notes receivable from participants ("participant loans" or "loans") are issued directly from the participant's account balance. Participants are allowed to borrow from their accounts not less than \$1,000 and up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Participant loans must be repaid in five years unless the loan is to purchase a principal residence. Participant loans are secured by the balance in the participant's account managed by the Custodians and bear interest at the prime rate plus 1%. Principal and interest payments are made directly by the participant to the Custodians. Outstanding participant loans as of December 31, 2024 bear interest at the annual rates of 4.25% to 9.50% and have various maturity dates through September 2029.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability or death. The participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial payment, installment payments, an annuity contract, or may postpone payment to a later date and remain in the Plan as described in the plan documents. A 10% Federal excise tax applies to certain withdrawals prior to age 59½. Unless otherwise elected, if a terminated participant's account balance is less than \$5,000, their balance shall be automatically rolled over into an individual retirement account designated by the Plan administrator.

Hardship withdrawal

Participants may withdraw their pretax contributions and Employer matching contributions invested to satisfy any of the following immediate and heavy financial needs: (1) medical expenses; (2) purchase of principal residence; (3) to prevent eviction from, or foreclosure on, principal residence; (4) tuition and education-related expenses for participant, spouse or dependents; (5) funeral or burial expenses; or (6) repair damage on principal residence. Participants must first exhaust all other assets reasonably available prior to obtaining a hardship withdrawal.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of estimates

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and the change therein, and disclosures of contingent liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3. Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally receive if they were to initiate permitted transactions under the terms of the Plan document. See Note 4.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions and receivables

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the School, which is the pay date.

Contributions from the School are recorded in the year they are earned and to coincide with the year in which the School records the contributions. The Plan records receivables for all contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Contributions representing participant rollovers from other qualified defined benefit or defined contribution plans are recorded when received.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and changes therein.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses of the Plan are recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- *Level 1* - inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- *Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- *Level 3* - inputs are unobservable inputs for the asset or liability and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following methods and assumptions were used to estimate the fair value of financial instruments:

Mutual funds: Investment securities traded on security exchanges are valued at the daily closing market prices as of the valuation date. The mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. The funds are deemed to be actively traded and are classified within Level 1 of the fair value hierarchy.

Pooled separate account: Units held in the separate account are accumulation units and calculate the contract owner's interest. Such units are valued daily to reflect investment performance and the prorated daily deduction for expense charges. The number of units credited to a participant's account is determined by dividing the dollar amount of the transaction by the unit value the next time value is computed. Units are valued any day the New York Stock Exchange is open for business and may be accessed by the plan sponsors and participants via the TIAA website. The pooled separate account is classified within Level 1 of the fair value hierarchy.

CREF variable annuities: The fair values of accumulation units held by the Plan in CREF variable annuities are primarily valued using market quotations or prices obtained from independent pricing sources. Data for values are available daily to Plan administrators and client investors on TIAA's website and provide sufficient corroborative evidence to ascertain the relationship between each fund's value and the values of individual underlying holdings. Underlying holdings include mutual funds and are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts, and these investments may be redeemed at any time. The CREF variable annuities are classified within Level 1 of the fair value hierarchy.

Self-directed brokerage accounts: Includes investments in a money market fund and common stocks. The common stock investments and the money market fund are classified as Level 1 investments within the valuation hierarchy. Common stock traded in active markets on national security exchanges are valued at closing prices on the date closest to December 31.

Fixed Annuity Contracts (Level 3): The contract value of the Plan's interest in non-fully benefit-responsive fixed annuity contracts is determined by the accumulated cash contributions and interest credited to the contracts, less any withdrawals. Contract value is an approximation of fair value. The crediting rate is based on the investment performance of a large, diversified portfolio, is correlated with the highest debt security yields, and is adjusted for contract liquidity. The Plan sold and purchased investments in non-fully benefit-responsive contracts totaling \$2,941,933 and \$1,892,448, respectively, during the year ended December 31, 2024. Transfers in and out of non-fully benefit-responsive investment contracts totaled \$2,561,912 and \$1,318,435, respectively, during the year ended December 31, 2024.

4. INVESTMENT CONTRACTS WITH TIAA

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The TIAA Traditional Annuity is offered through a variety of contract types, including the Group Retirement Annuity (GRA), Retirement Annuity (RA), Retirement Choice Annuity (RC), Group Supplemental Retirement Annuity (GSRA), Supplemental Retirement Annuity (SRA) and Retirement Choice Plus Annuity (RCP). The GRA, RA and RC contracts are considered non-benefit responsive, and the RCP, GSRA and SRA contracts are considered fully benefit-responsive.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported by TIAA, but are not included within the fair value hierarchy (Note 3). Investment contracts that are non-benefit responsive are presented at fair value. TIAA indicated that contract value approximates fair value for these investments at December 31, 2024 and 2023. Contract value represents accumulated cash contributions made under the contract, plus interest credited to the contracts, less participant withdrawals and transfers. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The contracts do not permit the issuer to terminate the agreement prior to the scheduled maturity date.

The Plan administrator is not aware of reserves against contract value for credit risk of the contract issuer or otherwise. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal and a guaranteed minimum rate of interest of 1% to 3%. The contract also offers the opportunity for additional amounts in excess of the guaranteed rate. When declared, additional amounts remain in effect for the 12-month period that begins each March 1. Additional interest is not guaranteed for future years.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA or Plan participants.

5. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The Plan administrator has elected the method of annual reporting permitted by 29 CFR 2520.103-8 of ERISA. Certain information related to investments and notes receivable from participants, and related activity, disclosed in the accompanying financial statements and supplemental schedule, was obtained by management and agreed to or derived from information certified by the Custodians (Note 1), whom the Plan administrator has determined to be a qualified institution. Accordingly, the Custodians have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividends and interest, and other income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and,
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) ("supplemental schedule") as of December 31, 2024.

Accordingly, as requested by the Plan administrator, the Plan's independent auditor performed no auditing procedures with respect to the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

6. PLAN TERMINATION

Although the School has not expressed any intent to do so, the School has the right under the Plan to discontinue all contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

7. TAX STATUS

The Plan is a defined contribution plan designed to qualify as a tax-exempt plan under the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Services (IRS) and is appropriate for use by employers for the benefit of their employees. The Plan is intended to meet the requirements of Section 403(b) of the Code. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRS and therefore, believes the Plan is qualified and tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines a party-in-interest similarly to a related party under financial accounting standards, except that ERISA's definition is broader and includes all entries and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. There are no related parties to the Plan that were not also considered to be a party-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Plan investments are shares of certain mutual funds, variable annuity contracts, guaranteed investment contracts and a real estate fund pooled account managed by the Custodians, therefore, related transactions qualify as exempt party-in-interest transactions.

The Custodians retain as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

Certain fund level fees incurred by the funds in which the Plan invests for services as investment management, shareholder services and sub-transfer agency fees are paid through fund level revenue sharing arrangements. These fees reduce fund earnings thereby impacting Plan revenue applied to participant accounts. Any excess amounts above the record keeping fees are credited back to the participants invested in specific funds.
