## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Veranex 401k Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Veranex 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of the Plan**

The following description of the Veranex 401k Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement or the Summary Plan Description for more information about the Plan.

***General***

The Plan is a participant-directed defined contribution 401(k) Plan, covering all eligible employees of Veranex, Inc. (Veranex or Plan Sponsor) and its wholly-owned subsidiary, Ximedica, LLC (Ximedica) (collectively, the Company or Employer), who have attained the age of 21 and has at least one month of service, except for leased employees, union employees, nonresident aliens, residents of Puerto Rico, interns, and contractors. Previous subsidiaries of Veranex were dissolved in 2023 and employees of those dissolved entities became employees of Veranex upon dissolution. Eligible employees will become participants in the Plan on the first day of the month after meeting the eligibility requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor is also the administrator of the Plan. As administrator, the Plan Sponsor has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. John Hancock Retirement Plan Services, LLC (John Hancock), the appointed trustee of the Plan, acts at the direction of the Plan Administrator.

Effective February 28, 2023, Fusion Biotech, Inc. (Fusion Biotech) was added as a Participating Employer. During February 2023, a total of approximately \$1,316,000 in assets were transferred in from the Fusion Biotech 401(k) Plan. In 2023, Fusion Biotech was dissolved, and all employees formerly employed by Fusion Biotech became employees of Veranex.

Effective January 1, 2024, those who became employees of the Company due to the acquisition of the assets of Translation Testing and Training Laboratories, Inc. (T3 Labs) became eligible to participate. No assets were transferred into the Plan.

Effective June 1, 2024, those who became employees of the Company due to the acquisition of the assets of HORUS Scientific, Inc. (Horus) became eligible to participate. No assets were transferred into the Plan.

***Contributions***

Participants may elect to contribute up to 90% of their eligible annual compensation, not to exceed annual limitations as prescribed by the Internal Revenue Code (IRC), on a pre-tax or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. An employee may change or revoke their deferral election at any time.

The Plan includes an automatic contribution provision, whereby newly eligible employees are automatically enrolled to defer 3% of eligible earnings, as applicable, in the Plan. Additionally, the Plan also includes an automatic escalation provision for participants whereby each eligible participant's deferral rate will increase annually by 1%, not to exceed 10% of a participant's eligible compensation. Participants must submit an election to opt out of the automatic enrollment provision of the Plan.

The Plan's employer matching contribution is based on a Flexible Discretionary Match, as defined in the Plan Agreement. During 2024, the Employer provided a matching contribution of 50% of the first 6% of a participant's elective deferral of eligible compensation. During the year ended December 31, 2024, the Employer made matching contributions to the Plan of approximately \$1,011,000.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, any rollover contributions made by the participant, the Employer's matching contributions and their allocation of the Plan's investment earnings/losses from the investment option(s) selected by the participants. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is based on the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions (including rollover contributions) plus actual earnings/losses on those contributions. Participants become fully vested in Plan Sponsor's matching contributions and allocated earnings on those contributions after four (4) years of service. Participants are partially vested in the Plan Sponsor's matching contributions as follows: 25% after 1 year, 50% after 2 years, 75% after 3 years, and 100% after 4 years. Participants' prior service with Participating Employers is credited towards vesting. Upon death, total and permanent disability or attaining the age of 65, a participant becomes fully vested in their accounts.

Special vesting provisions apply to certain merged in plans. Former participants in the Fusion Biotec 401(k) Plan with at least 3 years of service will remain fully vested in employer matching contributions and future matches made under the Plan while those with less than 3 years of service remain subject to the prior 3 year graded vesting schedule for the prior employer match and subject to the vesting schedule above for future contributions.

Prior safe harbor contributions made to participants of plans merged in during 2022 remain 100% vested. Prior employer matching and nonelective contributions of merged in plans will be subject to either the prior employer's or the Plan's vesting schedule as specified in the Plan Agreement.

***Participant Notes Receivable***

The Plan includes a loan provision allowing active participants to borrow against their total vested account balance. Loans must be a minimum of \$1,000 and may not exceed the lesser of \$50,000 (reduced by the highest outstanding loan balance held under the Plan in the previous 12 months) or 50% of a participant's total vested account balance. Loan terms range from 1 to 5 years, or up to 15 years for the purchase of a primary residence. A participant may not have more than one loan outstanding at any time. The interest rate for a new loan is the prime rate plus 1 percentage point. The rate is fixed for the term of the loan. Principal and interest are paid ratably through payroll deductions.

***Forfeitures***

Participants in the Plan who leave the employment of the Plan Sponsor before completing four years of service forfeit the non-vested portion of the Plan Sponsor contributions to their accounts. Forfeitures may be used to reduce future Plan Sponsor contributions or to pay Plan expenses. During the year ended December 31, 2024, approximately \$225,000 of forfeitures were used to reduce Plan Sponsor matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$44,678 and \$39,356, respectively.

***Payment of Benefits***

Upon termination of services due to death, disability or retirement, a participant (or participant's beneficiary in the event of death) will be entitled to 100% of their vested account balance, payable in accordance with the procedures described in the Plan.

For termination of service due to other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. Participant vested account balances that do not exceed \$5,000 are to be paid in a lump sum in accordance with the procedures described in the Plan to be made as soon as administratively feasible following severance of employment. Participant consent is required if the distribution is over \$5,000 and such participants may elect to delay distribution or take a single lump sum payment. If the participant makes no election, the balance will be automatically rolled over to an IRA.

In addition, hardship withdrawals from the Plan are permitted subject to the applicable ERISA laws. In-service withdrawals are permitted after a participant reaches age 59½.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balance plus any accrued and unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within the stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

***Contributions***

Employer matching and participant contributions are recorded bi-weekly when the Employer remits the payroll deductions for investment into the Plan.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in accordance with GAAP requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in four mutual funds that accounted for approximately 51% and 49% of total Plan investments as of December 31, 2024 and 2023, respectively.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the trustee's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

The Plan Administrator has evaluated subsequent events through September 3, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Fund:* The Plan invests in the John Hancock Stable Value Fund which invests in corporate bonds, government securities and other investment companies. This fund is valued at the NAV of units of a collective trust. The NAV, as provided by John Hancock Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined daily by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily.

There are no unfunded commitments or redemption restrictions for the individual participants within the Plan, however, there is up to a 12-month redemption notice period for this investment at the Plan level.

As of December 31, 2024 and 2023, the Plan’s investments in mutual funds are reported at level 1 within the fair value hierarchy.

**4. Plan Termination**

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**5. Income Tax Status**

The Plan has been designed using a non-standardized pre-approved profit sharing plan of John Hancock Retirement Plan Services, LLC in which the Internal Revenue Service (IRS) stated, in a letter dated June 30, 2020, that the Plan satisfies the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. The Employer and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**7. Related Party Transactions and Party-in-Interest Transactions**

Plan investments were held and managed by John Hancock. In addition, the Plan contracted with MMA Securities, LLC for investment advisory services. Therefore, transactions with these parties qualify as party-in-interest transactions. The Plan made direct payments to John Hancock of \$58,324 for administrative services for the year ended December 31, 2024. The Plan also made direct payments to its investment advisor of \$70,940 during 2024. In addition, participant notes receivable qualify as party-in-interest transactions.

**8. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are the result of different classifications between line items and the reversal of 2023 contributions receivable in the accrual basis financial statements.

**9. Non-exempt Transactions**

During 2024, the Employer failed to remit participant contributions of \$321,382 and loan repayments of \$10,964 to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulations 29 CFR 2510.3-102. Defined contribution plans must remit employee contributions to the Plan as soon as they can be reasonably segregated from the Employer's general assets and are withheld or received by the Employer.

During 2024, the Employer remitted untimely participant contributions of \$321,382 and loan repayments of \$10,964 due to the Plan for the year ended December 31, 2024. Lost earnings and employer match associated with these late remittances were remitted during 2025.

During 2023, the Employer failed to remit participant contributions of \$671,785 and loan repayments of \$14,295 to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulations 29 CFR 2510.3-102.

During 2023, the Employer remitted untimely participant contributions of \$527,255 and loan repayments of \$10,297 due to the Plan for the year ended December 31, 2023. During 2024, the Employer remitted untimely participant contributions of \$144,530 and loan repayments of \$3,998 due to the Plan for the year ended December 31, 2023. Lost earnings and employer match associated with these late remittances were remitted during 2025.
