### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Winxnet 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### 1. Plan Description

---

The following brief description of the Winxnet 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to the employees of Winxnet, LLC dba Logically and its wholly-owned subsidiaries (the Company). In January of 2023, the Cornerstone IT 401(k) Retirement Plan, the Halski Systems, LLC 401(k) Plan, and the Cerdant Inc 401(k) Profit Sharing Plan were merged into the Plan (See Note 7).

Employees are eligible to make pre-tax and designated after-tax Roth salary deferral contributions on the first day of the month after attaining 21 years of age and completing six consecutive months of service. Participants are also eligible to receive discretionary matching and profit-sharing contributions. Participants are eligible to receive discretionary profit-sharing contributions if they are employed on the last day of the Plan year. Eligible participants become participants on the first day of the month following the date on which entry requirements are fulfilled.

#### ***Contributions***

Participants may elect to defer up to 100% of their annual eligible compensation as defined by the Plan, up to the maximum dollar amounts allowable by law. Participants may also contribute amounts representing distributions for other qualified plans. At any time, a participant may elect not to contribute or may increase or decrease his or her deferral rate. The Company may make discretionary matching and profit-sharing contributions. Participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and an allocation of a) the Company's discretionary matching and profit-sharing contributions, b) Plan earnings and losses and c) an allocation of administrative expenses paid by the Plan. The Company's discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated based on the classification of the participant and their eligible compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Ascensus, LLC, as an authorized representative for Ascensus Trust Company and Newport Trust Company, LLC (collectively "Ascensus").

### *Vesting*

Participants are immediately vested in their participant contributions and the Company's discretionary matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions credited to participants' accounts is based on years of continuous service. A participant is 20% vested after one year of credited service and vesting increases 20% per year until a participant is 100% vested after five years of credited service.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest are paid through payroll deductions.

### *Payment of Benefits*

Upon death, termination, retirement, or disability a participant or beneficiary may elect to receive partial payments or single lump-sum payments equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution of payments between \$1,000 and \$7,000 (\$5,000 prior to November 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participants in the event the participant does not elect a payout option. Participants may also receive hardship and in-service distributions, as permitted in the Plan document. Benefits are recorded when paid.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce Company contributions or to pay Plan expenses. At December 31, 2024 and 2023, there were no forfeited non-vested accounts available. During 2024 and 2023, \$1,647 and \$0, respectively, of forfeited amounts were used to pay Plan fees.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 12, 2025, noting no items requiring disclosure.

### 3. Information Certified by Ascensus

### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts:* The self-directed brokerage accounts include investments in money market funds and common stocks. The money market funds and common stocks are valued at the daily closing price reported on the active market on which the individual security is traded.

*Common Collective Trust:* Valued at the NAV based on the market value of its underlying investments, FASB ASC 820, Fair Value Measurement, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meet those requirements. Participants can redeem the trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## Notes to Financial Statements

### December 31, 2024 and 2023

---

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution of account balances to participants would be made as soon as practicable after the termination date.

#### 7. Plan Mergers

---

Effective January 2023, the Company approved the merger of the Cornerstone IT 401(k) Retirement Plan (Cornerstone Plan). The blackout period for the transfer of assets from the Cornerstone Plan took place from March 5, 2023 up until April 1, 2023. As a result of the merger, net assets of the Cornerstone Plan of \$759,119 were transferred and received by Ascensus in March 2023.

Effective January 2023, the Company approved the merger of the Halski Systems, LLC 401(k) Plan (Halski Plan). The blackout period for the transfer of assets from the Halski Plan took place from January 22, 2023 up until February 18, 2023. As a result of the merger, net assets of the Halski Plan of \$1,377,278 were transferred and received by Ascensus in February 2023.

Effective January 2023, the Company approved the merger of the Cerdant Inc. 401(k) Profit Sharing Plan & Trust (Cerdant Plan). The blackout period for the transfer of assets from the Cerdant Plan took place from February 6, 2023 up until March 4, 2023. As a result of the merger, net assets of the Cerdant Plan of \$1,721,138 were transferred and received by Ascensus in February 2023.
