Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Felker Brothers Corporation Union 401(k) Plan's internal control. Accordingly, no such opinion is expressed.

### Note 1: Description of Plan

The following description of the Felker Brothers Corporation Union 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is an employer and employee contributory trustee plan providing for payment of retirement benefits under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers any non-leased employee of Felker Brothers Corporation (the "Company") who is a Local Lodge No. 697 of the International Brotherhood of Boilermakers, Iron Shipbuilders, Blacksmiths, Forgers, and Helpers, AFL-CIO employee. An employee becomes eligible to participate in the Plan on the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

#### Contributions

Participants are allowed to contribute pretax annual compensation, as defined by the Plan, or Roth contributions up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan.

The Company will contribute a nonelective contribution in accordance with a previously negotiated labor contract as follows:

September 3, 2023 through September 7, 2024	1.55/hour
September 8, 2024 through September 6, 2025	1.60/hour
September 7, 2025 through September 5, 2026	1.65/hour
September 6, 2026 through September 4, 2027	1.70/hour

The Company made nonelective contributions of \$295,024 (net of forfeitures) for the year ended December 31, 2024.

Contributions are subject to certain limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's nonelective contribution and allocations of plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. The Company's nonelective contributions, plus actual earnings (losses) thereon, vest at a rate of 20% per year beginning with the first year of service. A participant is fully vested in the Company's nonelective contributions after five years of continuous full-time service.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, partial lump-sum amount, or in substantially equal installments if the account balance is greater than \$7,000. If the participant's vested account balance does not exceed \$7,000, the plan administrator will pay an involuntary cashout distribution as a lump-sum. If the participant's vested account balance exceeds \$1,000 but does not exceed \$7,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement account. The Plan also allows for in-service distributions upon attaining age 59½.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's nonelective contributions. The Company may decide in its discretion how to treat forfeitures under the Plan. Forfeitures available at December 31, 2024 and 2023, were \$13,966 and \$4,852, respectively. During 2024, \$24,862 of forfeitures were used to reduce Company contributions.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### **Note 2: Summary of Significant Accounting Policies** (Continued)

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by its investment advisor, Matrix Trust Company ("Matrix"), the trustee of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

The Plan absorbs various plan expenses including third-party administration fees. Expenses that are paid by the Company are excluded from these financial statements. Investment advisory and management fees are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through September 11, 2025, which is the date the financial statements were available to be issued.

The Company was notified that effective January 1, 2025, One America Retirement Services, LLC ("One America") moved its retirement business to Voya Financial through an acquisition. The transition for the Company is scheduled to take place the weekend of October 11, 2025.

### **Note 3: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

### Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash (money market fund):* Valued at net asset value (NAV).

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and non-interest-bearing cash held and amounts due to broker for securities purchased at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and other income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix (the trustee of the Plan).

### **Note 5: Party-in-Interest Transactions**

Plan investments are held by Matrix, the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees for the trustee services during the plan year ended December 31, 2024, were offset against earnings. In addition, the Plan paid administrative expenses for record keeping services to One America. These transactions also qualify as party-in-interest transactions.

Plan investments are managed by Alpha Investment Consulting Group, which also qualify as party-in-interest transactions.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 7: Tax Status**

The Company adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the IRC. The Plan was amended subsequent to receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Transfers To and From Plan**

Transfers to and from the Plan represent investment assets transferred to/from the Felker Brothers Corporation Salaried 401(k) Plan as a result of employee transfers to office from union positions and to union from office positions during the plan year.
