Notes to Financial Statements

1. Description of Plan

The following description of the Local Initiatives Support Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Local Initiatives Support Corporation (LISC, the Company, or the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The current Plan is administered by LISC. LISC has contracted out certain aspects of the Plan administration to Vanguard Fiduciary Trust Company (Vanguard or Trustee). Vanguard, the Plan's trustee and recordkeeper, maintains the Plan's holdings.

Eligibility Requirements

All employees are eligible to participate in the salary-reduction contribution portion of the Plan on the date of hire with the Company. With respect to employer contributions, participants become eligible upon completion of one year of service, with at least 1,000 hours of service.

Contributions

Employees may contribute, in the form of salary deferrals, up to \$23,000 for 2024 and \$22,500 for 2023. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to legal limits of \$7,500 in both 2024 and 2023. After the completion of one year of service, LISC will match 50% of eligible contributions made by the participant to the Plan, up to 3% of the participant's compensation. Participants are also permitted to make rollover contributions of amounts received from other tax-qualified, employer-sponsored retirement plans, but only for those employees eligible to participate in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of LISC's contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions to the Plan plus actual earnings thereon. Vesting in LISC's matching contributions is based on the employees' years of service: zero to one year - 0%, two years - 20%, three years - 50%, four years - 75%, and five years or after - 100%. A participant will become 100% vested in LISC's matching contributions if, while employed by LISC, the participant dies, becomes disabled, or reaches early retirement age.

Investment Options

Vanguard

Participants may direct employee contributions in 1% increments in any of the investment options for the accounts maintained by the Trustee.

Participants may change their investment options daily in the investment options maintained by the Trustee on any open market day.

Equitable Financial Life Insurance Company

For those participants who still have assets at Equitable Financial Life Insurance Company (Equitable), formerly AXA Equitable Life Insurance Company, they are invested in the investment options offered by Equitable.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range up to five years or, if the loan proceeds are used to acquire a principal residence, the loan may be repaid over a reasonable period of time that may be longer than five years. All loans bear rates at prime of interest and are considered a direct investment from the participant's account under the Plan. All payments of principal and interest on a loan will be credited to the participant's account. Currently, participants that leave employment at LISC may not borrow from their accounts.

Payment of Benefits

On termination of service due to retirement, disability, or death, a participant may elect to receive the vested interest in their account in a lump-sum payment or annual installments.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$41,702 and \$54,683, respectively. These accounts will be used to pay administrative expenses and reduce future employer contributions. In 2024, there were no forfeitures used to pay administrative expenses and \$52,743 was used to reduce employer contributions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - These funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts - These assets are valued at their accumulation unit value (AUV) as a practical expedient to measuring fair value. The AUV is determined daily based on the NAV of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments. The underlying funds of the pooled separate accounts are generally invested in registered investment companies, whose investment strategies are to seek capital appreciation through investment in common and preferred stocks and debt securities.

Common Collective Trust - The common collective trust invests solely in the Vanguard Retirement Savings Master Trust. The underlying investments of the Vanguard Retirement Savings Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks, and that are backed by bond funds. The common collective trust is valued at the unit value of the Vanguard Retirement Savings Master Trust. The common collective trust intends to maintain a constant NAV of \$1.00 per share. The Plan's investments in the common collective trust may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments.

Guaranteed Interest Account - The guaranteed interest account is valued at fair value, which approximates contract value. The contract value equals the accumulated cash contributions, interest credited, and transfers, less any withdrawals and transfers. Interest is credited daily and is calculated using three levels of interest in effect at the same time, specifically, the minimum interest rate guaranteed over the life of the contract, the annual minimum guaranteed interest rate for the calendar year, and the current interest rate.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and a common collective trust managed by Vanguard and accounts managed by Equitable. These transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment management services were \$73,856 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

6. Tax Status

The Plan has adopted the Vanguard Group Volume Submitter Profit-Sharing Plan with Cash or Deferred Arrangement. Accordingly, the Plan is permitted to rely on the opinion letter. The Internal Revenue Service (IRS) has determined and informed the Vanguard, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Subsequent Events

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued, and there were no subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
