Note 1. Description of Plan

The following description of Zylo 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan sponsored by Zylo, Inc. (Company) for the benefit of its employees who are age 18 or older and who are scheduled to work at least 1,000 hours. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Through November 30, 2023, Matrix Trust Company served as custodian of the Plan and a member of Company management served as the trustee of the Plan. Human Interest Advisors, LLC served as the Plan's recordkeeper through November 30, 2023. Effective November 30, 2023, Empower Annuity Insurance Company of America and Empower Trust Company, LLC serves as Plan recordkeeper and trustee.

The conversion initiated a blackout period beginning November 27, 2023 through December 27, 2023. During this period, participants were unable to direct or diversify the assets held in their accounts until the Trusts had time to accurately complete the conversion. During this period, participant contributions continued to be made through payroll deductions and the contributions were deposited and held in a money market account until the completion of the blackout period. At the end of the blackout period, these funds were transferred to the applicable Trust and invested in funds as requested by each participant.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to the maximum allowed by law. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Company matching and profit-sharing contributions are discretionary as determined by the Company's Board of Directors annually. Effective April 1, 2023, the Board of Directors elected to make a discretionary matching contribution of 50% of the participants deferral on the first 3% of eligible compensation up to \$750 for 2023 and \$1,000 for subsequent years. Contributions are subject to certain limitations.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant made an affirmative election otherwise. Effective November 30, 2023, the Plan also includes an annual automatic participant deferral increase of 1% at the beginning of every Plan year starting with the second Plan year up to 10% of eligible compensation.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the mutual funds and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary contribution, if any, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in all account balances upon hire.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in their account. In-service withdrawals are allowed under certain circumstances provided by the Plan.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and only one loan can be outstanding. The loan interest rate is based on local prevailing market rates plus one percent. Principal and interest are paid ratably through monthly payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document. As of December 31, 2024 and 2023, there were no notes receivable from participants.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and the money market fund are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 3. Certification of Plan Trustee and Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company and Empower Trust Company, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Plan paid \$6,105 of recordkeeping fees to Empower during the year ended December 31, 2024. The Plan additionally paid \$12,196 of investment advisory fees to Kestra Advisory Services, LLC during 2024. The Plan paid \$15,526 of recordkeeping fees to LT Trust Company and \$75 of recordkeeping fees to Empower during the year ended December 31, 2023. The Company provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan currently does not hold any Level 2 or Level 3 securities.

Note 6. Plan Tax Status

Effective November 30, 2023, the Plan operates under a nonstandard submitter adoption agreement in connection with a prototype profit-sharing plan and trust document sponsored by Empower Retirement, LLC. From March 24, 2022 to November 30, 2023, the Plan operated under a nonstandardized submitter adoption agreement in connection with a prototype profit-sharing plan and trust document sponsored by CCH Incorporated (dba ftwilliam.com). The Plan has been amended since the prototypes received favorable opinion letters. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
