Note A.

Description of Plan

The following description of the Farwest Corrosion Control Company 401(k) Salary Reduction Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution savings plan sponsored by Farwest Corrosion Control Company (the "Company", "employer" or "Plan administrator"), pursuant to Section 401(k) and related provisions of the Internal Revenue Code ("IRC"), and was established effective June 30, 1975.

The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination or financial hardship. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent laws.

The Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act") was signed into law on December 20, 2019, and the SECURE 2.0 Act of 2022 ("SECURE 2.0") was enacted on December 29, 2022. These laws include numerous provisions impacting retirement plans, including, but not limited to, changes to the required minimum distribution age, eligibility for long-term part-time employees, automatic enrollment requirements for certain new plans, and expanded withdrawal and contribution options. The provisions of these laws become effective on various dates. The Plan is evaluating the impact of the SECURE Act and SECURE 2.0 and will implement required changes in accordance with applicable effective dates and regulatory guidance.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Recordkeeping services for the Plan are provided by The Standard Insurance Company ("The Standard"). Effective December 1, 2022, The Standard acquired Securian Financial Group, the Plan's former recordkeeper, and assumed responsibility for providing recordkeeping services to the Plan. Effective in 2024, The Standard also assumed responsibility for providing custodial and trustee services to the Plan.

Note A.

Description of Plan (Continued)

Eligibility

The Company's employees who are not leased employees, union employees or non-resident aliens become eligible to participate in the Plan on the first day of the quarter after completing one year of service and at least 1,000 hours of service as defined by the Plan.

Contributions

Each year participants may make voluntary pretax contributions to a traditional 401(k) account or after-tax contributions to a Roth 401(k) account from eligible compensation, as defined in the Plan document, subject to limitations imposed by applicable Internal Revenue Service ("IRS") regulations. Additionally, participants who attain age 50 by the end of the year may elect to make certain catch-up contributions subject to limitations imposed by applicable IRS regulations. Participants may also contribute amounts representing distributions from other qualified plans (rollovers)

The Plan provides for discretionary employer matching and nonelective contributions. During 2024, the Company contributed discretionary matching contributions equal to 50% of the first 4% that a participant contributed to the Plan. Total employer matching contributions amounted to \$109,249 for the year ended December 31, 2024. There were not discretionary nonelective contributions for the year ended December 31, 2024.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings, reduced by withdrawals and certain administrative fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' voluntary contributions and rollovers plus actual earnings thereon immediately vest. Vesting in the employer contribution portion of their accounts is based upon years of credited service.

Notes receivable from participants

A participant may borrow from their account an amount not in excess of fifty percent of the participant's vested interest or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment and participant loan accounts. The loans are secured by the balance in the participant's account and bear interest at prime plus two percent. Principal and interest is paid ratably not less frequently than quarterly. If loan payments are not made in accordance with the terms of the loan, a deemed distribution may occur in the amount of the unpaid loan balance.

Payment of benefits

Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, installment or partial payments.

Forfeited accounts

Forfeitures may be used to reduce employer contributions, reallocated as additional employer contributions or used to pay Plan expenses. At December 31, 2024, and 2023 forfeited nonvested accounts totaled \$19,855 and \$14,115, respectively. In 2025, subsequent to year end, forfeitures of \$19,456 were used to reduce the 2024 plan year employer contribution

Plan expenses

Expenses of maintaining the Plan are generally paid by the Company. The Plan provides that administrative expenses not paid by the Company are charged to the Plan. Fees charged to the Plan totaled \$4,087 for the year ended December 31, 2024.

Note B.

Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions

Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses incurred for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in the net change in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Note C.
Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

The Plan management has adopted the provision of ASU 2015-07 which removes the requirement to categorize within the fair value hierarchy investments for which fair values are estimated using the net asset value ("NAV") as a practical expedient.

The following is a description of the valuation methodologies used at December 31, 2024 and 2023.

Pooled separate accounts:

Valued at the NAV of shares held by the Plan at year end. Investments in pooled separate accounts are stated at the corresponding unit value of the pooled separate account. The estimated fair value of pooled separate accounts are based on the fair value of the underlying assets owned by the pooled separate account and are generally based on observable inputs. Assets within the pooled separate accounts include: fixed maturity securities, equity securities and cash and cash equivalents.

The preceding method might produce a fair value calculation that might not be indicative of current or future net realizable value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C.

Fair Value Measurements (Continued)

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

Note D.

Guaranteed Investment Contract with Insurance Company

During 2019, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company ("Minnesota Life"). Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events, such as termination of the contract, spin-offs, layoffs, corporate relocation, plan termination, or the liberalization of plan withdrawal provisions, may limit the ability of the Plan to transact at contract value. If such an event occurs and a market value adjustment applies, the Plan sponsor may elect to pay the adjustment directly so that participants' contract values are not affected. Transfers between funds are generally allowed; however, if the Plan offers competing investment options, transfers from the guaranteed investment contract to such options may be subject to equity wash provisions (e.g., a 90-day waiting period).

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$29,605 and \$136,724, respectively. The crediting interest rate is determined quarterly by Minnesota Life and may not be less than 0.25% annually after reduction for contract asset charges (the gross crediting rate will not be less than 1.0% annually).

Note F.
Party-In-Interest Transactions

Effective January 1, 2024, the Plan investments are held and managed by The Standard Insurance Company, the trustee; therefore, these investment transactions qualify as exempt party-in-interest transactions. Prior to January 1, 2024, the Plan investments were held and managed by Minnesota Life Insurance Company, the trustee. Therefore, these investment transactions qualify as party-in-interest.

Note G.
Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all amounts credited to their accounts.

**Note H.
Income Tax Status**

The sponsor of the pre-approved Plan has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the form of the Plan was in compliance with applicable requirements of the Internal Revenue Code (“IRC”) and that an employer that adopts this Plan may rely on the letter with respect to the qualification of its Plan under Code section 401(a). The Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note I.
Risk and Uncertainties**

The Plan invests in various investment securities which are in general exposed to various risks, such as market and credit risks. Because of the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
