### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cornell Dubilier Electronics, Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

### Note 1—Description of the Plan

The following description of the Plan Sponsor's 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

*General* – The Plan was a defined contribution plan covering all non-union and union employees ("participants") of Cornell Dubilier Electronics, Inc. (the Company or Plan Sponsor), and its affiliate, Cornell Dubilier Marketing, Inc. who had completed three months of service and attained age 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective October 31, 2023, the Plan Sponsor was acquired by an unrelated party, and the Plan began a termination process that concluded at December 31, 2024. Upon acquisition, all participants became fully vested and no further contributions were made. All participants were notified of the formal termination of the Plan effective April 1, 2024, and were required to take a distribution, of which an option was provided to rollover the funds to the acquiring company's retirement plan in accordance with that plan's rollover provisions. All participants divested from the Plan through distributions and the Plan was fully closed out as of December 31, 2024.

*Contributions* – Eligible participants could elect to contribute a portion of their compensation to the Plan, subject to the Internal Revenue Code ("IRC") limitations for 401(k) plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could also contribute amounts representing distributions from other qualified plans. Such contributions, if any, were recorded as rollover contributions in the accompanying financial statements. The Plan was amended effective January 1, 2019, to allow Roth rollovers. Matching contributions were made at the discretion of the Company's Board of Directors. The Company would make a matching contribution equal to 35% of participant contributions, up to a maximum of 6% of compensation. The discretionary matching Company contribution was invested in the same investment options and in the same ratio as the participants have directed their own investments. Company contributions were typically funded when the employee contributions were funded and were subject to certain limitations under the IRC. An additional profit-sharing amount could be contributed at the discretion of the Company's Board of Directors. No additional discretionary profit-sharing contributions were made for the year ended December 31, 2024.

*Participant Accounts* – Each participant's account was credited with (a) the participant's contribution, (b) the Company's contributions, if any, and (c) an allocation of the Plan's earnings. Each participant's account was charged with participant withdrawals and an allocation of Plan losses and administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

*Vesting* – All participant contributions made to the Plan were fully vested at all times and were not subject to forfeiture for any reason. Effective October 31, 2023, when the Plan began the termination process, all participants became fully vested in all employer contributions.

*Payment of Benefits* – Withdrawals were made on a lump-sum basis or at the participant's option as a deferred annuity upon retirement, disability, termination, or proof of hardship. If death occurred prior to retirement, the participant's account was paid to the designated beneficiary.

*Forfeitures* – Forfeitures were created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures could be used to reduce employer contributions or administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$2, respectively. For the year ended December 31, 2024, \$7,914 in forfeitures were used to pay administrative expenses.

### Note 1—Description of the Plan (continued)

*Hardship Withdrawals* – The Plan allowed participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant could request a hardship withdrawal for certain qualifying expenses as defined by the Plan document, and within what the Internal Revenue Service (“IRS”) deems an immediate and financial need of the participant.

*Administration* – Under the terms of a Plan Services Agreement between Voya Retirement Insurance and Annuity Company and the Plan, Voya Retirement Insurance and Annuity Company provided the participant recordkeeping and other related services. All monies contributed to the Plan were forwarded to Voya Institutional Trust Company (the “Trustee”) and invested in various funds as designated by the participant.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – As stated in Note 1, the governing body of the Plan approved a plan of liquidation on April 1, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements.

*Use of Estimates* – The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator and the Company to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value. Actual results, as determined at a later date, could differ from those estimates.

*Administrative Expenses* – Professional and other fees of the Plan were typically paid by the Company; however, the Plan was allowed to pay for such expenses. For the year ended December 31, 2024, the administrative expenses paid by the Plan were \$17,113. Personnel and facilities of the Company were used by the Plan for its accounting and other activities at no cost to the Plan.

*Investment Valuation and Income Recognition* – The Plan’s investments are stated at fair value except for the guaranteed investment contracts which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Guaranteed investment contracts held by defined contribution plans are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive guaranteed investment contracts since contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits present the contract value of the guaranteed investment contracts. The statement of changes in net assets available for benefits was also prepared on a contract value basis. See Note 4 for discussion of fully benefit-responsive guaranteed investment contracts.

Management fees and operating expenses charged to the Plan for investments in guaranteed investment contracts and mutual fund accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Note 2—Summary of significant accounting policies (continued)**

*Investment Options* – Upon enrollment in the Plan, a participant could direct employee and Employer contributions in any of the investment options offered by the Plan.

*Payment of Benefits* – Benefits are recorded when paid.

*Risks and Uncertainties* – Investment securities, in general, are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

*Excess Contributions Payable* – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the subsequent year.

**Note 3—Fair value measurements**

*Fair Value Measurements* – The Plan follows the fair value measurements topic of the Financial Accounting Standards Board Accounting Standards Codification 820, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date,

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is calculated using quoted prices available in active markets and classified at Level 1 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4—Guaranteed investment contract**

The Plan had fully benefit-responsive investment contracts with the Trustee, which maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer was contractually obligated to repay the principal and interest at a specified rate that was guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contracts were fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Consequently, the investment was stated at contract value on the statements of net assets available for benefits and was not included within the fair value hierarchy. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Prior to termination of the Plan, certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. As the Plan has terminated and closed down as of December 31, 2024, the contract has also been terminated in accordance with the contract terms.

#### **Note 5—Information certified by the Trustee (unaudited)**

The Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, the qualified institution has certified to the completeness and accuracy of the following data included in the accompanying financial statements.

- Investments, at fair value and guaranteed investment contracts, at contract value as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest on guaranteed investment contracts as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### **Note 6—Party-in-interest transactions**

Certain Plan investments are shares of mutual funds and a guaranteed investment contract managed by an affiliate of Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the Trustee as defined by the Plan and, therefore, those transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction in the net gain (loss) from investment activity.

#### **Note 7—Plan termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. As disclosed in Note 1, the Plan has been terminated and all participants became 100% vested in the Company's matching portion of their accounts.

#### **Note 8—Tax status**

The Plan obtained an opinion letter, dated June 30, 2020, from the IRS stating the Plan was designed in accordance with applicable sections of the IRC. The Plan was amended, revised, and restated since the date of the opinion letter. However, the Plan administrator believed the Plan, as amended, revised, and restated, remained in accordance with the applicable requirements of the IRC and had no income subject to unrelated business income tax and, therefore, the Plan and related trust continued to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.
