



**Eligibility Requirements\*:** Years of Service: 1  
Minimum Age: 21

**Contribution Credits:** A Participant's Cash Balance Account will be credited with the following Contribution Credits:

Mark M. Leyngold	100,000
All other Participants	Meaningful Benefit

**Normal Retirement Age:** Later of age 62 or the 5th anniversary of the date he commenced participation in the Plan, whichever is later.

**Accrued Benefit:** The amount in each participant's Cash Balance Account as of the date of separation from employment.

**Ancillary Benefits:**

1. Pre-Retirement Death Benefit: Cash Balance Account
2. Disability Benefit: Cash Balance Account

**Vesting:** 3-Year cliff

**Normal Form of Payment:** Life annuity

**Benefits Not Included in the Valuation:** None
