For the plan year 01/01/2024 through 12/31/2024

Effective for the 2024 plan year, the Plan changed the accounting basis used for Form 5500-SF Part III (Financial Information) from cash basis (used for the 2023 filing) to accrual basis (used for the 2024 filing).

The beginning-of-year balances for 2024 equal the end-of-year balances for 2023, as filed. No changes to the beginning 2024 balances were made to include previously unreported 2023 receivable contributions.

Because the 2023 filing was on cash basis, certain amounts received in 2024 that relate to the 2023 plan year were not reported in 2023. To preserve the integrity of the 2024 roll-forward, those amounts are included in the 2024 contributions lines solely as a one-time conversion item. The one-time conversion amounts included in 2024 contributions are as follows:

- Line 8a(1) — Employer contributions: \$586 relates to the 2023 plan year and was received in 2024.
- Line 8a(2) — Participant contributions: \$15,159 relates to the 2023 plan year and was received in 2024.

These items were not reported on the 2023 cash-basis Form 5500-SF and are disclosed here to explain their inclusion in 2024. Other 2024 financial statement amounts are presented in accordance with accrual-basis reporting.

Moving forward, beginning with the 2025 Form 5500-SF and thereafter, the Plan will continue to report on the accrual basis and will exclude prior-year-designated contributions from current-year contribution lines. Such amounts, if any, will be recognized as receivables at the prior year-end, consistent with accrual accounting.



