**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Earthlink 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that covers all eligible employees of Earthlink, LLC and its subsidiaries (“the Company”) except leased employees, temporary employees and independent contractors. New employees must complete two months of service and must be at least 18 years of age to become eligible to enter the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may elect to contribute up to 100% of compensation to the Plan through salary reduction. Plan participants may make pre-tax and/or Roth contributions of up to 100% of eligible compensation, as defined in the Plan document, not to exceed a maximum of \$23,000 in 2024, plus up to an additional \$7,500 catch-up deferral for participants who have reached at least 50 years of age by the end of the year. The Plan also allows rollover contributions.

The Company makes a safe harbor matching contribution up to 100% of the first 3% of eligible compensation and an additional 50% of eligible compensation that exceeds 3% but does not exceed 5% of eligible compensation.

The Company may make a discretionary contribution to the Plan in the form of an additional employer match or profit-sharing contribution. Additional employer match contributions are allocated based on a uniform percentage of matched employer contributions up to 4% of participant compensation and up to an elective deferral of 6% of participant compensation. Profit sharing contributions are allocated based on a participant's eligible compensation in relation to total Plan compensation. Participants must be employed on the last day of the plan year, except for participants who become disabled, die, or retire in the Plan year to receive discretionary contributions. The Company did not make an additional employer match or profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts: Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contribution, match, and discretionary contributions and plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments: Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Payment of Benefits: On termination of service, a participant may elect to receive a lump sum amount equal to the value of their account. There is a mandatory distribution of amounts not exceeding \$5,000. In the event of a mandatory distribution and if a distribution election is not made within the required timeframe, then that account will be rolled over into an IRA and invested in an investment designed to preserve principal and provide a reasonable rate of return. In certain circumstances, participants may make “hardship withdrawals” as defined by the Plan. Active participants may also take distributions from the Plan upon attainment of age 65.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. All safe harbor contributions are immediately vested plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as listed below.

Forfeited Accounts: When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account as defined by the Plan represents a forfeiture. The plan document permits the use of forfeitures to reduce plan administrative expenses, reduce future employer contributions for the Plan year, or to be added to future employer contributions. As of December 31, 2024, there was no balance in the forfeiture account. During the year ended December 31, 2024, no administrative fees were paid from the forfeiture account.

Notes Receivable from Participants: Plan participants may borrow from their account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. The loans are secured by the balance in the participant's account and bear interest. Principal and interest are paid through payroll deductions in level installments for period ranging up to 5 years, or longer for the purchase of a primary residence, in which case the period will be determined at the time the note is made. The notes bear interest at prime plus 1% at the date of the note plus accrued interest. The Plan allows participants to have 2 loans outstanding, 1 general purpose loan and 1 principal residence loan.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from the estimates.

Risk and Uncertainties: The Plan provides various investment options to its participants. Investments securities, in general, are exposed to various risks such as interest rate, market, liquidity, and credit risks as well as risks associated with global events. Due to the level of risk associated with certain investments, and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits: Benefits payments to participants are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive contracts are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 4 for a discussion of fair value measurements. Contract value is the relevant measure for the Plan's fully-benefit responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. See Note 6 for a discussion of contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events: Subsequent events were evaluated through September 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

#### NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts, other than stable value collective trust, are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Additionally, the plan holds one collective trust that is not a direct filling entity, and the trust seeks an investment return that approximates as closely as practicable, before expenses, the performance of the Nasdaq-100 Index over the long term.

**NOTE 5 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Actual fees paid by the Plan for recordkeeping services qualify as part-in-interest transactions. Such costs are included in administrative expenses in the accompanying financial statements. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Notes receivable from participants held by the Plan are also considered party-in-interest transactions.

**NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contract is presented below:

Traditional Guaranteed Investment Contract: The Plan holds a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in its general account. Empower guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 0%. Empower's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which Empower may terminate the contract. Examples of circumstances which would allow Empower to terminate the contract include the Plan's loss of its qualified status, uncured material breached of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, Empower could terminate the contact at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not possible.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would receive their vested account balance, less applicable costs.

**NOTE 8 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 1, 2021 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to potential audit for tax periods prior to 2022.

**NOTE 8 – PLAN TRANSFER**

On January 2, 2024, the assets of Telegia Communications, Inc. 401(k) Plan were transferred into the Plan subsequent to the Company's acquisition of its plan sponsor. The transfer of \$415,288 in plan assets is included in "plan transfers" on the statement of changes in net assets for the year ended December 31, 2024.

On February 9, 2024, the assets of the One Ring Networks Inc. 401(k) Profit Sharing Plan & Trust were transferred into the Plan subsequent to the Company's acquisition of its plan sponsor. The transfer of \$2,889,465 in plan assets is included in "plan transfers" on the statement of changes in net assets for the year ended December 31, 2024.
