## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of CBA Transition Holdings, LLC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of CBA Transition Holdings, LLC 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CBA Transition Holdings, LLC 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1: DESCRIPTION OF THE PLAN

General

The CBA Transition Holdings, LLC 401(k) Plan (the "Plan") was adopted effective January 1, 2023 as a defined contribution plan covering all of the eligible employees of CBA Transition Holdings, LLC. (the "Company", or "Plan Sponsor"). The Plan is a qualified plan as defined by Section 401(a) of the Internal Revenue Code and contains a provision for salary reduction contributions under Section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective July 1, 2024, the Plan changed trustees from Lincoln National Life Insurance Company to Transamerica Retirement Solutions.

Eligibility

Employees who had attained the age of 21 are eligible to participate in the Plan after completing 320 hours of service in a two month period of employment. Employees are eligible to participate in the Plan as of the first entry date based on when the minimum age and hours of service are met. Entry dates are January 1, April 1, July 1 and October 1.

Contributions

The Company automatically enrolls eligible participants into the plan at a pre-tax deferral contribution of 3% of that participant's eligible compensation. The Company will also automatically increase participants' contribution by 1% annually up to 10% of their eligible compensation. Employees may elect to contribute 100% of their eligible compensation to the Plan and may direct their contributions to various investment alternatives. Contributions for employees are limited in any calendar year to an amount which is adjusted annually by the Internal Revenue Service. For 2024, the maximum contribution allowed for any employee was \$23,000. Additionally, participants who attain age 50 during the plan year may make "catch up" contributions of up to \$7,500 for 2024. Participants may also contribute amounts representing distributions transferred from other qualified plans.

The Company makes a safe harbor match of 100% of an employee's contribution up to 4%. The total amount of employer match contributions were \$302,406 for the year ended December 31, 2024.

NOTE 1: DESCRIPTION OF THE PLAN *(Continued)*

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) the Company's contribution and (b) investment gain(loss), net of expenses. Income for each of the investment directives is allocated to the participant's accounts on a daily basis and is based on the relative units of participation. Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

Vesting and Payment of Benefits

Participants are immediately vested in safe harbor match contributions, their own contributions, plus any earnings thereon. The normal retirement age under the Plan is 65, however, benefits may be distributed during employment under hardship provisions. Additionally, participants who have attained the age of 59 ½ may receive distributions during employment. If death or disability occurs during employment, an employee's entire account becomes fully vested. Participants generally receive distributions in a lump sum. Installments are required for employees over 70 ½ to meet the minimum distribution requirements of Internal Revenue Code regulations. Separating participants may elect to rollover their account into another plan, as permitted by Internal Revenue Service regulations.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation

The accompanying financial statements of the Plan are presented in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported changes in net assets during the reporting period. Actual results could differ from those estimates.

Investments

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, all investment information disclosed in the accompanying financial statements and supplementary schedules, including investments held from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year then ended were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Transamerica Retirement Solutions ("Transamerica"), the custodian of the Plan.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(Continued)*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis.

NOTE 3: FEDERAL INCOME TAXES

Effective January 1, 2023, the Plan adopted a "prototype non-standardized" plan document prepared by Lincoln, the Plan's investment custodian (See Note 6). Under Internal Revenue Service Announcement 2001-77, when such providers receive a favorable determination letter from the Internal Revenue Service regarding the qualification of the Plan document for tax exempt status, an adopting Plan may rely on this opinion letter. The Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested.

NOTE 5: RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investments and are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that reduction in value can occur in the near term and that such changes could materially affect participant account balances reported in the statement of net assets available for benefits.

NOTE 6: ADMINISTRATION AND INVESTMENTS

Administration

January 1, 2024 through June 30, 2024, the Plan's investments were administered by Lincoln National Life Insurance Company ("Lincoln"), the custodian of the plan. Among other duties, Lincoln receives contributions, invests and reinvests the Plan's assets, collects income and makes distributions from the Plan's assets as directed by the Administrative Committee for the Plan.

NOTE 6: ADMINISTRATION AND INVESTMENTS *(Continued)*

On July 1, 2024 the Administrative Committee of CBA Transition Holdings, LLC 401(k) Plan approved and transferred the assets into Transamerica Retirement Solutions (“Transamerica”). On July 1, 2024 through December 31, 2024, the Plan’s investments were administered by Transamerica, the trustee of the plan. Among other duties, Transamerica receives contributions, invests and reinvests the Plan’s assets, collects income and makes distributions from the Plan’s assets as directed by the Administrative Committee for the Plan.

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Plan does not compensate the Plan Sponsor for its internal costs related to the administration of the Plan.

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, Lincoln certified that the accompanying investment balance and income information for the year ended December 31, 2023 and from January 1, 2024 through June 30, 2024 was complete and accurate. Transamerica certified that the accompany investment balances as of December 31, 2024 and income information from July 1, 2024 through December 31, 2024 were complete and accurate. Accordingly, the Plan’s independent auditors did not perform any procedures with respect to this information, except comparing and reconciling such information to the financial statements.

NOTE 7: FAIR VALUE MEASUREMENTS

ASC 820-10 provides standards and disclosures for assets and liabilities that are measured and reported at fair value. As defined in ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). ASC 820-10 requires disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements. The statement requires fair value measurements to be classified and disclosed in one of the following categories:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

NOTE 7: FAIR VALUE MEASUREMENTS *(Continued)*

Level 2: Measured based upon inputs that are observable, either directly or indirectly, for the asset or liability other than quoted market prices included in Level 1. These inputs include: a) quoted prices for similar asset or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in markets that are not active c) inputs other than quoted market prices that are observable and d) inputs that are derived primarily from or corroborated by observable market data by correlation or other means.

Level 3: Measured based on unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. This input includes management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. The inputs are developed based on the best information available in the circumstances, which might include management's own data.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed Investment Contracts:* Guaranteed Investment Contracts are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

As required by ASC 820-10, financial assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels.

NOTE 8: RELATED PARTY TRANSACTIONS

As of December 31, 2024, the Plan invests in mutual funds that are managed by Transamerica who is also the custodian for the Plan. During the year ended December 31, 2024, the Plan paid Lincoln \$26,401 and Transamerica \$5,922, in administration fees that are included in administrative expenses. The Plan believes the fees charged by Transamerica mutual funds and its administrative fees are no different than those that would be charged by other companies engaged in managing pension assets.

NOTE 9: INCOME TAXES

The Plan did not have any unrecognized tax benefits as of December 31, 2024 2023, and expects no significant change over the next 12 months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2024 and 2023, the Plan has not accrued interest or penalties related to uncertain tax positions.

NOTE 10: SUBSEQUENT EVENTS

Management evaluated the period from January 1, 2025 through September 12, 2025, which was the date the financial statements were available to be issued.
