## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Wells Brothers, Inc./Panel Control Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for the benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## WELLS BROTHERS, INC./PANEL CONTROL INC. 401(K) PLAN

Notes to Financial Statements  
Years Ended December 31, 2024 and 2023

### NOTE A - DESCRIPTION OF PLAN

The following description of the Wells Brothers, Inc./Panel Control Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan established by Wells Brothers, Inc. and Panel Control Inc. (the “Company”) covering all employees at least eighteen years of age who have completed ninety days of service, beginning on the employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers eligible employees of Wells Brothers, Inc. and Panel Control Inc.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and up to allowed Federal limits. Participants may contribute as pretax or after-tax (Roth). Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and an insurance investment contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The Company may make discretionary matching contributions to the Plan. The Company may also make profit sharing contributions to the Plan in the years and in the amounts determined each year by the managing body of the Company. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of the Company’s Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer discretionary and matching contributions and the earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

## **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

### **Payment of Benefits**

On termination of service due to death, disability, or retirement; a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance or partial payments (payments of a portion of the participant's account that are not regularly scheduled). In addition, hardship distributions are permitted if certain criteria are met.

The Plan has adopted the automatic rollover provisions as provided in Internal Revenue Notice 2005-5. In accordance with the SECURE 2.0 Act of 2022, the Plan has administratively implemented an increase in the involuntary cash-out threshold from \$5,000 to \$7,000, effective for distributions made on or after January 1, 2024. Although the formal plan amendment reflecting this change has not yet been executed, the Company intends to adopt a conforming amendment within the remedial amendment period.

### **Notes Receivable from Participants**

The Plan is designed to help participants save for retirement and does not allow a participant to take a loan from the participant's account under the Plan.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,519 and \$75, respectively. These accounts may be used to pay the Plan's administrative expenses. Forfeitures may also be used to reduce future employer contributions to the Plan. During the years ending December 31, 2024 and 2023, the amount of forfeitures paid from the forfeitures account to cover the Plan's administrative expenses were \$8,209 and \$5,200, respectively. During the years ending December 31, 2024 and 2023, the amount of forfeitures used to reduce employer contributions was \$0 and \$27,804, respectively.

### **Plan Amendment**

Effective January 1, 2023, the Plan was amended such that eligibility is obtained when the employee attains age eighteen and has completed ninety days of service.

Effective July 1, 2024, the Plan was amended such that (1) the automatic enrollment percentage was increased from 3% to 6%, (2) the automatic escalation provision increased from a maximum of 6% to a maximum of 10%, and (3) all participants without an existing affirmative election or whose affirmative election is less than 6% were increased to 6%.

## **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company, and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions from participants' accounts are charged directly to the participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Effective January 1, 2025, the Plan was amended such that Panel Control, Inc. was removed from the Plan's controlled group.

The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

## NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li></ul>

- inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Investment in Pooled Separate Accounts:* Consist of various accounts valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The net asset value is used as a practical expedient to estimate fair value.

## **NOTE D – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with VOYA Insurance Company, totaling \$156,940 and \$161,916 at December 31, 2024 and 2023, respectively. VOYA Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer. The credit rates are reviewed for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that would also limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

## **NOTE E – PARTY-IN-INTEREST AND PROHIBITED TRANSACTIONS**

Certain Plan investments are pooled separate accounts managed by the VOYA Retirement Insurance and Annuity Company. At December 31, 2024 and 2023, the Voya Retirement Insurance and Annuity Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

During the plan year ended December 31, 2024, the Company remitted \$87,912 of employee contributions withheld from participant paychecks after the Department of Labor's prescribed deadline. These contributions were deposited after the earliest date on which they could reasonably have been segregated from the Company's general assets. As a result, the Company is deemed to have committed a prohibited transaction under ERISA Section 406 and IRC Section 4975. The Company has self-corrected this issue outside of the DOL's Voluntary Fiduciary Correction Program (VFCP) by:

- Calculating and restoring lost earnings to affected participant accounts, and
- Filing IRS Form 5330 and paying the applicable excise tax under Internal Revenue Code Section 4975.

## NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

## NOTE G - TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## NOTE I – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of accrual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, Voya Retirement Insurance and Annuity Company, has certified that the investment information included in the accompanying financial statements and supplemental schedules is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.
