### **NOTE A -- Description of plan and significant accounting policies**

The following description of SMS Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Shared Medical Services, Inc. (the employer and plan sponsor) has adopted the FMR, LLC's Non-Standardized Pre-Approved Profit-Sharing Plan, effective October 26, 2021. The Plan was originally established on January 1, 1994.

#### **General**

The Plan is a defined-contribution profit sharing plan with elective deferral 401(k) features covering employees of the employer who have completed six months of service and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Overview Committee oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 41-1388075, and the Plan's number is 001.

#### **Contributions**

Participants may contribute at least 1%, but not to exceed 50%, of pretax or post-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

For 2024, the employer's contribution was a safe harbor matching contribution of 100% of the participant's deferral amount up to 4% of the participant's eligible compensation. Additional amounts may be contributed at the option of the employer's Board of Directors. These additional contributions are allocated pro-rata based on a participant's eligible compensation to the total eligible compensation of all participants.

The plan sponsor has established the Shared Medical Services Employee Stock Option Plan (ESOP). Effective April 15, 2012, an amendment was adopted to allow the plan sponsor to make its safe harbor matching contributions to the ESOP. The safe harbor matching contribution for the year ended December 31, 2024, totaling \$1,050,549 was made to the ESOP.

Participant contributions and total combined contributions to the Plan and the ESOP are subject to certain limitations defined by the Internal Revenue Service (IRS).

#### **Participant accounts and "rollovers"**

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account, which includes employer's matching and discretionary contributions prior to 2013. The Plan permits the rollover of funds from other qualified plans to a participant's account.

#### **Vesting**

Participants are immediately vested in their contributions and the employer's matching and discretionary contributions, made prior to 2013, plus actual earnings thereon. Effective April 15, 2012, an amendment was adopted to allow the plan sponsor to make safe harbor matching contributions to the ESOP plan. Participants are immediately vested in these contributions.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with the local prevailing rates as determined annually by the plan administrator. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest is paid ratably through payroll deductions or payment to Fidelity Management Trust Company (Fidelity).

#### **Benefits**

On termination of service due to death, disability, retirement (age 59 ½), or other reasons, a participant may elect either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in monthly, quarterly or annual installment payments. The Plan permits in-service distributions at age 59 ½. A participant with an account valued at less than \$5,000 shall receive a lump sum distribution. A participant is fully vested upon death, disability or retirement. The Plan permits hardship distributions if certain criteria are met.

A summary of significant accounting policies follows:

#### **Basis of accounting**

The financial statements of the Plan are prepared in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

#### **Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Overview Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Administrative expenses**

The Plan sponsor and employer pay some of the administrative expenses of the Plan, which are excluded from these financial statements. The major administrative expenses are payroll and related expenses.

#### **Notes receivable from participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

#### **Subsequent Events**

These financial statements have not been updated for subsequent events occurring after September 15, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after that date.

### **NOTE B -- Information certified by the asset custodian and trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest, dividends, other income, net appreciation, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity, the asset custodian and trustee of the Plan.

### **NOTE C -- Party-in-interest transactions**

Certain Plan investments are managed by Fidelity. Fidelity is the trustee, asset custodian, and recordkeeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreements (MSA) between the employer and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

### NOTE C -- Party-in-interest transactions (Continued)

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts will be allocated to the accounts of the participants. During 2024, excess amounts totaled \$71,172 and are recorded as other income on the Statement of Changes in Net Assets Available for Benefits. The Plan or plan sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

Fees were also paid by the Plan during the year for advisory services rendered by Strategic Advisors, Inc. These transactions also qualify as party-in-interest transactions.

### NOTE D -- Fair value measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

### NOTE D -- Fair value measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective investment fund. A fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

### **NOTE F -- Tax status**

The FMR LLC's Non-Standardized Pre-Approved Profit Sharing Plan, referred to in Note A, that the Plan has adopted effective October 26, 2021, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

### **NOTE G -- Concentration of market risks**

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

### **NOTE H -- Plan amendments**

Effective November 3, 2023, the Plan was amended to allow participants to make post-tax (Roth) deferral contributions to the Plan.
