### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of InterCambio Express Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**General:** The Plan is a defined contribution plan covering substantially all employees of InterCambio Express, Inc. and Torres Enterprises Corporation (collectively, the Company). Employees must have attained the age of 21, completed 12 months of service and 1,000 hours to be eligible to participate in the Plan. An employee may enroll in the Plan on the first day of the subsequent quarter after which the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, a participant may contribute a percentage of pre-tax and/or post-tax annual compensation as defined by the Plan, up to the maximum amount allowed by the Internal Revenue Service (IRS). Participant may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct these contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution and may make a discretionary profit-sharing contribution to the Plan. The Company made a safe harbor matching contribution of 100% of the first 3% of a participant's compensation and 50% on the next 2% of a participant's compensation and elected not to make a profit-sharing contribution for the year ended December 31, 2024. The Company's safe harbor and profit-sharing contributions are invested into the various investment options in a manner that is consistent with the participant contributions.

**Participant accounts:** Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions, (b) Plan earnings, and charged with an allocation of certain administrative expenses. Allocations are based on participant account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are also immediately vested in any safe harbor matching contributions and discretionary profit sharing contributions upon entering the Plan.

**Investment options:** Upon enrollment in the Plan, a participant may direct employee and employer contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

**Administration of plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Certain administrative expenses are paid by the Plan sponsor and, therefore, are not reflected in the Plan's financial statements.

**Payment of benefits:** Upon termination of service, death, total and permanent disability, or retirement, a participant or his or her beneficiary is eligible to receive an amount equal to the value of the participant's account in the form of a lump-sum distribution, as described in the Plan agreement.

**Forfeitures:** Forfeitures may be used to pay administrative expenses or reduce the Company contributions. There were no forfeitures at December 31, 2024 or 2023. No forfeited amounts were used to reduce the employer safe harbor matching contribution or pay administrative fees during the year ended December 31, 2024.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Payment of benefits:** Benefits are recorded when paid.

**Fair value measurements:** Accounting standards establish a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### Note 2. Significant Accounting Policies (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of pooled separate accounts:** Valued as the total of the net asset value (NAV) (as a practical expedient) of shares of underlying investments held by the account at year-end. The Plan's interest in the pooled separate accounts is valued based on the information reported by the investment advisor. This practical expedient is not to be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**Common/collective trust:** Valued based on the NAV of units of the common collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not to be used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

**Subsequent events:** The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through September 12, 2025, the date the financial statements were available to be issued.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. #### Note 5. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to discontinue their contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **Note 6. Related-Party Transactions**

Certain plan investments were managed by John Hancock. John Hancock was the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services provided by the parties-in-interest amounted to approximately \$39,000 for the year ended December 31, 2024.

#### **Note 7. Tax Status**

The Plan has adopted a volume submitter plan sponsored by Crowe LLP. The volume submitter plan has received an opinion letter from the IRS dated June 30, 2020 as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan has since been amended. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan's administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is not subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

#### **Note 8. Delinquent Contributions**

During the year ended December 31, 2023, the Plan inadvertently failed to deposit \$2,956 respectively of participant contributions within the required timeframe as required by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. Due to the appreciation of Plan investments, there were \$29 of lost earnings associated with the 2023 delinquent contributions. The Plan sponsor remitted the lost earnings to correct the late deposits related to 2023.


