INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Rotschy, Inc. 401(K) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rotschy, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rotschy, Inc. 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – PLAN DESCRIPTION

The following description of the Rotschy, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement and the Summary Plan Description for a more complete description of the Plan's provisions.

General – The Plan is a 401(k) and prevailing wage rate defined contribution plan covering all employees of Rotschy, LLC. (the Company). The Company is the Plan's sponsor and serves as plan administrator. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility – Employees of the Company are eligible to participate in the Plan on the date of hire. With respect to employer matching contributions and employer profit sharing contributions, eligibility begins upon completing 6 consecutive months of employment. If 6 months of consecutive employment are not completed, employees are eligible after 1 year of service and 1,000 hours. However, with respect to prevailing wage contributions, eligibility begins on the date of hire.

Contributions – Each year, participants may contribute annual compensation, as defined in the Plan, not to exceed limits imposed by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employer discretionary and non-elective prevailing wage rate contributions are invested as directed by the participant. Contributions are subject to certain limitations and are tested annually to determine the amount, if any, of excess contributions required to be repaid to the participant.

Employer matching contributions are determined annually. The Company matched 100% of employee deferrals up to a maximum of 4% of participant's eligible wages for the years ended December 31, 2024 and 2023, respectively. The contribution made by the employer was offset by any prevailing wage contributions for those employees that are eligible to receive both types of contributions.

Participant Accounts – Each participant's account is credited with (a) the participant's contribution, (b) allocations of the Company's discretionary contributions and non-elective prevailing wage rate contributions, (c) Plan earnings, and (d) investment expense charges. Separate accounts are maintained for each participant by investment fund and type of contribution or allocation. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is that which can be provided from the participant's vested account.

NOTE 1 – PLAN DESCRIPTION (continued)

Vesting – Participants are immediately vested in their salary deferral contributions and prevailing wage contributions plus actual earnings thereon. Employer matching contributions and profit sharing contributions vest according to the following schedule.

Hardship Withdrawals and Notes Receivable from Participants – Participants may withdraw funds from the Plan if hardship criteria specified by the Plan are met. Loans may also be made to participants. Loans range from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the loan fund. Loan terms may not exceed 5 years or a longer term for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest of 3.25% to 8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions, or in the event of loan payoffs participants may make lump sum payments directly to the plan.

Forfeited Accounts – Forfeitures are available to offset plan expenses or to reduce employer match contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$-0-, respectively.

Investment Options – Upon enrollment in the Plan, a participant may direct contributions into a variety of investment options, which may be changed at the participant’s discretion either by written request, telephone, or via the internet.

Payment of Benefits – Upon termination of service due to death, disability or retirement, participants will receive lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installments over a specified time period not exceeding the participant’s individual or joint life expectancy.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 8 for discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Empower Select Guaranteed Fund is not fully benefit-responsive and as such is reported at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Management has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

NOTE 3 – PLAN ADMINISTRATION

The Plan has elected to use consultants to assist in the administration of the Plan, specifically for the performance of contribution limits and calculations ensuring compliance with ERISA for participation guidelines.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 5 – INFORMATION PREPARED AND CERTIFIED BY EMPOWER TRUST COMPANY

NOTE 6 – TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 7 – ADMINISTRATIVE COSTS

The Company has elected to absorb portions of the administrative costs of operating the Plan. The Plan paid administrative expenses for the years ended December 31, 2024 and 2023 totaling \$152,884 and \$121,935, respectively.

NOTE 8 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 “Fair Value Measurements”, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 8 – FAIR VALUE MEASUREMENTS (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered investment companies: Valued at the net asset value (NAV) of shares held by the Plan at year end. Investments are marked-to-market on a daily basis.

Group annuity contract: Group annuity contracts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 9 – RELATED PARTY TRANSACTIONS

Plan investments include shares of pooled separate accounts that invest in registered investment company funds and group annuity contracts managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company is the custodian of the Plan and, therefore, transactions with this entity qualify as exempt party-in-interest transactions.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
