At December 31, 2024 and 2023 and the Year Ended December 31, 2024

(1) Description of Plan

The following description of the Hyer Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of Rowell Chemical Corporation and Milport Enterprises, Inc. (collectively referred to as the "Company") who have completed six months of service and have attained age twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions. Participants may contribute up to the maximum dollar amount permitted by law. The employer matches 100% of the first 3% of compensation and 50% of the amounts in excess of 3%, not to exceed 5% of compensation. In addition, the employer may make a discretionary contribution each year. Such contributions are allocated among all participants. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocation of (a) Plan earnings and (b) employer match and discretionary contributions, as authorized. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of service.

Forfeitures. Forfeitures are used to pay plan expenses and reduce future discretionary employer contributions, if any. There were no forfeited unvested accounts at December 31, 2024 and 2023. There were no forfeitures during the year ended December 31, 2024.

Investment Options. Upon enrollment in the Plan, a participant may direct employee contributions and discretionary employer contributions, if any, in 1% increments in any of the Plan's investment options. Participants may change their current or future investment options periodically.

(1) Description of Plan, Continued

Payment of Benefits. On termination of service, a participant will receive a lump-sum amount equal to the value of his or her account.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1-5 years or up to 15 years for the purchase of a primary residence. These loans are collateralized by the balance in the participant's account and bear interest at prevailing rates as determined by the trustee. Principal and interest is paid through payroll deductions.

(2) Summary of Accounting Policies

The Plan's financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP"). The following is a summary of the significant accounting policies:

Subsequent Events. Management has evaluated all significant events occurring subsequent to the financial statements date through July 30, 2025, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements.

Estimates. The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Contributions are accrued and credited to participants' accounts as of each pay period.

Benefits. Benefit payments to participants are recorded when paid.

Party-In-Interest. Certain of the Plan's investments were offered by the Variable Annuity Life Insurance Company ("VALIC"), one of the Plan's trustees. These transactions qualify as party-in-interest.

Notes Receivable From Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

(2) Summary of Accounting Policies, Continued

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements. GAAP defines fair value, establishes a framework for measuring fair value and enhances disclosures about fair value measurements.

GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. GAAP also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. GAAP describes three levels of inputs that may be used to measure fair value:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities that are not active; and model-driven valuations whose inputs are observable or whose significant value drivers are observable. Valuations may be obtained from, or corroborated by, third-party pricing services.

Level 3: Unobservable inputs to measure fair value of assets and liabilities for which there is little, if any market activity at the measurement date, using reasonable inputs and assumptions based upon the best information at the time, to the extent that inputs are available without undue cost and effort.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

Fair Value Measurements, Continued.

Common Collective Trusts ("CCT"). CCTs represent investments with various investment managers. Units held in CCTs are valued at the unit value as reported by the investment managers.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(3) Investments

At December 31, 2024 and 2023 and for the year ending December 31, 2024, the Plan's investments were held by Bank of America ("BOA") and VALIC (together the "Trustees").

(5) Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated December 16, 1993, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Company's management believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Company has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(7) Related Party Transactions

The Company provides certain accounting, administrative and investment management services to the Plan for which no fees are charged.

(8) Risks and Uncertainties

The Plan has made available various investment options. These investment options are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' balances and the amounts reported in the statements of net assets available for benefit and the statement of changes in net assets available for benefits. The Plan permits every participant to direct the investment of their account balances under the Plan.
