My audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audits.

**(1) Description of the plan**

The following brief description of Elmington Property Management 401(k) Profit Sharing Plan & Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**(a) General**

The Plan is a defined contribution plan covering all full-time employees of Elmington Property Management (the “Plan Sponsor”) who are age twenty-one or older. The Plan, which was adopted by action of the Plan Sponsor’s Board of Directors on January 1, 2014, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2024, Elmington Residential and Elmington Elevates, Inc. ceased participation in the Plan and accordingly assets were transferred out of the Plan in 2024 in the amount of \$134,834.

**(b) Contributions**

Each year, participants may defer up to 100% of their pretax annual compensation as defined in the plan agreement as well as after-tax Roth contributions, not to exceed the maximum annual amount as determined by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor made a matching contribution equal to 50% of each participant’s elective deferrals not exceeding 6% of eligible compensation. The Plan Sponsor may also contribute an additional discretionary contribution amount each year. However, an additional discretionary contribution was not made for 2024 or 2023.

A Qualified Non-Elective Contribution (“QNEC”) was deposited to the Plan in 2024 totaling \$37,040. The QNEC corrected an operational mistake for the plan year ended December 31, 2022.

**(c) Participant accounts**

Each participant's account is credited with the participant's contributions and the Plan Sponsor’s contributions, as well as allocations of plan earnings or losses. Participant accounts may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

**(1) Description of the plan, continued**

**(d) Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's contribution portion of their account plus actual earnings (losses) thereon is based on years of continuous service. A participant becomes 20% vested after two years of service and vesting increases 20% each year until the participant is 100% vested after six years of credited service.

**(e) Payment of benefits**

On termination of service due to death, disability, retirement, or termination of service, a participant will receive a lump-sum or annuity distribution equal to the value of the participant's vested account.

**(f) Hardship withdrawals**

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to a participant's elective deferrals.

**(g) Forfeitures**

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor portion of their accounts. At December 31, 2024 and 2023, forfeited nonvested accounts available for future use totaled \$38,618 and \$99,789, respectively. Forfeitures totaling \$212,373 were used in 2024 to reduce Plan Sponsor contributions to the Plan.

**(h) Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rates, as determined by the plan administrator, range from 7.25% to 9.50% and are commensurate with local prevailing rates. Principal and interest are collected ratably through payroll deductions.

**(2) Summary of significant accounting policies**

**(a) Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**(b) Payment of benefits**

Benefits are recorded when paid.

**(c) Investment valuation and income recognition**

The Plan's investments are stated at fair value as reported by the custodian, except for fully benefit-responsive investment contracts, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**(d) Contributions**

Contributions from plan participants and any respective matching contributions from the Plan Sponsor, if applicable, are recorded in the year in which the employee contributions are withheld from compensation.

**(e) Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions are charged directly to the participant's account and are included in administrative expenses. The Plan holds assets in an expense balance account which receives deposits as a result of a revenue sharing agreement with a party-in-interest to the Plan. During 2024, deposits to the account were netted with administrative expenses and used to pay qualified plan expenses. See Note 5 for further disclosure.

**(f) Use of estimates**

The preparation of financial statements in accordance with U.S. generally accepted accounting principles ("GAAP") requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(g) Events occurring after the reporting date**

The Plan has performed an analysis of the activities and transactions subsequent to December 31, 2024, to determine the need for any adjustments or disclosures for the year then ended. The Plan has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

**(h) Excess contributions payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction from net assets. The payable as of December 31, 2024 and 2023 reflect amounts refundable to affected participants in 2025 and 2024, respectively.

**(h) Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**(3) Summary of information certified by the custodian**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of the date of the financial statements under audit and covered by the certification, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (“Empower”), the custodian of the Plan as of December 31, 2024 and 2023.

**(4) Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

**Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.**

**Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:**

- (a) Quoted prices for similar assets or liabilities in active markets;**
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;**
- (c) Inputs other than quoted prices that are observable for the asset or liability; and**

**(d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the assets or liability.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled separate accounts* (“PSAs”) are valued at the net asset value (“NAV”) of units held by the account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value and is based on the value of the underlying investments held through sub-accounts of a separate account of an insurance company. The practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. PSAs are comprised primarily of shares of mutual funds held through sub-accounts of an insurance company and seek to mirror the investment objectives and strategies of the underlying mutual fund for which the PSA is named. Certain PSAs are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date.

The investments are redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. Were the Plan to initiate a full redemption of a PSA, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner. There are currently no redemption restrictions or unfunded commitments on these investments.

**(5) Related party and party-in-interest transactions**

Certain plan investments are managed by Empower. Empower is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to an agreement between the Plan Sponsor and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the agreement, Empower remits the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay the Plan’s administrative expenses or allocated to the accounts of the participants.

During the plan year, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Empower for administrative expenses not covered by revenue sharing.

**(5) Related party and party-in-interest transactions, continued**

Certain administrative functions are performed by officers or employees of the Plan Sponsor and no such officer or employee receives compensation from the Plan.

Administrative expenses paid to the custodian and other parties-in-interest amounted to \$26,284 and \$11,028 for 2024 and 2023, respectively. The Plan Sponsor also pays for certain plan expenses for which it is not reimbursed by the Plan.

**(6) Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. The Plan has submitted a request to the Internal Revenue Service (“IRS”) to determine if a partial plan termination (“PPT”) occurred in a prior year. If the IRS determines a PPT occurred, affected participants will become 100% vested in all contribution sources and therefore, the Plan Sponsor will be required to reinstate forfeitures previously used, so that amounts may be refunded to affected participant accounts.

**(7) Investment contract with insurance company**

The Plan has entered into a fully benefit-responsive investment contract with Empower, who maintains the Plan's contributions in a guaranteed interest account. The account is credited with earnings of \$7,585 on the underlying investments, had purchases totaling \$405,103, and was charged for plan withdrawals and administrative expenses totaling \$41,869 in 2024. Net transfers out of the fund amounted to \$257,647 in 2024.

Empower may impose restrictions on the ability to move plan assets into or out of this investment option. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the guaranteed interest accounts, which approximates fair value, was \$389,751 and \$276,579 as of December 31, 2024 and 2023, respectively.

Under the contract, Empower is contractually obligated to repay the principal and a specified interest rate to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield and crediting interest rates are reviewed periodically for resetting and were 1.41% and 1.23% for 2024 and 2023, respectively. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, has occurred or is probable.

**(8) Risks and uncertainties**

The Plan invests in various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

**(9) Income tax status**

The Plan Sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
