### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the J.R. CARLSON LABORATORIES INC. 401(K) PLAN AND TRUST, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1—PLAN DESCRIPTION**

J.R. Carlson Laboratories, Inc. 401(k) Plan and Trust (the “Plan”) is a defined contribution plan designed to operate under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers all eligible domestic employees of J.R. Carlson Laboratories, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The following description of the Plan provides only summary information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

**ELIGIBILITY**

Each employee who is age 21 or older is eligible to make pre-tax deferrals to the Plan after completion of six months of service. Each employee shall become eligible for the Company matching and profit-sharing contribution on the first day of the year after the employee completes one year of service.

**CONTRIBUTIONS**

Each year, participants may contribute up to the maximum allowable amount of pretax annual compensation, as defined in the Plan. The Plan has the automatic enrollment feature. Unless a participant opts out of this feature, 401(k) deferrals of 6% of eligible compensation will be made. The deferral amount increases each year by 1% until a maximum of 10%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance contract as investment options for participants. The Company has the option of making matching and profit-sharing contributions on behalf of participants. For 2024 and 2023, the Company made a matching contribution of 20% of 401(k) deferrals up to 4% of eligible compensation. For 2024, the Company made a total of \$66,742 in matching contributions and \$500,000 in profit sharing contributions to the Plan. For 2023, the Company made a total of \$58,599 in matching contributions and \$454,556 in profit sharing contributions to the Plan. Contributions are subject to certain statutory limitations.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contribution, the Company’s discretionary matching contribution, and an allocation of the Company’s discretionary profit-sharing contribution, if applicable, and Plan earnings. Allocations are based on participant contributions, Plan compensation, or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**VESTING**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

**NOTE 1—PLAN DESCRIPTION (Continued)**

**PAYMENT OF BENEFITS**

On termination of service due to death, the distribution of the value of the participant's vested interest in his or her entire account must be completed by December 31 of the calendar year containing the fifth anniversary of the date of death. For reasons other than death, a participant must receive the value of the vested interest in his or her account as a lump-sum distribution. In-service distributions may be made once the participant reaches age 59½ and is fully vested. Force-out distributions may be made for balances of less than \$5,000 for terminated employees.

**FORFEITURES**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0-. Forfeited accounts are used to reduce future employer contributions or pay future administrative expenses. During the year ended December 31, 2024, \$4,441 in forfeitures were used to reduce Company contributions and \$799 in forfeitures were used to pay fees. During the year ended December 31, 2023, \$2,428 in forfeitures were used to reduce Company contributions and \$25 in forfeitures were used to pay fees.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The accompanying financial statements have been prepared using the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments held by a defined contribution plan are required to be reported at fair value, except for investments with contract values. Contract value is the relevant measure for those investments because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. The Plan's investments at December 31, 2024 and 2023 were held by Principal Trust Company (Principal). Investments other than the Principal Fixed Income Guaranty Option are stated at fair value as of December 31, 2024 and 2023. In accordance with U.S. GAAP, this investment is excluded from the fair value hierarchy. Investments in mutual funds are valued at the net asset value of shares held by the Plan at year-end.

INVESTMENT VALUATION AND INCOME RECOGNITION (Continued)

The Principal Fixed Income Guaranty Option is a fully benefit-responsive investment contract. It is a singly group annuity contract with a fixed rate of interest. Under the terms of the contract, the composite crediting rate is reset on a semi-annual basis and will never be less than the guaranteed minimum interest rate. Contract value, as reported to the Plan by Principal, represents participant contributions and earnings, less withdrawals and administrative expenses. At December 31, 2024 and 2023, fair value and contract value were equal. Fair value is the amount a plan sponsor would receive if they were to withdraw or transfer funds prior to maturity. This event is not probable to occur. The fair value represents the discontinuation value or 95% of the contract value. The 5% surrender face is described in the contract. The market yield for the Fund was 0.90% for 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account. Administrative expenses were netted against fee credits and included in other income.

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Level 1 Fair Value Measurements**

Mutual funds are valued at quoted net asset values of the shares held by the Plan at year-end.

**Level 2 and Level 3 Fair Value Measurements**

Level 2 and level 3 fair value measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4—INFORMATION CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information in the accompanying financial statements and supplemental schedule has been certified by Principal Trust Company that the information is complete and accurate.

- a. Investments, as shown in the accompanying statements of assets available for benefits as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H - Line 4(i).

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**NOTE 5—NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant’s account. The loan interest rate is set at prime plus one percent. Principal and interest is paid ratably through biweekly payroll deductions.

**NOTE 6—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Principal Trust Company. This company is the custodian of the Plan's assets and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment and other income, as they are paid through revenue sharing, rather than a direct payment.

**NOTE 7—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 8—TAX STATUS**

The Plan adopted the CCH Incorporated Non-Standardized Pre-Approved Profit Sharing Basic Plan Document #1 effective January 1, 2022. The Internal Revenue Service has informed CCH by a letter dated June 30, 2020, that the plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10—SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 3, 2025, the date which the financial statements were available for issue. There were no subsequent events which require disclosure.
